7 **Be it enacted by the General Assembly of Virginia:**8 **1. That § 4, as amended, Chapter IV of Chapter 431 of the Acts of Assembly of 1950 is amended**
9 **and reenacted as follows:**10 § 4. ~~Election~~ *Appointment* and terms of president (ex officio mayor), vice-president (ex officio
11 vice-mayor) and members of boards and commissions; quorum; journal; etc.12 (a) On the first Tuesday in January next following the regular municipal election, or as soon
13 thereafter as may be practicable, the newly elected council shall proceed to ~~choose~~ *appoint* by majority
14 vote of all the members thereof one of their number to be president, who shall be ex officio mayor, and
15 another as vice-president, who shall be ex officio vice-mayor, of the council, each of whom shall serve
16 for a period of two years from the first day of the January next following the *regular municipal* election
17 and until their successor or successors ~~as mayor or vice-mayor~~ have been ~~elected~~ *appointed* and
18 qualified; ~~provided, however, that the terms of the president and vice-president set to expire on June 30,~~
19 ~~2012, shall be extended to December 31, 2012, and until their successors have been elected and~~
20 ~~qualified.~~21 (b) Appointment of boards and commissions; enumeration, term. The school board, library board, and
22 dock commission shall each consist of five members of the board of such regional free library system as
23 are permitted under the inter-jurisdictional contract establishing the regional library system as that
24 contract may be amended from time to time.25 The council shall appoint the members of such boards and commissions as are provided for in this
26 charter, or as may be established by the council or by general law on a date and for such terms as may
27 be established by ordinance.28 The members of the boards and commissions shall serve until their successors have been appointed
29 and qualified.30 (c) Elections to be by viva voce vote; rules of procedure; punishment of members for misconduct,
31 etc.; quorum; eligibility of members for other office; journal of proceedings. All elections by the council
32 shall be viva voce and the vote recorded in the journal of the council.33 The council may determine its own rules of procedure; in the absence of established rules of
34 procedure, Robert's Rules of Order shall prevail. Council may punish its members for misconduct and
35 may compel the attendance of members in such manner and under such penalties as may be prescribed
36 by ordinance. It shall keep a journal of its proceedings. A majority of all the members of the council
37 shall constitute a quorum to do business, but a smaller number may adjourn from time to time.38 No person, now a member or who may hereafter be elected to the council, shall during his tenure of
39 office, or during the term for which he was elected as such member, be eligible to any office to be
40 filled by the council by election or appointment.
