10 Be it enacted by the General Assembly of Virginia:

1. That §§ 13.1-1002, 13.1-1004, 13.1-1005, 13.1-1012, 13.1-1051, 13.1-1061, 13.1-1062, 13.1-1064, 11

- 12 13.1-1065, and 13.1-1067 of the Code of Virginia are amended and reenacted and that the Code of 13 Virginia is amended by adding in Chapter 12 of Title 13.1 an article numbered 16, consisting of
- sections numbered 13.1-1088 through 13.1-1099.27, as follows: 14

15 § 13.1-1002. Definitions.

16 As used in this chapter:

17 "Articles of organization" means all documents constituting, at any particular time, the articles of organization of a limited liability company. The articles of organization include the original articles of 18 19 organization, the original certificate of organization issued by the Commission, and all amendments to the articles of organization. When the articles of organization have been restated pursuant to any articles 20 21 of restatement, amendment, domestication, or merger, the articles of organization include only the 22 restated articles of organization without the articles of restatement, amendment, domestication, or 23 merger.

24 "Assignee" means a person to which all or part of a membership interest has been transferred, 25 whether or not the transferor is a member.

26 "Bankruptcy" means, with respect to any person, being the subject of an order for relief under Title 27 11 of the United States Code. 28

"Commission" means the State Corporation Commission of Virginia.

29 "Contribution" means any cash, property or services rendered, or a promissory note or other binding 30 obligation to contribute cash or property or to perform services, which a member contributes to a limited 31 liability company in his capacity as a member.

32 "Distribution" means a direct or indirect transfer of money or other property, or incurrence of 33 indebtedness by a limited liability company, to or for the benefit of its members in respect of their 34 interests. 35

"Domestic business trust" has the same meaning as specified in § 13.1-1201.

"Domestic corporation" has the same meaning as specified in § 13.1-603.

37 "Domestic limited partnership" has the same meaning as specified in § 50-73.1.

38 "Domestic nonstock corporation" has the same meaning as "domestic corporation" as specified in 39 § 13.1-803.

40 "Domestic other business entity" means a partnership, limited partnership, business trust, stock 41 corporation, or nonstock corporation that is formed, organized, or incorporated under the laws of the 42 Commonwealth.

43 "Domestic partnership" means an association of two or more persons to carry on as co-owners a 44 business for profit formed under § 50-73.88, or predecessor law of the Commonwealth, and includes, for 45 all purposes of the laws of the Commonwealth, a registered limited liability partnership.

'Domestic stock corporation" has the same meaning as "domestic corporation" as specified in 46 47 § 13.1-603.

48 "Electronic transmission" means any form of communication, not directly involving the physical 49 transmission of paper, that creates a record that may be retained, retrieved, and reviewed by a recipient 50 thereof, and that may be directly reproduced in paper form by the recipient through an automated process. Any term used in this definition that is defined in § 59.1-480 of the Uniform Electronic 51 Transactions Act (§ 59.1-479 et seq.) shall have the meaning set forth in that section. 52

53 "Eligible interests" means, as to a partnership, partnership interest as specified in § 50-73.79; as to a 54 limited partnership, partnership interest as specified in § 50-73.1; as to a business trust, the beneficial 55 interest of a beneficial owner as specified in § 13.1-1226; as to a stock corporation, shares as specified 56 in § 13.1-603; or, as to a nonstock corporation, membership interest as specified in § 13.1-803.

57 "Foreign business trust" has the same meaning as specified in § 13.1-1201.

58 "Foreign corporation" has the same meaning as specified in § 13.1-603.

59 "Foreign limited liability company" means an entity, excluding a foreign business trust, that is an unincorporated organization that is organized under laws other than the laws of the Commonwealth and that is denominated by that law as a limited liability company, and that affords to each of its members, pursuant to the laws under which it is organized, limited liability with respect to the liabilities of the entity.

64 "Foreign limited partnership" has the same meaning as specified in § 50-73.1.

65 "Foreign nonstock corporation" has the same meaning as "foreign corporation" as specified in 66 § 13.1-803.

67 "Foreign other business entity" means a partnership, limited partnership, business trust, stock
68 corporation, or nonstock corporation that is formed, organized, or incorporated under the laws of a state
69 or jurisdiction other than the Commonwealth.

"Foreign partnership" means an association of two or more persons to carry on as co-owners a
business for profit formed under the laws of any state or jurisdiction other than the Commonwealth, and
includes, for all purposes of the laws of the Commonwealth, a foreign registered limited liability
partnership.

74 "Foreign protected series" means a protected series established by a foreign series limited liability
75 company and having attributes comparable to a protected series established under Article 16
76 (§ 13.1-1088 et seq.). The term applies whether or not the law under which the foreign series limited
77 liability company is organized refers to "protected series" or "series."

78 "Foreign registered limited liability partnership" has the same meanings as specified in §§ 50-2 and 50-73.79.

80 "Foreign series limited liability company" means a foreign limited liability company having at least
 81 one foreign protected series.

82 "Foreign stock corporation" has the same meaning as "foreign corporation" as specified in83 § 13.1-603.

84 "Jurisdiction," when used to refer to a political entity, means the United States, a state, a foreign
85 country, or a political subdivision of a foreign country.

86 "Jurisdiction of formation" means the jurisdiction whose law governs the internal affairs of a person. "Limited liability company" or "domestic limited liability company" means an entity that is an 87 88 unincorporated organization organized and existing under this chapter, or that has become a domestic 89 limited liability company of the Commonwealth pursuant to § 13.1-1010.3 as it existed prior to its 90 repeal, even though also being a non-United States entity organized under laws other than the laws of 91 the Commonwealth, or that has become a domestic limited liability company of the Commonwealth pursuant to § 56-1, even though also being a non-United States entity organized under laws other than 92 93 the laws of the Commonwealth, or that has become a domestic limited liability company of the Commonwealth pursuant to § 13.1-1010.1 as it existed prior to its repeal, or that has become a domestic 94 95 limited liability company of the Commonwealth pursuant to Article 12.2 (§ 13.1-722.8 et seq.) of Chapter 9, Article 17.1 (§ 13.1-944.1 et seq.) of Chapter 10, Article 14 (§ 13.1-1074 et seq.) or Article 96 97 15 (§ 13.1-1081 et seq.) of this chapter, or Article 12 (§ 13.1-1264 et seq.) of Chapter 14. A limited 98 liability company's status for federal tax purposes shall not affect its status as a distinct entity organized 99 and existing under this chapter.

"Manager" or "managers" means a person or persons designated by the members of a limited liability
 company to manage the limited liability company as provided in the articles of organization or an
 operating agreement.

103 "Manager-managed limited liability company" means a limited liability company that is managed by
 104 a manager or managers as provided for in its articles of organization or an operating agreement.

105 "Member" means a person that has been admitted to membership in a limited liability company as106 provided in § 13.1-1038.1 and that has not ceased to be a member.

107 "Member-managed limited liability company" means a limited liability company that is not a manager-managed limited liability company.

"Membership interest" or "interest" means a member's share of the profits and the losses of the
 limited liability company and the right to receive distributions of the limited liability company's assets.

111 "Non-United States entity" means a foreign limited liability company (other than one formed under 112 the laws of a state), or a corporation, business trust or association, real estate investment trust, 113 common-law trust, or any other unincorporated business, including a partnership, formed, incorporated, 114 organized, created or that otherwise came into being under the laws of any foreign country or other 115 foreign jurisdiction (other than any state).

116 "Operating agreement" means an agreement of the members as to the affairs of a limited liability company and the conduct of its business, or a writing or agreement of a limited liability company with

one member that satisfies the requirements of subdivision A 2 of § 13.1-1023. 118

119 "Person" has the same meaning as specified in § 13.1-603. "Person" includes a protected series.

120 "Principal office" means the office, in or out of the Commonwealth, where the principal executive 121 offices of a domestic or foreign limited liability company are located or, if there are no such offices, the 122 office, in or out of the Commonwealth, so designated by the limited liability company. The designation 123 of the principal office in the most recent statement of change filed pursuant to § 13.1-1018.1 shall be 124 conclusive for the purpose of this chapter.

125 "Property" means all property, whether real, personal, or mixed or tangible or intangible, or any 126 right or interest therein.

127 "Protected series," except in the term "foreign protected series," means a person established under 128 § 13.1-1095.

129 "Record," when used as a noun, means information that is inscribed on a tangible medium or that is 130 stored in an electronic or other medium and is retrievable in perceivable form.

"Series limited liability company," except in the term "foreign series limited liability company," 131 132 means a limited liability company having at least one protected series.

133 "Sign" means, with present intent to authenticate or adopt a record, to execute or adopt a tangible 134 symbol or to attach to or logically associate with the record an electronic symbol, sound, or process.

135 "State," when referring to a part of the United States, includes a state, commonwealth and the 136 District of Columbia, and their agencies and governmental subdivisions; and a territory or insular 137 possession, and their agencies and governmental subdivisions, of the United States.

138 "Transfer" includes an assignment, a conveyance, a sale, a lease, an encumbrance including a 139 mortgage or security interest, a gift, and a transfer by operation of law.

140 "United States" includes a district, authority, bureau, commission, department, and any other agency 141 of the United States. 142

§ 13.1-1004. Issuance of certificate by Commission; recordation of documents.

143 A. Whenever this chapter conditions the effectiveness of a document upon the issuance of a 144 certificate by the Commission to evidence the effectiveness of the document, the Commission shall by 145 order issue the certificate if it finds that the document complies with the provisions of this chapter and 146 that all required fees have been paid. The Commission shall admit any such certificate to record in its 147 office.

148 B. The existence of a limited liability company or a protected series shall begin at the time the 149 Commission issues a certificate of organization or certificate of protected series designation unless a 150 later date and time are specified as provided by subsection D of this section. The certificate of 151 organization shall be conclusive evidence that all conditions precedent required to be performed by the 152 person(s) forming the limited liability company have been complied with and that the limited liability 153 company has been formed under this chapter.

154 C. Whenever the Commission is directed to admit any document to record in its office, it shall cause 155 it to be spread upon its record books or to be recorded or reproduced in any other manner the 156 Commission may deem suitable. Except as otherwise provided by law, the Commission may furnish 157 information from and provide access to any of its records by any means the Commission may deem 158 suitable.

159 D. 1. A certificate issued by the Commission is effective at the time such certificate is issued, unless 160 the certificate relates to articles filed with the Commission or a statement filed with the Commission 161 pursuant to Article 16 (§ 13.1-1088 et seq.) and the articles state or statement states that the certificate 162 shall become effective at a later time and date specified in the articles or statement. In that event, the certificate shall become effective at the earlier of the time and date so specified or 11:59 p.m. on the 163 164 fifteenth day after the date on which the certificate is issued by the Commission. Any other document 165 filed with the Commission shall be effective when accepted for filing unless otherwise provided for in 166 this chapter.

2. Notwithstanding subdivision 1 of this subsection, any certificate that has a delayed effective time 167 168 and date shall not become effective if, prior to the effective time and date, the parties to the articles or 169 statement to which the certificate relates file a request for cancellation with the Commission, and the 170 Commission, by order, cancels the certificate.

171 3. Notwithstanding subdivision 1 of this subsection, for purposes of §§ 13.1-1012 and, 13.1-1054, 172 and 13.1-1096, any certificate that has a delayed effective date shall be deemed to be effective when the 173 certificate is issued.

174 E. Notwithstanding any other provision of law to the contrary, the Commission shall have the power to act upon a petition filed by a limited liability company or protected series at any time to correct 175 Commission records so as to eliminate the effects of clerical errors and of filings made by a person 176 177 without authority to act for the limited liability company.

178 § 13.1-1005. Fees.

- 179 The Commission shall charge and collect the following fees:
- 180 1. For filing any one of the following, the fee shall be \$100:
- 181 a. Articles of organization.
- b. An application for registration as a foreign limited liability company. 182

183 c. Articles of entity conversion to convert a domestic corporation to a limited liability company to a 184 domestic business trust or to convert a domestic partnership or limited partnership to a limited liability 185 company.

- 186 d. Articles of domestication.
- 187 e. A statement of protected series designation.
- f. An application for registration as a foreign protected series. 188
- 189 2. For filing any one of the following, the fee shall be \$25:
- 190 a. Articles of amendment.
- 191 b. Articles of cancellation.

192 c. Articles of correction referred to in § 13.1-1011.1, a copy of an amendment or correction referred 193 to in § 13.1-1055, or an amended application for registration referred to in § 13.1-1055, provided that an 194 amended application shall not require a separate fee when it is filed with a copy of an amendment or a 195 correction referred to in § 13.1-1055.

196 d. A copy of an instrument of merger of a foreign limited liability company referred to in 197 § 13.1-1060. 198

e. Articles of merger.

199 f. Articles of entity conversion to convert a limited liability company to a domestic corporation, in 200 addition to a charter fee ascertained in accordance with § 13.1-615.1.

201 g. A copy of an instrument of entity conversion of a foreign limited liability company holding a 202 certificate of registration to transact business in the Commonwealth. 203

- g. h. Articles of restatement.
- h. *i*. Articles of organization surrender.

i. i. An application for a certificate of cancellation of to cancel a certificate of registration as a 205 foreign limited liability company. 206

207 k. A statement of designation change pursuant to § 13.1-1095 or 13.1-1096. 208

l. A statement of designation cancellation.

209 m. An application for a certificate of cancellation to cancel a certificate of registration as a foreign 210 protected series. 211

3. For filing any one of the following, the fee shall be \$10:

212 a. An application to reserve or to renew the reservation of a name for use by a domestic or foreign 213 limited liability company or any protected series thereof.

214 b. A notice of the transfer of a name reserved for use by a domestic or a foreign limited liability 215 company or any protected series thereof. 216

4. For issuing a certificate pursuant to § 13.1-1067 or 13.1-1099, \$6 for each certificate. 217

§ 13.1-1012. Name.

A. A limited liability company name shall contain the words "limited company" or "limited liability company" or their abbreviations "L.C.," "LC," "L.L.C.," or "LLC." 218 219 220

B. A limited liability company name shall not contain:

221 1. Any word, abbreviation, or combination of characters that states or implies the limited liability 222 company is a corporation Θ , a limited partnership, or a protected series of a series limited liability 223 company; or 224

2. Any word or phrase the use of which is prohibited by law for such company.

225 C. Except as authorized by subsection D, a limited liability company name shall be distinguishable 226 upon the records of the Commission from:

227 1. The name of a domestic limited liability company or a foreign limited liability company registered 228 to transact business in the Commonwealth; 229

2. A limited liability company name reserved under § 13.1-1013;

3. The designated name adopted by a foreign limited liability company because its real name is 230 231 unavailable for use in the Commonwealth;

232 4. The name of any corporation, whether issuing shares or not issuing shares, existing under the laws 233 of the Commonwealth or authorized to transact business in the Commonwealth; 234

5. A corporate name reserved or registered under § 13.1-631, 13.1-632, 13.1-830 or 13.1-831;

235 6. The designated name adopted by a foreign corporation, whether issuing shares or not issuing 236 shares, because its real name is unavailable for use in the Commonwealth;

237 7. The name of a domestic business trust or a foreign business trust registered to transact business in 238 the Commonwealth;

239 8. A business trust name reserved under § 13.1-1215;

- 9. The designated name adopted by a foreign business trust because its real name is unavailable for use in the Commonwealth;
- 10. The name of a domestic limited partnership or a foreign limited partnership registered to transactbusiness in the Commonwealth;
- 244 11. A limited partnership name reserved under § 50-73.3; and
- 12. The designated name adopted by a foreign limited partnership because its real name isunavailable for use in the Commonwealth.
- D. A domestic limited liability company may apply to the Commission for authorization to use a name that is not distinguishable upon its records from one or more of the names described in subsection
 C. The Commission shall authorize use of the name applied for if the other entity consents to the use in writing and submits an undertaking in form satisfactory to the Commission to change its name to a name that is distinguishable upon the records of the Commission from the name of the applying limited liability company.
- E. The use of assumed names or fictitious names, as provided for in Chapter 5 (§ 59.1-69 et seq.) of
 Title 59.1, is not affected by this chapter.
- F. The Commission, in determining whether a limited liability company name is distinguishable upon its records from the name of any of the business entities listed in subsection C, shall not consider any word, phrase, abbreviation, or designation required or permitted under this section and § 13.1-544.1, subsection A of § 13.1-630, § 13.1-1104, subsection A of § 50-73.2, and subdivision A 2 of § 50-73.78 to be contained in the name of a business entity formed or organized under the laws of the 260 Commonwealth or authorized or registered to transact business in the Commonwealth.
 - § 13.1-1051. Authority to transact business required; governing law.
- A. A foreign limited liability company may not transact business in the Commonwealth until itobtains a certificate of registration from the Commission.
- **264** B. Subject to the Constitution of the Commonwealth:

- 1. The Except as provided in §§ 13.1-1099.8 and 13.1-1099.10, the laws of the state or other
 jurisdiction under which a foreign limited liability company is formed govern its formation and internal
 affairs and the liability of its members and managers; and
- 268 2. A foreign limited liability company may not be denied a certificate of registration by reason of269 any difference between those laws and the laws of the Commonwealth.
- However, a foreign limited liability company holding a valid certificate of registration to transact
 business in the Commonwealth shall have no greater rights and privileges than a domestic limited
 liability company. The certificate of registration shall not be deemed to authorize the foreign limited
 liability company to exercise any of its powers or purposes that a domestic limited liability company is
 forbidden by law to exercise in the Commonwealth.
- § 13.1-1061. Annual registration fees to be assessed and collected by Commission; application of
 payment.
- The Commission shall assess and collect the annual registration fees imposed by this chapter. When
 the Commission receives payment of a registration fee assessed against a domestic or foreign limited
 liability company, *or any protected series thereof*, such payment shall be applied against any unpaid
 registration fees previously assessed against such limited liability company *or protected series*, including
 any penalties incurred thereon, beginning with the assessment that has remained unpaid for the longest
 period of time.
- § 13.1-1062. Assessment of annual registration fees; annual registration fees to be paid by
 domestic and foreign limited liability companies.
- A. Each domestic limited liability company and, each protected series, each foreign limited liability 285 286 company registered to transact business in the Commonwealth, and each foreign protected series 287 registered to transact business in the Commonwealth shall pay into the state treasury on or before the 288 last day of the twelfth month next succeeding the month in which it was organized, established, or 289 registered to transact business in the Commonwealth, and by such date in each year thereafter, an annual 290 registration fee of \$50, provided that the initial annual registration fee to be paid by a domestic limited 291 liability company created by entity conversion shall be due in the year after the calendar year in which 292 it converted.
- The annual registration fee shall be imposed irrespective of any specific license tax or other tax or
 fee imposed by law upon the *domestic or foreign* limited liability company *or any protected series thereof* for the privilege of carrying on its business in the Commonwealth or upon its franchise, property
 or receipts.
- 297 B. Each year, the Commission shall ascertain from its records each domestic limited liability
 298 company and, each protected series, each foreign limited liability company registered to transact
 299 business in the Commonwealth, and each foreign protected series registered to transact business in the
 300 Commonwealth, as of the first day of the second month next preceding the month in which it was

301 organized, established, or registered to transact business in the Commonwealth, and, except as provided 302 in subsection A, shall assess against each such limited liability company and each such protected series 303 the annual registration fee herein imposed.

304 C. At the discretion of the Commission, the annual registration fee due date for a limited liability 305 company may be extended, on a monthly basis for a period of not less than one month nor more than 306 11 months, at the request of its registered agent of record or as may be necessary to distribute annual 307 registration fee due dates of limited liability companies as equally as practicable throughout the year on 308 a monthly basis.

309 D. A statement of the assessment, when made, shall be forwarded by the clerk of the Commission to 310 the Comptroller and to each domestic and foreign limited liability company and each protected series 311 thereof.

312 E. Any domestic limited liability company that has ceased to exist in the Commonwealth because of 313 the issuance of a certificate of cancellation of existence, certificate of organization surrender, or 314 certificate of entity conversion, or any protected series that has been canceled, any foreign limited 315 liability company that has obtained a certificate of cancellation, or any foreign protected series that has 316 obtained a certificate of cancellation, effective on or before its annual registration fee due date pursuant 317 to subsection A in any year, shall not be required to pay the annual registration fee for that year. Any 318 domestic or foreign limited liability company that has merged, effective on or before its annual 319 registration fee due date pursuant to subsection A in any year, into a surviving domestic or foreign 320 corporation, limited liability company, business trust, limited partnership, or partnership that files with 321 the Commission an authenticated copy of the instrument of merger on or before such date, shall not be 322 required to pay the annual registration fee for that year. Any foreign limited liability company that has 323 converted, effective on or before its annual registration fee due date pursuant to subsection A in any 324 year, to a different entity type that files with the Commission an authenticated copy of the instrument of 325 entity conversion on or before such date, shall not be required to pay the annual registration fee for that 326 year. The Commission shall cancel the annual registration fee assessments specified in this subsection 327 that remain unpaid. 328

F. Registration fee assessments that have been paid shall not be refunded.

329 G. The fees paid into the state treasury under this section and the fees collected under § 13.1-1005 330 shall be set aside and paid into the special fund created under § 13.1-775.1, and shall be used only by 331 the Commission as it deems necessary to defray the costs of the Commission and of the office of the 332 clerk of the Commission in supervising, implementing, administering and enforcing the provisions of 333 this chapter. The projected excess of fees collected over the costs of administration and enforcement so 334 incurred shall be paid into the general fund prior to the close of each fiscal year, based on the 335 unexpended balance of the special fund at the end of the prior fiscal year. An adjustment of this transfer 336 amount to reflect actual fees collected shall occur during the first quarter of the succeeding fiscal year. 337

§ 13.1-1064. Penalty for failure to timely pay annual registration fees.

338 A. Any domestic or foreign limited liability company, or any protected series thereof, that fails to 339 pay the annual registration fee into the state treasury within the time prescribed in § 13.1-1062 shall 340 incur a penalty of \$25, which shall be added to the amount of the annual registration fee due. The 341 penalty prescribed herein shall be in addition to any other penalty or liability imposed by law.

342 B. The Commission shall mail to each domestic and foreign limited liability company that fails to 343 pay the annual registration fee within the time prescribed in § 13.1-1062 a notice of assessment of the 344 penalty imposed herein and of the impending cancellation of its existence or certificate of registration, as 345 the case may be.

346 C. The Commission shall mail to each protected series and each foreign protected series that fails to 347 pay the annual registration fee within the time prescribed in § 13.1-1062 a notice of assessment of the 348 penalty imposed herein and of its impending cancellation or the impending cancellation of its certificate 349 of registration, as the case may be.

350 § 13.1-1065. Payment of fees, fines, penalties, and interest prerequisite to Commission action; 351 refunds.

352 A. The Commission shall not file or issue with respect to any domestic or foreign limited liability 353 company any document or certificate specified in this chapter, except a statement of change pursuant to 354 § 13.1-1016, a statement of resignation pursuant to § 13.1-1017, and a statement of change pursuant to § 13.1-1018.1, until all fees, fines, penalties, and interest assessed, imposed, charged, or to be collected 355 by the Commission pursuant to this chapter or Title 12.1 have been paid by or on behalf of such limited 356 357 liability company. Notwithstanding the foregoing, the Commission may file or issue any document or 358 certificate with respect to a domestic or foreign limited liability company that has been assessed an 359 annual registration fee if the document or certificate is filed or issued with an effective date that is on or before the due date of the limited liability company's annual registration fee payment in any year, 360 provided that the Commission shall not issue a certificate of domestication with respect to a foreign 361

362 limited liability company until the annual registration fee has been paid by or on behalf of that limited363 liability company.

364 B. The Commission shall not file or issue with respect to any protected series or foreign protected 365 series any document or certificate specified in this chapter until all fees, fines, penalties, and interest 366 assessed, imposed, charged, or to be collected by the Commission pursuant to this chapter or Title 12.1 367 have been paid by or on behalf of such protected series. Notwithstanding the foregoing, the Commission 368 may file or issue any document or certificate with respect to a protected series or foreign protected 369 series that has been assessed an annual registration fee if the document or certificate is filed or issued 370 with an effective date that is on or before the due date of the protected series' annual registration fee 371 payment in any year.

372 C. The Commission shall have authority to certify to the Comptroller directing refund of any
373 overpayment of a fee, or of any fee collected for a document that is not accepted for filing, at any time
374 within one year from the date of its payment.

375 § 13.1-1067. Property title records.

376 A. Whenever the records in the office of the clerk of the Commission reflect that a domestic or 377 foreign limited liability company, or any protected series thereof, has changed or corrected its name, 378 merged into a domestic or foreign limited liability company, corporation, business trust, limited 379 partnership or partnership, converted into to or from a domestic or foreign corporation, business trust, 380 limited partnership or partnership, or domesticated in or from another jurisdiction, the clerk of the 381 Commission, upon request, shall issue a certificate reciting such change, correction, merger, conversion 382 or domestication. Whenever a foreign limited liability company or foreign protected series has changed or corrected 387 its name, merged into another business entity, converted into another type of business entity, or 388 domesticated in another jurisdiction, and it cannot or chooses not to obtain a certificate reciting such 389 change, correction, merger, conversion or domestication from the clerk of the Commission pursuant to 390 subsection A, a similar certificate by any competent authority of the foreign limited liability company's 391 or foreign protected series' jurisdiction of organization formation may be admitted to record in the deed 392 books, in accordance with § 17.1-227, of any recording office within the jurisdiction of which any 393 property of the limited liability company is located in order to maintain the continuity of title records. 394 The person filing the certificate shall pay a fee of \$10 to the clerk of the court, but no tax shall be due 395 thereon.

Protected Series.

§ 13.1-1088. Definitions.

As used in this article, unless the context requires a different meaning:

400 "After a merger" or "after the merger" means when a merger under § 13.1-1099.16 becomes effective **401** and afterwards.

- **402** "Asset" means property:
- 403 1. In which a series limited liability company or protected series has rights; or
- 404 2. As to which the series limited liability company or protected series has the power to transfer 405 rights.
- **406** "Associated asset" means an asset that meets the requirements stated in § 13.1-1099.2.
- **407** "Associated member" means, with respect to a protected series, a member that meets the **408** requirements stated in § 13.1-1099.3.
- **409** "Before a merger" or "before the merger" means before a merger under § 13.1-1099.16 becomes **410** effective.
- **411** "Continuing protected series" means a protected series of a surviving company that continues in **412** uninterrupted existence after a merger under § 13.1-1099.16.
- **413** "Merging company" means a limited liability company that is party to a merger under **414** § 13.1-1099.16.
- 415 "Non-associated asset" means:
- **416** *1.* An asset of a series limited liability company that is not an associated asset of the series limited **417** liability company; or
- **418** 2. Any asset of a protected series of the series limited liability company that is not an associated **419** asset of the protected series.
- 420 "Non-surviving company" means a merging company whose separate existence ceases after a merger 421 under § 13.1-1099.16.
- 422 "Principal office of the protected series" means the office, in or out of the Commonwealth, where the

423 principal executive offices of a protected series of a domestic or foreign series limited liability company 424 are located or, if there are no such offices, the office, in or out of the Commonwealth, so designated by 425 the protected series. The designation of the principal office of a protected series in the most recent 426 statement of change filed pursuant to § 13.1-1018.1 and subsection G of § 13.1-1095 shall be conclusive 427 for the purpose of this chapter. 428 "Protected series assignee" means a person to which all or part of a protected series membership 429 interest of a protected series of a series limited liability company has been transferred, other than the 430 series limited liability company. "Protected series assignee" includes a person that owns a protected

431 series membership interest as a result of ceasing to be an associated member of a protected series.

432 "Protected series manager" means a person under whose authority the powers of a protected series 433 are exercised and under whose direction the activities and affairs of the protected series are managed 434 pursuant to the operating agreement, this article, and other provisions of this chapter.

"Protected series membership interest" means the share of the profits and losses of a protected series 435 436 and the right to receive distributions.

437 "Relocated protected series" means a protected series of a non-surviving company which, after a merger under § 13.1-1099.16, continues in uninterrupted existence as a protected series of the surviving 438 439 company.

440 "Surviving company" means a merging company that is the survivor of a merger under 441 § 13.1-1099.16.

442 "Survivor" has the same meaning as specified in § 13.1-1069.1.

443 § 13.1-1089. Nature of protected series. 444

A protected series of a series limited liability company is a person distinct from:

445 1. The series limited liability company, subject to subsection C of § 13.1-1090, subdivision 1 of 446 § 13.1-1099.11, and § 13.1-1099.12; 447

2. Another protected series of the series limited liability company;

448 3. A member of the series limited liability company, whether or not the member is an associated 449 *member of the protected series;* 450

4. A protected series assignee of any protected series of the series limited liability company; and

5. An assignee of a membership interest of the series limited liability company.

452 § 13.1-1090. Powers and duration of protected series.

453 A. A protected series of a series limited liability company has the capacity to sue and be sued in its 454 own name.

455 B. Except as otherwise provided in subsections C and D, a protected series of a series limited 456 liability company has the same powers and purpose as the series limited liability company.

457 C. A protected series of a series limited liability company ceases to exist not later than when the 458 series limited liability company ceases to exist. 459

D. Service of process, notice, or demand on a foreign series limited liability company is notice to 681 each foreign protected series of the foreign series limited liability company of the process, notice, or 682 683 demand and the contents thereof.

684 E. Service of a process, notice, or demand on a foreign protected series of a foreign series limited 685 liability company is notice to the foreign series limited liability company and any other foreign 686 protected series of the foreign series limited liability company of service of the process, notice, or 687 demand and the contents thereof.

§ 13.1-1099. Effectiveness of notice.

689 Notice to a person under subsection B, C, D, or E of § 13.1-1098 is effective against the person whether or not the process, notice, or demand identifies the person if the process, notice, or demand 690 691 identifies the person so long as the process, notice, or demand names as a party and identifies:

721 1. Identify the asset and distinguish it from any other assets of the series limited liability company 722 and any assets of any protected series of the series limited liability company;

723 2. Determine when and from what person the series limited liability company acquired the asset or 724 how the asset otherwise became an asset of the series limited liability company; and

725 3. If the series limited liability company acquired the asset from a protected series of the series 726 limited liability company, determine any consideration paid, the payor, and the payee.

727 D. The records and recordkeeping required by subsections B and C may be organized by specific

728 listing, category, type, quantity, or computational or allocational formula or procedure, including a 729 percentage or share of any asset, or in any other reasonable manner.

730 E. To the extent permitted by the law of the Commonwealth other than this article, a series limited 731 liability company or a protected series of the series limited liability company may hold an associated 732 asset directly or indirectly, through a representative, nominee, or similar arrangement, except that:

733 1. A protected series shall not hold an associated asset in the name of the series limited liability 734 company or another protected series of the series limited liability company; and

735 2. The series limited liability company may not hold an associated asset in the name of a protected 736 series of the series limited liability company.

737 § 13.1-1099.3. Associated members.

A. Only a member of a series limited liability company may be an associated member of a protected 738 739 series of the series limited liability company.

A. A protected series may have more than one protected series manager.

769 B. If a protected series has no associated members, the series limited liability company is the 770 protected series manager.

771 C. Section 13.1-1094 shall be applicable to the determination of any duties of a protected series 772 manager of a protected series of a series limited liability company to:

- 773 1. The protected series;
- 774 2. Any associated member of the protected series; and

775 3. Any protected series assignee of the protected series.

- 776 D. Solely by reason of being or acting as a protected series manager of a protected series of a 777 series limited liability company, a person owes no duty to:

An associated member of a protected series is an agent for the protected series with power to 792 bind the protected series to the same extent that a member of a limited liability company is under 793 subdivision A 1 of § 13.1-1021.1 an agent for the series limited liability company with statutory power to bind the company. 794

795 § 13.1-1099.6. Right of person not associated member of protected series to information concerning 796 protected series.

797 A. A member of a series limited liability company that is not an associated member of a protected 798 series of the series limited liability company has a right to information concerning the protected series 799 to the same extent, in the same manner, and under the same conditions that a member that is not a manager of a manager-managed limited liability company has a right to information concerning the 800 limited liability company under subsection B of § 13.1-1028 or other applicable law. 801

802 B. A person formerly an associated member of a protected series has a right to information concerning the protected series to the same extent, in the same manner, and under the same conditions 803 that a person dissociated as a member of a manager-managed limited liability company has a right to 804 805 information concerning the limited liability company under subsection B of § 13.1-1028 or other 806 applicable law.

807 C. If an associated member of a protected series dies, the legal representative of the deceased 808 associated member has a right to information concerning the protected series to the same extent, in the 809 same manner, and under the same conditions that the legal representative of a deceased member has a 810 right to information concerning the limited liability company under subsection B of § 13.1-1028 or other 811 applicable law.

812 D. A protected series manager of a protected series has a right to information concerning the protected series to the same extent, in the same manner, and under the same conditions that a manager 813 814 of a manager-managed limited liability company has a right to information concerning the limited 815 liability company under subsection B of § 13.1-1028 or other applicable law. 816

§ 13.1-1099.7. Limitations on liability.

A. A person is not liable, directly or indirectly, by way of contribution or otherwise, for a debt, 817 818 obligation, or other liability of: 819

I. A protected series of a series limited liability company solely by reason of being or acting as:

820 a. An associated member, protected series manager, or protected series assignee of the protected 821 series; or 822

b. A member, manager, or an assignee of the series limited liability company; or

2. A series limited liability company solely by reason of being or acting as an associated member, 823 824 protected series manager, or protected series assignee of a protected series of the series limited liability 825 company. 826

B. Subject to § 13.1-1099.10, the following rules apply:

1. A debt, obligation, or other liability of a series limited liability company is solely the debt, 827 828 obligation, or liability of the series limited liability company.

829 2. A debt, obligation, or other liability of a protected series is solely the debt, obligation, or liability 830 of the protected series.

831 3. A series limited liability company is not liable, directly or indirectly, by way of contribution or 832 otherwise, for a debt, obligation, or other liability of a protected series of the series limited liability 833 company solely by reason of the protected series being a protected series of the series limited liability 834 company or the series limited liability company:

835 a. Being or acting as a protected series manager of the protected series;

836 b. Having the protected series manage the series limited liability company; or

837 c. Owning a protected series membership interest of the protected series.

4. A protected series of a series limited liability company is not liable, directly or indirectly, by way 838 839 of contribution or otherwise, for a debt, obligation, or other liability of the series limited liability 840 company or another protected series of the series limited liability company solely by reason of: 841

a. Being a protected series of the series limited liability company;

842 b. Being or acting as a manager of the series limited liability company or a protected series 843 manager of another protected series of the series limited liability company; or

844 c. Having the series limited liability company or another protected series of the series limited 845 liability company be or act as a protected series manager of the protected series. 846

§ 13.1-1099.8. Claim seeking to disregard limitation of liability.

847 A. Except as otherwise provided in subsection B, a claim seeking to disregard a limitation in 848 \$ 13.1-1099.7 is governed by the principles of law and equity, including a principle providing a right to

a creditor or holding a person liable for a debt, obligation, or other liability of another person, that 849

2. The claim is to establish or enforce a liability arising under a law of the Commonwealth other 862 863 than this chapter or from an act or omission in the Commonwealth.

864 § 13.1-1099.9. Remedies of judgment creditor of associated member or protected series assignee.

865 Any provision of § 13.1-1041.1 that provides or restricts remedies available to a judgment creditor of 866 a member of a limited liability company or owner of a membership interest of the series limited liability 867 company applies to a judgment creditor of:

868 1. An associated member or protected series assignee of a protected series; or

869 2. A series limited liability company, to the extent the series limited liability company owns a 870 protected series membership interest of a protected series.

871 § 13.1-1099.10. Enforcement of claim against non-associated asset.

872 A. As used in this section:

873 "Enforcement date" means 12:01 a.m. on the date on which a claimant first serves process on a 874 series limited liability company or protected series of the series limited liability company in an action 875 seeking to enforce under this section a claim against an asset of the series limited liability company or 876 protected series by attachment, levy, or other action.

877 "Incurrence date" means, subject to subsection B of § 13.1-1099.20, the date on which a series 878 limited liability company or protected series of the series limited liability company incurred the liability 879 giving rise to a claim that a claimant seeks to enforce under this section.

880 B. If a claim against a series limited liability company or a protected series of the series limited 881 liability company has been reduced to judgment, in addition to any other remedy provided by law or 882 equity, the judgment may be enforced in accordance with the following rules:

883 1. A judgment against the series limited liability company may be enforced against an asset of a 884 protected series of the series limited liability company if the asset:

885 a. Was a non-associated asset of the protected series on the incurrence date; or

886 b. Is a non-associated asset of the protected series on the enforcement date.

b. Is a non-associated asset of the series limited liability company on the enforcement date.

891 3. A judgment against a protected series may be enforced against an asset of another protected 892 series of the series limited liability company if the asset:

b. Is a non-associated asset of the other protected series on the enforcement date.

In addition to any other remedy provided by law or equity, if a claim against a series limited 896 liability company or a protected series of the series limited liability company has not been reduced to a 897 judgment and law other than this article permits a prejudgment remedy by attachment, levy, or other 898 action, the court may apply subsection B as a prejudgment remedy.

1189 1. The name of the foreign protected series, the name of the foreign series limited liability company
1190 that established the foreign protected series, the name of the jurisdiction of formation of the foreign
1191 series limited liability company, and the identification number issued by the Commission to the foreign
1192 series limited liability company;

1193 2. If applicable, a statement that the foreign series limited liability company that established the
1194 foreign protected series was a party to a merger permitted by the laws of its jurisdiction of formation
1195 and that it was not the surviving entity of the merger, or has converted to another type of entity under
1196 the laws of its jurisdiction of formation;

1197 3. That the foreign protected series is not transacting business in the Commonwealth and that it surrenders its registration to transact business in the Commonwealth;

4. That the foreign protected series revokes the authority of its registered agent to accept service on
its behalf and appoints the clerk of the Commission as its agent for service of process in any proceeding
based on a cause of action arising during the time it was registered to transact business in the
Commonwealth;

1203 5. A mailing address to which the clerk of the Commission may mail a copy of any process served1204 on the clerk under subdivision 4; and

1205 6. A commitment to notify the clerk of the Commission in the future of any change in the mailing address of the foreign protected series.

1207 J. The Commission shall not issue a certificate of cancellation to any foreign protected series unless 1208 the foreign protected series files with the Commission a statement certifying that the foreign protected 1209 series has filed returns and has paid all state taxes to the time of the statement, or a statement that no 1210 returns are required to be filed or taxes are required to be paid. In that case the foreign protected 1211 series may file returns and pay taxes before they would otherwise be due. If the Commission finds that 1212 the application complies with the requirements of law and all required fees have been paid, it shall 1213 issue a certificate of cancellation canceling the certificate of registration.

1214 *K. Service of process on the clerk of the Commission is service of process on a foreign protected* 1215 *series whose certificate of registration has been canceled pursuant to this section. Service upon the clerk*

- shall be made in accordance with § 12.1-19.1, and service upon the foreign protected series may be 1216 1217 made in any other manner permitted by law.
- 1218 § 13.1-1099.24. Disclosure required when foreign series limited liability company or foreign 1219 protected series subject to proceeding.
- 1220 A. Not later than 30 days after becoming a party to a proceeding before a civil, criminal, 1221 administrative, or other adjudicative tribunal of the Commonwealth or a tribunal of the United States 1222 located in the Commonwealth:
- 1223 1. A foreign series limited liability company shall disclose to each other party the name and the 1224 street and mailing addresses of:
- 1225 a. Each foreign protected series of the foreign series limited liability company; and
- 1226 b. Each foreign protected series manager of and an agent for service of process for each foreign 1227 protected series of the foreign series limited liability company; and
- 1228 2. A foreign protected series of a foreign series limited liability company shall disclose to each other 1229 party the name and the street and mailing addresses of:
- 1230 a. The foreign series limited liability company that established the foreign protected series, each 1231 person managing the foreign series limited liability company, and an agent for service of process for the 1232 foreign series limited liability company; and
- 1233 b. Any other foreign protected series of the foreign series limited liability company and each 1234 protected series manager of and an agent for service of process for the other protected series.
- 1235 B. If a foreign series limited liability company or foreign protected series challenges the personal 1236 jurisdiction of the tribunal, the requirement that the foreign series limited liability company or foreign 1237 protected series make disclosure under subsection A is tolled until the tribunal determines whether it has 1238 personal jurisdiction.
- 1239 C. If a foreign series limited liability company or foreign protected series does not comply with 1240 subsection A, a party to the proceeding may:
- 1241 1. Request the tribunal to treat the noncompliance as a failure to comply with the tribunal's 1242 discovery rules; or
- 1243 2. Bring a separate proceeding in the tribunal to enforce subsection A.
- 1244 § 13.1-1099.25. Uniformity of application and construction.
- 1245 In applying and construing this article, consideration shall be given to the need to promote 1246 uniformity of the law with respect to its subject matter among states that enact the Uniform Protected 1247 Series Act. 1248
 - § 13.1-1099.26. Effect on certain actions.
- 1249 This article does not affect an action commenced, proceeding brought, or right accrued before July 1250 1, 2020.
- 1251 § 13.1-1099.27. Relation to Electronic Signatures in Global and National Commerce Act.
- 1252 This chapter modifies, limits, or supersedes the federal Electronic Signatures in Global and National 1253 Commerce Act (15 U.S.C. § 7001 et seq.) but does not modify, limit, or supersede § 101 of that Act (15 1254 U.S.C. § 7001(c)) or authorize electronic delivery of any of the notices described in § 103 of that Act 1255 (15 U.S.C. § 7003 (b)).
