| 10 | 1. That §§ 54.1-3505 and 54.1-3506 of the Code of Virginia are amended and reenacted as follows: |
| 12 | § 54.1-3505. Specific powers and duties of the Board. |
| 13 | In addition to the powers granted in § 54.1-2400, the Board shall have the following specific powers |
| 14 | and duties: |
| 15 | 1. To cooperate with and maintain a close liaison with other professional boards and the community |
| 16 | to ensure that regulatory systems stay abreast of community and professional needs. |
| 17 | 2. To conduct inspections to ensure that licensees conduct their practices in a competent manner and |
| 18 | in conformance with the relevant regulations. |
| 19 | 3. To designate specialties within the profession. |
| 20 | 4. To administer the certification of rehabilitation providers pursuant to Article 2 (§ 54.1-3510 et |

| 56 | A. In order to engage in the practice of counseling or marriage and family therapy or in the |
| 57 | independent practice of substance abuse treatment, as defined in this chapter, it shall be necessary to |
| 58 | hold a license issued by the Board. |

B. The Board may issue a license, without examination, for the practice of marriage and family therapy or the independent practice of substance abuse treatment to persons who hold a current and unrestricted license as a professional counselor within the Commonwealth and who meet the clinical and academic requirements for licensure as a marriage and family therapist or licensed substance abuse treatment practitioner, respectively. The applicant for such license shall present satisfactory evidence of qualifications equal to those required of applicants for licensure as marriage and family therapists or licensed substance abuse treatment practitioners, respectively, by examination in the Commonwealth.

C. Any person who renders substance abuse treatment services as defined in this chapter and who is
not licensed to do so, other than a person who is exempt pursuant to § 54.1-3501, shall render such
services only when he is (i) under the supervision and direction of a person licensed under this chapter
who shall be responsible for the services performed by such unlicensed person, or (ii) in compliance
with the regulations governing an organization or a facility licensed by the Department of Behavioral
Health and Developmental Services.

72 D. The Board may issue a temporary license, without examination, for the practice of counseling 73 during the supervised residency period required by the Board for licensure.
