That § 9.1-184 of the Code of Virginia is amended and reenacted and that the Code of Virginia 12 is amended by adding a section numbered 22.1-280.2:3 as follows: 13 14 § 9.1-184. Virginia Center for School and Campus Safety created; duties. A. From such funds as may be appropriated, the Virginia Center for School and Campus Safety (the 15 16 Center) is hereby established within the Department. The Center shall: 1. Provide training for Virginia public school personnel in school safety, on evidence-based 17 antibullying tactics based on the definition of bullying in § 22.1-276.01, and in the effective 18 19 identification of students who may be at risk for violent behavior and in need of special services or 20 assistance: 21 2. Serve as a resource and referral center for Virginia school divisions by conducting research, sponsoring workshops, and providing information regarding current school safety concerns, such as 22 23 conflict management and peer mediation, bullying as defined in § 22.1-276.01, school facility design and 24 technology, current state and federal statutory and regulatory school safety requirements, and legal and 25 constitutional issues regarding school safety and individual rights; 3. Maintain and disseminate information to local school divisions on effective school safety 26 27 initiatives in Virginia and across the nation; 28 4. Collect, analyze, and disseminate various Virginia school safety data, including school safety audit 29 information submitted to it pursuant to § 22.1-279.8, collected by the Department; 30 5. Encourage the development of partnerships between the public and private sectors to promote 31 school safety in Virginia; 32 6. Provide technical assistance to Virginia school divisions in the development and implementation of 33 initiatives promoting school safety, including threat assessment-based protocols with such funds as may 34 be available for such purpose; 35 7. Develop a memorandum of understanding between the Director of the Department of Criminal 36 Justice Services and the Superintendent of Public Instruction to ensure collaboration and coordination of 37 roles and responsibilities in areas of mutual concern, such as school safety audits and crime prevention; 38 8. Provide training for and certification of school security officers, as defined in § 9.1-101 and 39 consistent with § 9.1-110; 9. Develop, in conjunction with the Department of State Police, the Department of Behavioral Health 40 41 and Developmental Services, and the Department of Education, a model critical incident response training program for public school personnel and others providing services to schools that shall also be 42 made available to private schools in the Commonwealth; and 43 10. In consultation with the Department of Education, provide schools with a model policy for the 44 establishment of threat assessment teams, including procedures for the assessment of and intervention 45 with students whose behavior poses a threat to the safety of school staff or students; and 46 47 11. Develop a model memorandum of understanding setting forth the respective roles and responsibilities of local school boards and local law-enforcement agencies regarding the use of school 48 49 resource officers. Such model memorandum of understanding may be used by local school boards and local law-enforcement agencies to satisfy the requirements of § 22.1-280.2:3. 50 51 B. All agencies of the Commonwealth shall cooperate with the Center and, upon request, assist the 52 Center in the performance of its duties and responsibilities. 53 § 22.1-280.2:3. School boards; local law-enforcement agencies; memorandum of understanding. 54 The school board in each school division in which the local law-enforcement agency employs school 55 resource officers, as defined in § 9.1-101, shall enter into a memorandum of understanding with such local law-enforcement agency that sets forth (i) the respective roles and responsibilities of the school 56 board and the law-enforcement agency and (ii) the roles and responsibilities of such school resource 57 58 officers. The provisions of such memorandum of understanding shall be consistent with the model

memorandum of understanding developed by the Virginia Center for School and Campus Safety pursuant to subdivision A 11 of § 9.1-184. The school board and the local law-enforcement agency shall (a) review the memorandum of understanding every two years or at any time upon the request of either 59 60

party and may revise such memorandum at any time as agreed by the parties and (b) ensure that all 62 63

relevant personnel employed by either party are informed of and review the provisions of the memorandum of understanding, including any revisions to the memorandum of understanding. 64
