11	Be it enacted by the General Assembly of Virginia:
12	1. That the Code of Virginia is amended by adding in Title 3.2 a subtitle numbered VI, containing
13	a chapter numbered 66, consisting of sections numbered 3.2-6600, 3.2-6601, and 3.2-6602, as
14 15	follows: SUBTITLE VI.
15 16	PRODUCT SAFETY.
17	CHAPTER 66.
18	PRODUCTS CONTAINING FLAME RETARDANTS.
19	§ 3.2-6600. Virginia Product Safety Fund.
20	There is hereby created in the state treasury a special nonreverting fund to be known as the Virginia
21	Product Safety Fund, referred to in this section as "the Fund." The Fund shall be established on the
22	books of the Comptroller. All penalties collected pursuant to § 3.2-6602 shall be paid into the state
23 24	treasury and credited to the Fund. Interest earned on moneys in the Fund shall remain in the Fund and be credited to it. Any moneys remaining in the Fund, including interest thereon, at the end of each
24 25	fiscal year shall not revert to the general fund but shall remain in the Fund. Moneys in the Fund shall
2 6	be used solely for the purposes of increasing the safety of consumer products in the Commonwealth.
27	Expenditures and disbursements from the Fund shall be made by the State Treasurer on warrants issued
28	by the Comptroller upon written request signed by the Commissioner.
29	§ 3.2-6601. Regulations.
30	The Board shall adopt regulations to (i) carry out the provisions of this chapter and (ii) impose the
31	prohibitions of § 3.2-6602 upon other consumer products when such products are sold for indoor use in
32 33	a residence, child care facility, office, or school where a child under 12 years of age or a woman who is pregnant is expected to have direct physical contact with the product.
33 34	§ 3.2-6602. Flame-retardant chemicals; children's products; residential upholstered furniture;
35	penalty.
36	A. Beginning July 1, 2020, no manufacturer, wholesaler, or retailer in the Commonwealth shall
37	manufacture, sell, offer for sale, distribute for sale, or distribute in the Commonwealth any product that
38	contains any prohibited flame-retardant chemical listed in subsection B and is (i) intended to be worn
39	by, be used by, or come into close and prolonged contact with a person under 12 years old or (ii) a
40 41	piece of upholstered furniture intended for use in a residence. B. The flame-retardant chemicals whose presence in certain products is prohibited under subsection
42	A are: TDCPP (tris(1,3-dichloro-2-propyl)phosphate), Chemical Abstracts Service number 13674-87-8;

52	C. Any manufacturer in the Commonwealth that manufactures a product that is prohibited pursuant
53	to this section shall notify any person who sells the product in the Commonwealth of the prohibition by
54	March 31, 2020.
55 56	D. Any manufacturer that produces, sells, or distributes a product that is prohibited by this chapter shall recall the product by March 31, 2020, and reimburse the retailer or any other purchaser for the
50 57	product.

58 E. The sale or purchase of any previously owned product containing a chemical restricted under this

59 chapter made in a casual or isolated sale or by a nonprofit organization is exempt from the provisions 60 of this chapter.

61 F. Any manufacturer that manufactures a product intended for use by a child in violation of any provision of this chapter shall be subject to a civil penalty not to exceed \$5,000 for each violation in 62

the case of a first offense. A second or subsequent violation shall subject the manufacturer to a civil penalty not to exceed \$10,000 for each repeat offense. Penalties collected under this section shall be deposited in the Virginia Product Safety Fund created in § 3.2-6600. 64
