15	Be it enacted by the General Assembly of Virginia:
16 17	1. That § 2.2-2699.3 of the Code of Virginia is amended and reenacted as follows: § 2.2-2699.3. (Expires July 1, 2019) Broadband Advisory Council; purpose; membership;
18	compensation; chairman.
19	A. The Broadband Advisory Council (the Council) is established as an advisory council, within the
20	meaning of § 2.2-2100, in the executive branch of state government. The purpose of the Council shall be
21	to advise the Governor on policy and funding priorities to expedite deployment and reduce the cost of
22	broadband access in the Commonwealth.
23	B. The Council shall have a total membership of 14 16 members that shall consist of six seven
24	legislative members, four <i>five</i> nonlegislative citizen members, and four ex officio members. Members
25 26	shall be appointed as follows: four members of the House of Delegates to be appointed by the Speaker of the House of Delegates in accordance with the principles of proportional representation contained in
20 27	the Rules of the House of Delegates; two <i>three</i> members of the Senate to be appointed by the Senate
28	Committee on Rules; and four five nonlegislative citizen members to be appointed by the Governor, of
29	whom one shall be a representative of the Virginia Cable Telecommunications Association, one shall be
30	a representative of the Virginia Telecommunications Industry Association, one shall be a representative
31	from local government recommended by the Virginia Municipal League and Virginia Association of
32 33	Counties, and one shall be a representative of the Virginia Wireless Internet Service Providers
33 34	Association, and one shall be a representative of the Virginia, Maryland and Delaware Association of Electric Cooperatives. The Secretaries of Administration, Agriculture and Forestry, and Commerce and
35	Trade, and Technology, or their designees, and the executive director of the Center for Rural Virginia
36	shall serve ex officio. Legislative and ex officio members shall serve terms coincident with their terms
37	of office. Other members shall be appointed for terms of two years. Appointments to fill vacancies,
38	other than by expiration of a term, shall be for the unexpired terms. Vacancies shall be filled in the
39	same manner as the original appointments. All members may be reappointed.
40	C. Legislative members of the Council shall receive such compensation as provided in § 30-19.12.
41 42	Nonlegislative citizen members shall serve without compensation. All members shall be reimbursed for all reasonable and necessary expenses incurred in the performance of their duties as provided in
43	§§ 2.2-2813 and 2.2-2825. Funding for compensation and expenses of legislative members shall be
44	provided by the operating budgets of the Clerk of the House of Delegates and the Clerk of the Senate
45	upon approval of the Joint Rules Committee. Funding for the costs of expenses of the nonlegislative
46	citizen members and all other expenses of the Council shall be provided by the Office of the Secretary
47	of Technology Commerce and Trade.
48	D. The Council shall elect a chairman and a vice-chairman annually from among its membership. A
49 50	majority of the members shall constitute a quorum. The Council shall meet at such times as may be called by the chairman or a majority of the Council.
50 51	E. Staff to the Council shall be provided by the Office of Telework Promotion and Broadband
52	Assistance Secretary of Commerce and Trade. The Division of Legislative Services shall provide
53	additional staff support to legislative members serving on the Council.
54	2. That the second enactment of Chapter 444 of the Acts of Assembly of 2008, as amended by
55 56	Chapter 759 of the Acts of Assembly of 2018, is amended and reenacted as follows:
