7 Be it enacted by the General Assembly of Virginia:

8 1. That the Code of Virginia is amended by adding in Article 1 of Chapter 1 of Title 9.1 a section 9 numbered 9.1-116.4 and by adding sections numbered 16.1-69.48:6 and 17.1-275.13 as follows: 10 § 9.1-116.4. Virginia Prevention of Sex Trafficking Fund; purpose; guidelines.

11 A. There is hereby created in the state treasury a special nonreverting fund to be known as the 12 Virginia Prevention of Sex Trafficking Fund (the Fund). The Fund shall be established on the books of 13 the Comptroller. All moneys accruing to the Fund shall be paid into the state treasury and credited to the Fund. Interest earned on moneys in the Fund shall remain in the Fund and be credited to it. Any 14 15 moneys remaining in the Fund, including interest thereon, at the end of each fiscal year shall not revert 16 to the general fund but shall remain in the Fund. Moneys in the Fund shall be used for the purpose of 17 promoting prevention and awareness of sex trafficking. Expenditures and disbursements from the Fund 18 shall be made by the State Treasurer on warrants issued by the Comptroller upon written request signed 19 by the Director of the Department.

20 B. The Fund shall be administered by the Department, and the Department shall adopt guidelines to 21 make funds available to agencies of the state and local governments for the purpose of promoting 22 awareness of and preventative training and education related to sex trafficking. 23

§ 16.1-69.48:6. Fees for offenses related to sex trafficking.

24 The court shall order any person convicted of a misdemeanor violation of subsection B of § 18.2-346 25 or of § 18.2-348 or 18.2-349 to pay a \$100 fee, which shall be deposited into the Virginia Prevention of 26 Sex Trafficking Fund to be used in accordance with § 9.1-116.4.

27 § 17.1-275.13. Additional fee for offenses related to sex trafficking.

28 In addition to the fees provided for by §§ 17.1-275.1, 17.1-275.2, 17.1-275.7, 17.1-275.10, and 29 17.1-275.12, any person convicted of a misdemeanor violation of subsection B of § 18.2-346 or of 30 § 18.2-348 or 18.2-349 shall be ordered to pay a \$100 fee, and any person convicted of a violation of clause (ii), (iii), or (iv) of § 18.2-48, or of § 18.2-368, or any felony violation of the laws pertaining to 31 32 commercial sex trafficking or prostitution offenses pursuant to Article 3 (§ 18.2-344 et seq.) of Chapter 8, with the exception of § 18.2-361, shall be ordered to pay a \$500 fee. All fees collected pursuant to 33 34 this section shall be deposited into the Virginia Prevention of Sex Trafficking Fund to be used in 35 accordance with § 9.1-116.4.
