3 Commending Michael J. Brown.

WHEREAS, Michael J. Brown, Bedford County Sheriff, will retire on December 31, 2019, after 24 years in the law-enforcement leadership position; and

8 WHEREAS, Michael "Mike" J. Brown is a native of Bedford County and a graduate of American 9 University, where he earned a bachelor's degree in the administration of justice and police 10 administration; he has additional advanced training with the United States Department of Justice's 11 Executive Development Program, the National Sheriffs' Institute, and numerous courses of instruction 12 from federal agencies; and

WHEREAS, Mike Brown has brought a wide range of experience to his position; he is a retired
senior special agent in the United States Treasury Department; he served in the United States Army
Military Police Corps, in Washington, D.C.'s Metropolitan Police Department, in the United States
Department of Defense, and as an instructor overseas with the United States Department of Justice's
International Criminal Investigative Training Assistance Program; and

18 WHEREAS, since 1998, Mike Brown has directed a national task force dealing with the sexual
19 exploitation of children over the Internet for the United States Department of Justice's Office of Juvenile
20 Justice and Delinquency Prevention; he testified twice before Congress on these matters; and

WHEREAS, under Mike Brown's leadership, the Bedford County Sheriff's Office had one of the first
 Internet Crimes Against Children task forces in the country, and in 2000, he founded the nonprofit
 Safe Surfin' Foundation which seeks to educate people about Internet safety; and

WHEREAS, Mike Brown was selected by United States Attorney General Janet Reno to participate
at the Crime Technology Initiative Forum of the Office of Science and Technology Policy, Executive
Office of the White House; in 2002 he was a member of Virginia Attorney General Kilgore's task force
on identity theft; and

WHEREAS, Mike Brown is a member of the executive committee and board of directors of the
National Sheriffs' Association, focusing on education and awards, congressional affairs, and technology;
he is also in a leadership position in the National White Collar Crime Center, as well as the Law
Enforcement Innovation Center at the University of Tennessee; and

WHEREAS, Mike Brown maintains memberships in numerous other organizations focused on
policing and the military; his concern for community involvement has twice earned him recognition as
Citizen of the Year by the Bedford Chapter of the NAACP, and he was named Sheriff of the Year in
2017 by the National Sheriffs' Association; now, therefore, be it

RESOLVED by the House of Delegates, the Senate concurring, That the General Assembly hereby
 commend Michael J. Brown on his retirement as Bedford County Sheriff on December 31, 2019, after
 years in the law-enforcement leadership position; and, be it

RESOLVED FURTHER, That the Clerk of the House of Delegates prepare a copy of this resolution
 for presentation to Michael J. Brown as an expression of the General Assembly's admiration for his
 service to Bedford County and the law-enforcement community.
