6 WHEREAS, Johnston-Willis Hospital, a hospital delivering high-quality health care to the Greater
7 Richmond and Tri-Cities area, celebrates its 110th anniversary and its accreditation from the American
8 College of Surgeons' National Accreditation Program for Breast Centers in 2019; and
