10	Be it enacted by the General Assembly of Virginia:
11 12	1. That the Code of Virginia is amended by adding a section numbered 3.2-6513.2 as follows: § 3.2-6513.2. Rental or lease of dog or cat prohibited; civil penalty.
13	A. The rental or leasing of a dog or cat to a consumer, including by a purported sale of the animal
14 15	in such a manner as to vest no permanent ownership in the consumer at the time of the purported sale, is prohibited.
16	B. No person may enter into any agreement with a consumer for the transfer of a dog or cat to the
17 18	consumer in which the animal is used as collateral for the agreement or is subject to repossession in any manner upon default of the agreement by the consumer.
10 19	C. No financial institution, as defined in § 6.2-100, shall offer in Virginia a loan or financing
20	agreement for the rental, lease, or sale of a dog or cat where the animal is used as collateral for the
21 22	loan or financing agreement default. D. The Attorney General may bring a civil action in the appropriate circuit court for injunctive relief
23	to enforce the provisions of this section. Any person who violates any provision of this section may,
24 25	upon such finding by an appropriate circuit court, be subject to a civil penalty of not more than \$5,000 and any court costs and attorney fees. Such civil penalties shall be paid into the general fund of the
26	state treasury. In addition, any pet shop, commercial dog breeder, dealer, firm, or other business that
27 28	violates any provision of this section may have its business license, retail license, or local pet shop permit issued pursuant to § 3.2-6537 suspended or revoked after a hearing by the issuing authority. The
29	court also may suspend or revoke the retail license of any business found to be in violation of this
