10	Be it enacted by the General Assembly of Virginia:
11 12	1. That § 64.2-2020 of the Code of Virginia is amended and reenacted as follows:
12 13	§ 64.2-2020. Annual reports by guardians. A. A guardian shall file an annual report in compliance with the filing deadlines in § 64.2-1305 with
14	the local department of social services for the jurisdiction where the incapacitated person then resides.
15	The annual report shall be on a form prepared by the Office of the Executive Secretary of the Supreme
16	Court and shall be accompanied by a filing fee of \$5. The local department shall retain the fee in the
17	jurisdiction where the fee is collected for use in the provision of services to adults in need of protection.
18	Within 60 days of receipt of the annual report, the local department shall file a copy of the <i>annual</i>
19 20	report with the clerk of the circuit court that appointed the guardian, to be placed with the court papers pertaining to the guardianship case. Twice each year the local department shall file with the clerk of the
2 0 2 1	circuit court a list of all guardians who are more than 90 days delinquent in filing an annual report as
22	required by this section. If the guardian is also a conservator, a settlement of accounts shall also be filed
23	with the commissioner of accounts as provided in § 64.2-1305.
24	B. The annual report to the local department of social services shall include:
25	1. A description of the current mental, physical, and social condition of the incapacitated person;
26 27	 A description of the <i>incapacitated</i> person's living arrangements during the reported period; The medical, educational, vocational, and other professional services provided to the <i>incapacitated</i>
27 28	person and the guardian's opinion as to the adequacy of the <i>incapacitated</i> person's care;
29	4. A statement of the frequency and nature of the guardian's visits with and activities on behalf of
30	the <i>incapacitated</i> person;
31	5. A statement of whether the guardian agrees with the current treatment or habilitation plan;
32	6. A recommendation as to the need for continued guardianship, any recommended changes in the
33 34	scope of the guardianship, and any other information useful in the opinion of the guardian; and 7. The compensation requested and the reasonable and necessary expenses incurred by the guardian.
34 35	The guardian shall certify that the information contained in the <i>annual</i> report is true and correct to
36	the best of his knowledge.
37	C. If the local department of social services files notice that the annual report has not been timely
38	filed in accordance with subsection A with the clerk of the circuit court, the court may issue a summons
39	or rule to show cause why the guardian has failed to file such annual report.
