5	(Patrons Prior to Substitute—Senators Saslaw, Marsden [SB 1085], and Favola [SB 1140])
6	A BILL to amend the Code of Virginia by adding a section numbered 53.1-39.1, relating to Department
7	of Corrections; restrictive housing; data collection and reporting; report.
8	Be it enacted by the General Assembly of Virginia:
9 10	1. That the Code of Virginia is amended by adding a section numbered 53.1-39.1 as follows: § 53.1-39.1. Restrictive housing; data collection and reporting; report.
11	A. As used in this section:
12	"Offender" means an adult or juvenile who is under sentence to or confined in a state correctional
13	facility.
14	"Restrictive housing" means special-purpose bed assignments operated under maximum security
15	regulations and procedures, and utilized under proper administrative process, for the personal
16	protection or custodial management of offenders.
17	"Shared Allied Management Unit" or "SAM Unit" means a general population environment used to
18	promote safety within institutions by avoiding the use of restrictive housing to manage vulnerable
19	population that typically require a high level of services from security, mental health, or medical staff.
20	"Vulnerable population" means offenders who are at a greater risk of victimization or being bullied
21 22	in the general population due to characteristics such as cognitive challenge, age (seniors and youthful), small stature, or timid personalities.
$\frac{22}{23}$	B. The Department shall report to the General Assembly and the Governor on or before October 1
23 24	of each year the following information for the Department, in the aggregate, for the previous fiscal
25	year:
26	1. The average daily population;
27	2. The number of offenders who were placed in and the number of offenders who were released from
28	restrictive housing;
29	3. The age, sex, race, ethnicity, mental health code, medical class code, security level, and custody
30	level classification of each offender housed in restrictive housing or a SAM Unit;
31 32	4. The disciplinary offense history preceding placement in restrictive housing or a SAM Unit; 5. The number of days each offender spent in restrictive housing;
33	6. The number of offenders released from restrictive housing directly into the community;
34	7. The number of full-time mental health staff; and
35	8. Any changes made during the reporting period to written policies or procedures of the
36	Department and each state correctional facility relating to the use and conditions of restrictive housing
37	and SAM Units.
38	C. The Department shall submit the annual report to the Governor, the Clerk of the Senate, and the
39	Clerk of the House of Delegates as provided in the procedures of the Division of Legislative Automated
40	Systems for the processing of legislative documents and reports, and the annual report shall be posted
41 42	on the General Assembly's website. The Department shall publish the annual report on the Department's website following its submission to the Governor, the Clerk of the Senate, and the Clerk of the House of
43	Delegates.
