11 12	Be it enacted by the General Assembly of Virginia: 1. That the Code of Virginia is amended by adding in Title 3.2 a chapter numbered 33.1,
12	consisting of sections numbered 3.2-3304, 3.2-3305, and 3.2-3306, as follows:
14	CHAPTER 33.1.
15	DAIRY PRODUCER MARGIN COVERAGE PREMIUM ASSISTANCE PROGRAM.
16	§ 3.2-3304. Definitions.
17	For the purposes of this chapter, unless the context requires a different meaning:
18	"DCR" means the Department of Conservation and Recreation.
19	"Farm Act" means the federal Agriculture Improvement Act of 2018, P.L. 115-334.
20	"Federal coverage program" means the federal margin coverage program for dairy producers as
21	contained in the Farm Act.
22	"Program" means the Dairy Producer Margin Coverage Premium Assistance Program created
23	pursuant to this chapter.
24	§ 3.2-3305. Dairy Producer Margin Coverage Premium Assistance Program.
25 26	A. The Commissioner shall establish and administer the Dairy Producer Margin Coverage Premium
26 27	Assistance Program to assist dairy producers that participate in the federal coverage program. The Board shall adopt regulations to implement the Program.
27 28	B. Any dairy producer in the Commonwealth that participates in the federal coverage program at the
20 29	first tier coverage level and (i) has a resource management plan and has been certified as having
<b>3</b> 0	implemented such plan by, or is in the process of having such plan reviewed by, DCR or a local soil
31	and water conservation district or (ii) has a nutrient management plan that has been approved by, or is
32	currently being reviewed by, DCR shall be eligible to apply to participate in the Program. An eligible
33	dairy producer shall apply to the Department by February 1 of each year to participate.
34	

C. Any participating dairy producer that has paid an annual federal premium payment at the Tier 1 level in accordance with the Farm Act and provides proof of such payment to the Department shall have 34 35 the amount of such premium reimbursed by the Department. § 3.2-3306. Expiration of chapter. The provisions of this chapter shall expire upon the expiration or repeal of the Farm Act. 36 37
