10 11	Be it enacted by the General Assembly of Virginia: 1. That § 2.2-2400 of the Code of Virginia is amended and reenacted as follows:
12 13	§ 2.2-2400. Art and Architectural Review Board; members and officers; travel expenses; quorum; compensation; staff; report.
14 15	A. The Art and Architectural Review Board (the Board) is established as an advisory board, within the meaning of § 2.2-2100, in the executive branch of state government. The Board shall consist of six
16 17	seven voting members as follows: the Director of the Department of Historic Resources, or his designee,
18	serving as an ex officio member and five six citizen members, appointed by the Governor. Of the citizen members, one shall be an architect who may be appointed from a list of two or more architects
19 20	nominated by the governing board of the Virginia Society of the American Institute of Architects; one may be appointed from a list of two or more persons nominated by the governing board of the
21 22	University of Virginia; one shall be a member of the board of trustees of the Virginia Museum of Fine Arts; and two <i>three</i> shall be appointed from the Commonwealth at large, one of whom shall be a painter
23 24	or sculptor. Lists of nominees shall be submitted at least 60 days before the expiration of the member's term for which the nominations are being made in order to be considered by the Governor in making
25	appointments pursuant to this section.
26 27	B. Beginning July 1, 2011, the Governor's appointments of the five six citizen members shall be staggered as follows: two members for a term of one year, two members for a term of two years, and
28 29	one member two members for a term of three years. Thereafter, members of the Board shall be appointed for terms of four years each, except appointments to fill vacancies, which shall be for the
30 31	unexpired terms. No member shall serve for more than two consecutive four-year terms, except that any member appointed to the unexpired term of another shall be eligible to serve two consecutive four-year
32	terms. Vacancies shall be filled in the manner of the original appointments. The Director of the
33 34	Department of Historic Resources shall serve a term coincident with his term of office. C. Annually, the Board shall elect a chairman and vice-chairman and may elect such other officers as
35 36	the Board deems proper from among its membership. A majority of the members of the Board shall constitute a quorum.
37 38	D. The members of the Board shall serve without compensation, but shall be reimbursed for all reasonable and necessary expenses incurred in the discharge of their duties as provided in § 2.2-2825.
39 40	E. The Division of Engineering and Buildings of the Department of General Services shall provide assistance to the Board in the undertaking of its responsibilities.
41	F. The Board shall submit a biennial report to the Governor and General Assembly on or before
42	October 1 of each even-numbered year.
