## HOUSE BILL NO. 1467

AMENDMENT IN THE NATURE OF A SUBSTITUTE (Proposed by the Senate Committee on Finance and Appropriations

on February 26, 2020)

(Patron Prior to Substitute—Delegate Aird)

234567 A BILL to amend and reenact § 53.1-116.1:02 of the Code of Virginia and to amend the Code of Virginia by adding in Article 1 of Chapter 2 of Title 53.1 a section numbered 53.1-31.4, relating to 8 prisoners; obtaining certain identification and documentation upon release. 9

Be it enacted by the General Assembly of Virginia:

1. That § 53.1-116.1:02 of the Code of Virginia is amended and reenacted and that the Code of 10 11 Virginia is amended by adding in Article 1 of Chapter 2 of Title 53.1 a section numbered 53.1-31.4 12 as follows:

§ 53.1-31.4. Department of Corrections-issued identification.

14 Prior to the release or discharge of any prisoner who has been confined for at least 90 days and 15 does not possess a government-issued identification card, birth certificate, and Social Security card, the Department shall provide the assistance necessary for such prisoner to apply for and obtain such 16 17 identification and documents prior to his release or discharge, provided that the Department has or can readily obtain all records and information necessary for their issuance. If the prisoner is unable to 18 obtain a government-issued identification card prior to his release or discharge, the Department shall 19 20 provide the prisoner with a Department of Corrections Offender Identification form. If the Department 21 receives a government-issued identification card, birth certificate, or Social Security card for a prisoner after his release or discharge, the Department shall forward such identification or document to the 22 prisoner. Unless the prisoner is determined to be indigent pursuant to § 19.2-159, all costs and fees 23 24 associated with applying for and obtaining any identification or documents pursuant to this section shall 25 be paid by the prisoner. 26

§ 53.1-116.1:02. Jailer-issued identification.

27 Prior to the release or discharge of any prisoner, if the prisoner who has been confined for at least 28 90 days and does not already possess a government-issued identification card, birth certificate, and 29 Social Security card, the sheriff, jail superintendent, or other jail administrator may issue that shall provide the assistance necessary for such prisoner a special identification card to be given to the 30 prisoner upon to apply for and obtain such identification and documents prior to his release or 31 32 discharge, provided that the sheriff, superintendent, or administrator has or can readily obtain all 33 records and information necessary for their issuance and the prisoner has not declined an offer by the 34 sheriff, superintendent, or administrator to provide such assistance. If the sheriff, jail superintendent, or 35 other jail administrator receives a government-issued identification card, birth certificate, or Social 36 Security card for a prisoner after his release or discharge, the sheriff, superintendent, or administrator 37 shall forward such identification or document to the prisoner. The sheriff, jail superintendent, or other 38 jail administrator may establish a procedure for securing such identification through the Department of 39 Motor Vehicles. All Unless the prisoner is determined to be indigent pursuant to § 19.2-159, all costs 40 and fees associated with applying for and obtaining such special identification card any identification or 41 documents pursuant to this section shall be paid by the prisoner.
