In conducting its compliance reviews, the Joint Legislative Audit and Review Commission s solicit certification by the State Council of Higher Education for Virginia that each institution f the academic performance standards and financial and administrative standards set forth Restructuring Act during each of the previous two academic years, and in the case of James M University, during the previous academic year; (ii) evaluate each institution's performance in ac the aspirational goals specified in the management agreement during each of the previous two ac years, and in the case of James Madison University, during the previous academic year; (ii) revi evaluate any concerns expressed by central agencies regarding each institution's compliance w procedures and rules contained in the management agreement for each operational area during of the previous two academic years, and in the case of James Madison University, during the p academic year; and (iv) make recommendations for any amendment to the management agreement deems necessary to ensure compliance with the provisions of the Restructuring Act.
