11	Be it enacted by the General Assembly of Virginia:
12	1. That the Code of Virginia is amended by adding in Chapter 1 of Title 9.1 an article numbered
13	14, consisting of a section numbered 9.1-191, as follows:
14	Article 14.
15	Virginia Sexual Assault Forensic Examiner Coordination Program.
16	§ 9.1-191. Virginia sexual assault forensic examiner coordination program.
17	A. The Department shall establish a Virginia sexual assault forensic examiner coordination program.
18	The program shall be headed by a coordinator (the Coordinator). The Coordinator shall:
19	I. Create and coordinate an annual statewide sexual assault forensic nurse examiner training
20	program in partnership with the Attorney General, the Department of Health, the Virginia Hospital and
21	Healthcare Association, the Victim Compensation Fund, the International Association of Forensic
22	Nurses, and the Secretary of Health and Human Services;
23	2. Coordinate the development and enhancement of sexual assault forensic examiner programs across
24	the Commonwealth that include prevention of secondary trauma to survivors and culturally sensitive
25	training for health professionals;
26	3. Participate in the development of hospital protocols and guidelines for treatment of survivors of
27	sexual assault in partnership with the Department of Health;
28	4. Coordinate and strengthen communications among sexual assault nurse examiner medical
29	directors, sexual assault response teams, and hospitals for existing and developing sexual assault nurse
30	examiner programs;
31	5. Provide technical assistance for existing and developing sexual assault forensic examiner
32	programs, including local sexual assault forensic examiner training programs;
33	6. Create and maintain a statewide list, updated biannually, to include the following:
34	a. A list of available sexual assault forensic examiners, sexual assault nurse examiners, sexual
35	assault forensic nurse examiners, and pediatric sexual assault nurse examiners;
36	b. The location and facility affiliation of each examiner;
37	c. The duty hours for each examiner and affiliated facility for sexual assault exam services; and
38	d. The location of available local sexual assault forensic examiner training programs;
<b>39</b>	7. Coordinate, share, and disseminate the list created pursuant to subdivision 6 to the emergency
<b>40</b>	operations communications system available to emergency medical services and law-enforcement
41	agencies as well as the internal emergency and hospital communications system;
42	8. Share and disseminate the list created pursuant to subdivision 6 with all other relevant agencies,
43	including law-enforcement agencies, attorneys for the Commonwealth, victim-witness programs, sexual
<b>44</b>	assault service organizations, the Department of Juvenile Justice, the Department of Social Services, the
45	Department of Education, and school divisions;
<b>46</b>	9. Create sexual assault nurse examiner recruitment materials for universities and colleges with
47	nursing programs in partnership with the State Council of Higher Education for Virginia; and
48	10. Support and coordinate community education and public outreach, when appropriate, relating to

	sexual assault nurse examiner issues for the Commonwealth.
50 51	B. The Coordinator may request and shall receive from every department, division, board, bureau, commission, authority, or other agency created by the Commonwealth, or to which the Commonwealth is

52 53	a party, or any political subdivision thereof, cooperation and assistance in the performance of its duties.
53 54	The Coordinator may also consult and exchange information with local government agencies and
54 55	interested stakeholders.
55 56	C. The Coordinator shall report annually on or before October 1 to the Governor and the General
56	Assembly. The report shall include a summary of activities for the year and any recommendations to
57	address sexual assault exams within the Commonwealth, including budget needs to increase the
<b>58</b>	availability of sexual assault exam services across the Commonwealth. The Department shall ensure that
59	such report is available to the public.

ENGROSSED

2. That the Department, in cooperation with Virginia's existing sexual assault forensic examiner 60 programs, shall submit a report providing a feasibility plan for the establishment of centers of 61 62 excellence as a model to increase the availability of sexual assault exam services to the Chairmen 63 of the House Committee on Appropriations and the Senate Committee on Finance and Appropriations by January 1, 2022, as provided in the procedures of the Division of Legislative 64 Automated Systems for the processing of legislative documents, and the report shall be posted on 65 the General Assembly's website. The Department shall publish the report on the Department's 66 67 website no later than 10 days following its submission to the General Assembly.

68 [ 3. That the provisions of this act shall not become effective unless an appropriation effectuating

- 69 the purposes of this act is included in a general appropriation act passed in 2020 by the General
- 70 Assembly that becomes law. ]
