5 6	(Patrons Prior to Substitute—Senators Hashmi and McClellan [SB 714]) A BILL to amend the Code of Virginia by adding in Chapter 25 of Title 2.2 an article numbered 11,
7	consisting of sections numbered 2.2-2544 through 2.2-2550, relating to the American Revolution 250
8	Commission; report.
9	Be it enacted by the General Assembly of Virginia:
10	1. That the Code of Virginia is amended by adding in Chapter 25 of Title 2.2 an article numbered
11	11, consisting of sections numbered 2.2-2544 through 2.2-2550, as follows:
12 13	Article 11. American Revolution 250 Commission.
13 14	§ 2.2-2544. American Revolution 250 Commission; purpose.
15	The American Revolution 250 Commission (the Commission) is established as an advisory
16	commission within the executive branch of state government.
17	The purpose of the Commission is to commemorate the 250th anniversary of the American
18	Revolution, the Revolutionary War, and the independence of the United States.
19 20	§ 2.2-2545. Membership; terms; quorum; meetings. A. The Commission shall have a total membership of 22 members that shall consist of 17
20 21	nonlegislative citizen members and five ex officio members. Members shall be appointed as follows:
22	1. One representative from each of the lead commemoration partners: the Jamestown-Yorktown
23	Foundation, the primary state agency and fiscal agent; the Virginia Museum of History & Culture, the
24	primary nonstate agency; and Gunston Hall, the primary representative of Virginia's historic homes and
25	related sites;
26 27	2. One representative from the American Battlefield Trust, the secretariat of the United States Semiquincentennial Commission, and one representative from the Virginia Bar Association;
28	5. Six members appointed by the Governor from a list of 10 provided by the Jamestown-Yorktown
29	Foundation; and
30	6. Six members appointed by the Governor from a list of 10 provided by the Virginia Museum of
31	History & Culture.
32	The Secretary of Education, the Librarian of Virginia, the Director of the Department of Historic
33 34	Resources, the Executive Director of Virginia Humanities, and the Chief Executive Officer of the Virginia Tourism Authority, or their designees, shall serve as ex officio members with voting privileges.
35	Nonlegislative citizen members of the Commission shall be citizens of the Commonwealth.
36	B. The Commission shall elect a chairman and vice chairman from among its membership.
37	C. Nonlegislative citizen members shall be appointed for the duration of the Commission's activities.
38	Appointments to fill vacancies shall be for the unexpired terms. Vacancies shall be filled in the same
39 40	manner as the original appointments. § 2.2-2546. Quorum; meetings.
41	A majority of the members shall constitute a quorum. The meetings of the Commission will be held
42	at the call of the chair or whenever a majority of the members so request.
43	§ 2.2-2547. Compensation; expenses.
44	Nonlegislative citizen members of the Commission shall not receive compensation or reimbursement
45 46	for travel and other expenses incurred in the performance of their duties.
40 47	§ 2.2-2548. Powers and duties of the Commission. The Commission shall have the power and duty to:
48	1. Formulate and implement a program for the inclusive observance of the 250th anniversary of the
49	independence of the United States and the Revolutionary War in Virginia, including (i) civic, cultural,
50	and historical education and scholarship concerning the ideals of the American Revolution and their
51	contemporary relevance; (ii) visitation of museums and historic sites, including battlefields; (iii) creation
52 53	and publication of historical documents and studies; (iv) cooperation with agencies responsible for the
53 54	preservation or restoration of historic sites, buildings, art, and artifacts; (v) establishment of exhibitions and interpretive and wayfinding signage; (vi) arrangement of appropriate public ceremonies; (vii) a
55	comprehensive marketing and tourism campaign encompassing calendar year 2025 through calendar
56	year 2026; and (viii) the general dissemination of public information regarding Virginia's involvement in
57	the American Revolution and its legacy today;
58 50	2. Submit to the Governor and the General Assembly an annual executive summary of the interim
59	activity and work of the Commission no later than the first day of each regular session of the General

61 3. Solicit, accept, use, and dispose of funds appropriated by the General Assembly and any gifts, 62 grants, donations, bequests, or other funds received by the Commission for the purpose of aiding or 63 facilitating its work;

64 4. Appoint and establish an advisory council, to be led by the Commission member representing 65 Gunston Hall, composed of nonlegislative citizen members at large who have a knowledge of relevant 66 history or expertise in areas useful to the work of the Commission, including a representative of the Sons of the Revolution in the Commonwealth of Virginia, a representative of the Virginia Daughters of 67 the American Revolution, and a representative of the National Washington-Rochambeau Revolutionary 68 Route Association. The advisory council shall make recommendations and provide comment as requested 69 70 by the Commission. The Commission may from time to time appoint, add, or remove members of the 71 advisory council. Members of the advisory council shall serve without compensation or reimbursement;

72 5. Appoint and establish an executive committee composed of members of the Commission, to include 73 the Commission's chair and vice-chair and one representative designated by each of the following: the Jamestown-Yorktown Foundation, the Virginia Museum of History & Culture, and Gunston Hall; and 74

75 6. Perform such other duties, functions, and activities as may be necessary to facilitate and 76 implement the objectives of the Commission.

§ 2.2-2549. Cooperation of agencies of state and local government.

78 The Jamestown-Yorktown Foundation will be the primary state agency and fiscal agent for the 79 commemoration of the 250th anniversary of the American Revolution. All agencies of the Commonwealth and local governments are authorized, consistent with their missions, to provide assistance and advice to 80 the Jamestown-Yorktown Foundation, or directly to the Commission, in fulfilling all things necessary 81 and proper to plan for and implement the commemoration. The various agencies and institutions of the 82 Commonwealth, upon request of the Commission and approval of the respective agency head, shall 83 84 designate a liaison to coordinate assistance and services to the Commission from their agencies and 85 institutions. 86

§ 2.2-2550. Sunset.

This article shall expire on July 1, 2027.

88 2. That during the first year of its existence the American Revolution 250 Commission (the 89 Commission) created pursuant to this act shall be limited to two meetings, which shall be 90 convened by the Secretary of Education, for the purpose of developing a work plan for the 91 Commission. Such work plan shall include information related to staffing and proposed internal 92 organizational structure and funding needs. The Secretary shall submit a report on his findings 93 regarding the work plan, including any recommendations, to the Governor and the General Assembly by November 30, 2020. 94

95 3. That the membership of the American Revolution 250 Commission created pursuant to this act 96 shall be increased by the addition of legislative members in such number and of such composition 97 as determined by a bill passed by the 2021 Regular Session of the General Assembly that becomes
