1 VIRGINIA ACTS OF ASSEMBLY - CHAPTER 2 An Act to amend and reenact §§ 46.2-1503.4 and 46.2-1582 of the Code of Virginia and to repeal 3 § 46.2-1580 of the Code of Virginia, relating to motor vehicle dealer advertising. [S 524] 4 5 Approved 6 Be it enacted by the General Assembly of Virginia: 1. That §§ 46.2-1503.4 and 46.2-1582 of the Code of Virginia are amended and reenacted as 7 8 follows: 9 § 46.2-1503.4. General powers and duties of Board. 10 The powers and duties of the Board shall include, but not be limited to the following: 11 1. To establish the qualifications of applicants for certification or licensure, provided that all 12 qualifications shall be necessary to ensure competence and integrity. 2. To examine, or cause to be examined, the qualifications of each applicant for certification or 13 14 licensure, including the preparation, administration and grading of examinations. 15 3. To certify or license qualified applicants as motor vehicle dealers and motor vehicle salespersons. 4. To levy and collect fees for certification or licensure and renewal that are sufficient to cover all 16 17 expenses for the administration and operation of the Board. 18 5. To levy on licensees special assessments necessary to cover expenses of the Board. 19 6. To revoke, suspend, or fail to renew a certificate or license for just cause as set out in Articles 2 20 (§ 46.2-1508 et seq.), 3.1 (§ 46.2-1527.1 et seq.), 4 (§ 46.2-1528 et seq.), 8 (§ 46.2-1574 et seq.), and 9 21 (§ 46.2-1580 46.2-1581 et seq.) of this chapter or enumerated in regulations promulgated by the Board. 7. To ensure that inspections are conducted relating to the motor vehicle sales industry and to ensure 22 23 that all licensed dealers and salespersons are conducting business in a professional manner, not in 24 violation of any provision of Articles 2 (§ 46.2-1508 et seq.), 3.1 (§ 46.2-1527.1 et seq.), 4 (§ 46.2-1528 25 et seq.), 7 (§ 46.2-1566 et seq.), 8 (§ 46.2-1574 et seq.), and 9 (§ 46.2-1580 46.2-1581 et seq.) of this 26 chapter and within the lawful regulations promulgated by the Board. 27 8. To receive complaints concerning the conduct of persons and businesses licensed by the Board 28 and to take appropriate disciplinary action if warranted. 29 9. To enter into contracts necessary or convenient for carrying out the provisions of this chapter or 30 the functions of the Board. 31 10. To establish committees of the Board, appoint persons to such committees, and to promulgate 32 regulations establishing the responsibilities of these committees. Each of these committees shall include 33 at least one Board member and the Advertising, Dealer Practices and Transaction Recovery Fund 34 committees shall include at least one citizen member who is not licensed or certified by the Board. The Board may establish one of each committee in each DMV District. Committees to be established shall 35 36 include, but not be limited to the following: 37 a. Advertising; 38 b. Licensing; 39 c. Dealer Practices; 40 d. Franchise Review and Advisory Committee; and 41 e. Transaction Recovery Fund. 42 11. To do all things necessary and convenient for carrying into effect Articles 2, 3.1, 4, 8 and 9 of 43 this chapter or as enumerated in regulations promulgated by the Board. 44 § 46.2-1582. Enforcement; regulations. 45 A. The Board may promulgate regulations reasonably necessary for enforcement of this article. 46 B. In addition to any other sanctions or remedies available to the Board under this chapter, the Board 47 may assess a civil penalty not to exceed \$1,000 for any single violation of this article. Each day that a 48 violation continues shall constitute a separate violation. 49 C. The authority granted in this article shall be in addition to and not a substitute for the powers 50 and authority granted pursuant to the provisions of the Virginia Consumer Protection Act (§ 59.1-196 et 51 seq.). 52 2. That § 46.2-1580 of the Code of Virginia is repealed.
