SENATE BILL NO. 577

AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the House Committee on Appropriations
on February 28, 2020)

(Patron Prior to Substitute—Senator Howell)

A BILL to create a six-year capital outlay plan for projects to be funded entirely or partially from general fund-supported resources and to repeal Chapters 715 and 722 of the Acts of Assembly of 2017.

Be it enacted by the General Assembly of Virginia:

1. § 1. That the following capital outlay projects and descriptive information shall constitute the Commonwealth's capital outlay plan, pursuant to § 2.2-1518 of the Code of Virginia, for the capital projects supported entirely or partially from the general fund for the six-year period beginning July 1, 2020. These projects do not include projects that were previously funded and authorized to proceed to construction.
