o 9	Be it enacted by the General Assembly of Virginia:
10	1. That § 46.2-1078.1 of the Code of Virginia is amended and reenacted as follows:
11	§ 46.2-1078.1. Use of handheld personal communications devices in certain motor vehicles;
12	exceptions; penalty.
13	A. It is unlawful for any person to operate a moving motor vehicle on the highways in the
14	Commonwealth while using any handheld personal communications device to:
15	1. Manually enter multiple letters or text in the device as a means of communicating with another
16	person; or
17	2. Read any email or text message transmitted to the device or stored within the device, provided
18	that this prohibition shall not apply to any name or number stored within the device of any caller
19	identification information.
20	B. It is unlawful for any person while driving a moving motor vehicle in a highway work zone, in a
21	school crossing zone, or on the property of a school to hold in his hand a handheld personal
22	communications device.
23	C. The provisions of this section shall not apply to:
24	1. The operator of any emergency vehicle while he is engaged in the performance of his official
25	duties;
26	2. An operator who is lawfully parked or stopped;
27	3. The use of factory-installed or aftermarket global positioning systems (GPS) or wireless
28	communications devices used to transmit or receive data as part of a digital dispatch system; [or]
29	4. Any person using a handheld personal communications device to report an emergency [;
30	5. The use of an amateur or a citizens band radio; or
31 32	6. The operator of any Department of Transportation vehicle or vehicle operated pursuant to the
32 33	Department of Transportation safety service patrol program or pursuant to a contract with the Department of Transportation for, or that includes, traffic incident management services as defined in
33 34	subsection B of § 46.2-920.1 during the performance of traffic incident management services].
35	D. A violation of subsection A is a traffic infraction punishable, for a first offense, by a fine of \$125
36	and, for a second or subsequent offense, by a fine of $$250$. A violation of subsection B is punishable by
37	a mandatory fine of \$250.
38	E. For the purposes of this section:
39	"Emergency vehicle" means:
40	1. Any law-enforcement vehicle operated by or under the direction of a federal, state, or local
41	law-enforcement officer;
42	2. Any regional detention center vehicle operated by or under the direction of a correctional officer
43	responding to an emergency call or operating in an emergency situation;
44	3. Any vehicle used to fight fire, including publicly owned state forest warden vehicles, when
45	traveling in response to a fire alarm or emergency call;
46 47	4. Any emergency medical services vehicle designed or used for the principal purpose of emergency
48	medical services where human life is endangered;5. Any Department of Emergency Management vehicle or Office of Emergency Medical Services
49	vehicle, when responding to an emergency call or operating in an emergency situation;
50	6. Any Department of Corrections vehicle designated by the Director of the Department of
51	Corrections, when (i) responding to an emergency call at a correctional facility, (ii) participating in a
52	drug-related investigation, (iii) pursuing escapees from a correctional facility, or (iv) responding to a
53	request for assistance from a law-enforcement officer; and
54	7. Any vehicle authorized to be equipped with alternating, blinking, or flashing red or red and white
55	secondary warning lights pursuant to § 46.2-1029.2.
<u>56</u>	"Highway work zone" means a construction or maintenance area that is located on or beside a
57	highway and is marked by appropriate warning signs with attached flashing lights or other traffic control
58	devices indicating that work is in progress.
