15	As used in this chapter, unless the context requires another meaning:
16	"Alternative nicotine product" has the same meaning as in § 18.2-371.2.
17	"Child-resistant packaging" means packaging that is designed or constructed to meet the
18	child-resistant effectiveness standards set forth in 16 C.F.R. § 1700.15(b)(1) when tested in accordance
19	with the protocols described in 16 C.F.R. § 1700.20 as in effect on July 1, 2015.
20	"High-nicotine vapor product" means a nicotine vapor product or liquid nicotine that contains more
21	than 20 milligrams of nicotine per milliliter.
22	"Liquid nicotine" means a liquid or other substance containing nicotine in any concentration that is
23	sold, marketed, or intended for use in a nicotine vapor product.
24	"Liquid nicotine container" means a bottle or other container holding liquid nicotine in any
25	concentration but does not include a cartridge containing liquid nicotine if such cartridge is prefilled and
26	sealed by the manufacturer of such cartridge and is not intended to be opened by the consumer.
27	"Nicotine vapor product" has the same meaning as in § 18.2-371.2.
28 29	"Specialty retail facility" means a retail facility that generates at least 50 percent of its revenue from the sale of tobacco products; nicotine vapor products, including liquid nicotine; and alternative nicotine

30 31	"Tobacco product" has the same meaning as in § 18.2-371.2.
