SENATE BILL NO. 957

AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the House Committee on Rules

on February 27, 2020)

- (Patron Prior to Substitute—Senator Marsden) A BILL to amend and reenact § 30-348 of the Code of Virginia and to repeal § 30-354 of the Code of
- Virginia and the second enactment of Chapter 562 of the Acts of Assembly of 2014, relating to Commission on Civic Education; sunset and funding; membership.

9 Be it enacted by the General Assembly of Virginia:

10 1. That § 30-348 of the Code of Virginia is amended and reenacted as follows:

11 § 30-348. (Expires July 1, 2020) Commission on Civic Education; purpose; membership; terms.

The Commission on Civic Education (the Commission) is established in the legislative branch of state government. The purposes of the Commission are to (i) educate students on the importance of citizen involvement in a constitutional republic, (ii) promote the study of state and local government among the Commonwealth's citizenry, and (iii) enhance communication and collaboration among organizations in the Commonwealth that conduct civic education.

17 The Commission shall have a total membership of $\frac{15}{17}$ members that shall consist of eight five legislative members, six and 12 nonlegislative citizen members, and one ex officio member. Members 18 19 shall be appointed as follows: five three members of the House of Delegates, to be appointed by the 20 Speaker of the House of Delegates in accordance with the principles of proportional representation 21 contained in the Rules of the House of Delegates; three two members of the Senate, to be appointed by 22 the Senate Committee on Rules; three six nonlegislative citizen members, one of whom shall have a 23 background in curriculum development, interactive learning, and multimedia technology, one of whom 24 shall be a current or retired school civics teacher, and one of whom shall be a representative of an 25 organization that promotes civic learning two of whom shall be former or current government or civics teachers, one of whom shall be a representative of an organization involved in civic engagement, one of 26 27 whom shall be a representative of an institution of political or civil engagement studies center, one of 28 whom shall be a Department of Education social studies specialist, and one of whom shall have the 29 qualifications or experience as determined by the Speaker, to be appointed by the Speaker of the House 30 of Delegates; and three six nonlegislative citizen members, one of whom shall be a retired school civics teacher, one of whom shall be a representative of a public policy center of a public institution of higher 31 32 education in the Commonwealth, and one of whom shall be a representative of the Virginia Press 33 Association two of whom shall be current or former social studies coordinators, one of whom shall be a 34 representative of a voter outreach organization, one of whom shall be a member of the Virginia Press 35 Association, one of whom shall be a professor of social studies education, and one of whom shall have 36 the qualifications or experience as determined by the Senate Committee on Rules, to be appointed by the 37 Senate Committee on Rules. The Superintendent of Public Instruction or his designee shall serve ex 38 officio with voting privileges. Nonlegislative citizen members of the Commission shall be citizens of the 39 Commonwealth. Unless otherwise approved in writing by the chairman of the Commission, the Clerk of 40 the House of Delegates, and the Clerk of the Senate, nonlegislative citizen members shall only be 41 reimbursed for travel originating and ending within the Commonwealth for the purpose of attending 42 meetings.

Legislative members and the ex officio member of the Commission shall serve terms coincident with their terms of office. Nonlegislative citizen members shall be appointed for a term of two years. Appointments to fill vacancies, other than by expiration of a term, shall be for the unexpired terms. Legislative members and nonlegislative citizen members may be reappointed. However, no nonlegislative citizen member shall serve more than four consecutive two-year terms. The remainder of any term to which a member is appointed to fill a vacancy shall not constitute a term in determining the member's eligibility for reappointment. Vacancies shall be filled in the same manner as the original appointments.

50 The Commission shall elect a chairman and vice-chairman from among its membership, who shall be 51 members of the General Assembly.

- 52 2. That § 30-354 of the Code of Virginia is repealed.
- 53 3. That the second enactment of Chapter 562 of the Acts of Assembly of 2014 is repealed.
