

## Department of Planning and Budget 2020 Fiscal Impact Statement

**2. Patron:** McQuinn

**3. Committee:** Education and Health

**4. Title:** Minimum staffing ratio for school counselors.

**5. Summary:** Changes the effective date from school year 2019-2020 to school year 2020-2021 for the staffing standard that requires local school boards to employ school counselors in accordance with the following ratios: in elementary schools, one hour per day per 75 students, one full-time equivalent at 375 students, one hour per day additional time per 75 students or major fraction thereof; in middle schools, one period per 65 students, one full-time equivalent at 325 students, one additional period per 65 students or major fraction thereof; and in high schools, one period per 60 students, one full-time equivalent at 300 students, one additional period per 60 students or major fraction thereof. Effective with the 2021-2022 school year, the bill requires local school boards to employ one full-time equivalent school counselor position per 325 students in grades kindergarten through 12.

**7. Fiscal Impact Estimates:** Preliminary. See Item 8.

**8. Fiscal Implications:** The introduced budget, HB/SB 30, included \$21.2 million in FY 2021 to support the state share of cost for the additional school counselors required by this bill in school year 2020-2021, and included \$78.1 million in FY 2022 to support the state share of cost for one full-time equivalent school counselor position per 250 students in grades kindergarten through 12 in school year 2021-2022. Since the engrossed version of this bill requires less funding than is contained in the introduced budget, no budget amendment is necessary to fund the changes.

Further, the engrossed version of this bill is consistent with a House amendment to the budget that funds the state share of cost for one full-time equivalent school counselor position per 325 students in grades kindergarten through 12 for school year 2021-2022 and reduces the state general fund appropriation by \$53.2 million in FY 2022; thus, no budget amendment is necessary to comport to the House version of the budget.

A related Senate budget amendment funds the state share of cost for one full-time equivalent school counselor position per 300 students in grades kindergarten through 12 for school year 2021-2022 and reduces the state general fund appropriation by \$38.5 million in FY 2022.

**10. Technical Amendment Necessary:** No

**11. Other Comments:** This bill requires local school divisions to employ one full-time equivalent school counselor position per 300 students in high school for the 2020-2021 school year, and requires divisions to employ one full-time equivalent school counselor position per 325 students in grades kindergarten through 12 effective with the 2021-2022 school year. Local school divisions may employ additional counselors in the 2020-2021 school year that are not required in the 2021-2022 school year.
