4. Title: Historical African American cemeteries; Montgomery County and City of Radford.

5. Summary: This bill adds two cemeteries in Montgomery County and one in the City of Radford to the list of cemeteries for which qualified organizations may receive funds from the Department of Historic Resources for the care of historical African American cemeteries and graves. The cemeteries are the Wake Forest Cemetery and Westview Cemetery in Montgomery County, which respectively contain 40 and 47 eligible graves, and the Mountain View Cemetery in Radford, which contains 91 eligible graves.

8. Fiscal Implications: This bill specifically lists the Wake Forest Cemetery, Westview Cemetery and Mountain View Cemetery, with a combined total of 178 eligible graves. Based on the number of graves and the \$5.00 minimal payment for each, the estimated fiscal impact to the general fund would be at least \$890 per year. The fiscal impact of providing funding equal to the average actual cost of routine maintenance is indeterminate.

Budget language in paragraph I.1 of Item 385 in HB30/SB30, as introduced, provides \$100,000 in FY 2021 and \$150,000 in FY 2022 from the general fund to support the preservation and care of historical African American graves. Out of these amounts, \$54,655 in each year is for the care and maintenance of graves and cemeteries listed in the Code and in Item 385, paragraphs I.2. through I.10., and \$45,345 is available in FY 2021 and \$95,345

is available in FY 2022 to support the care and maintenance of historical African American cemeteries and graves in addition to those that are specifically listed in statute and the budget bill. It is anticipated that this funding is sufficient to support the care and maintenance of the 178 eligible graves in this bill at the \$5.00 minimal payment for each.

However, to add the graves and cemeteries provided for in this bill and the funding for their care and maintenance to those specifically listed in the budget in paragraphs I.2. through I.10., a language amendment to Item 385 of HB30/SB30, as introduced, would be required.

11. Other Comments: House Bills 1523 and 210 add historical African American cemeteries and graves to the list of cemeteries in the Code for the care and maintenance of which DHR may disburse funds. Additionally, House Bill 1523 creates the Historical African American Cemeteries and Graves Fund.
