- **5. Summary:** The proposed bill amends Code of Virginia § 19.2-163.04 to allow for the establishment of a public defender office to serve the cities of Manassas and Manassas Park and the county of Prince William.
- **6. Budget Amendment Necessary**: No. Item 48 of the Introduced Budget (HB30/SB30) provides appropriation to support this legislation at the partially-staffed level.

**8. Fiscal Implications:** The proposed bill would allow for the establishment of a public defender office to serve the cities of Manassas and Manassas Park and the county of Prince William.

According to cost estimates provided by the Virginia Indigent Defense Commission ("VIDC"), it would require 50 positions and \$3,906,958 to fully staff a public defender office in the Prince William area. Alternatively, a partially staff office consisting of approximately 35 positions could be operated at an annual cost of \$2,701,065. The positions to fund a partially-staffed public defender office in the Prince William area are shown in the table below:
