24	parts, sections and items, for the purposes stated and for the years indicated:
25	A. The balances of appropriations made by previous acts of the General Assembly which are
26	recorded as unexpended, as of the close of business on the last day of the previous biennium, on the
27	final records of the State Comptroller; and
28	B. The public taxes and arrears of taxes, as well as moneys derived from all other sources, which
29	shall come into the state treasury prior to the close of business on the last day of the current biennium.
30	The term "moneys" means nontax revenues of all kinds, including but not limited to fees, licenses,
