Limiting legislation to be considered by the 2020 Special Session I of the General Assembly and establishing a schedule for the conduct of business coming before such Special Session.

7 RESOLVED by the House of Delegates, That during the 2020 Special Session I of the General Assembly, summoned by proclamation of the Governor on July 17, 2020, to begin August 18, 2020, 8 except with the unanimous consent of the house in which the legislation is offered, no bill, joint 9 resolution, or resolution shall be offered in either house during the Special Session other than those 10 relating to (i) police reform and criminal and social justice reforms; (ii) impacts on health, education, 11 state and local government operations, business, and the Commonwealth's economy from the 12 Coronavirus Disease 2019 (COVID-19); (iii) Budget Bills; (iv) single-house commending or memorial 13 resolutions; (v) the rules of procedure or schedule of business of the General Assembly, either of its 14 15 houses, or any of its committees; or (vi) appointments subject to the confirmation of the General 16 Assembly or either house:

RESOLVED FURTHER, after adoption of this resolution, no member may introduce more than three 17 bills. The following shall not count against such limit: (i) legislation relating to the rules of procedure 18 19 or schedule of business of the General Assembly, either of its houses, or any of its committees, (ii) any 20 bill introduced with unanimous consent of the House, and (iii) bills or joint resolutions requested in 21 writing by the Governor;

22 **RESOLVED** FURTHER, That after the Special Session is convened for the first time, the House 23 may recess from time-to-time until reconvened with at least 48 hours' notice by the call of the Speaker 24 of the House of Delegates;

25 RESOLVED FURTHER, No engrossment of the Budget Bill shall be required. A report shall be issued concurrently with the report of the conference committee that identifies the following by item 26 27 number, narrative description, and dollar amount: (i) any nonstate agency appropriation, (ii) any item in 28 the conference report that was not included in a general appropriation bill as passed by either the House 29 or the Senate, and (iii) any item that represents legislation that failed in either house during the 2020 30 Regular Session or the Special Session described hereunder; and, be it 31

RESOLVED FINALLY, That for purposes of this resolution:

"Budget Bill" means a general appropriation bill introduced in each house that proposes amendments 32 33 to Chapter 1289 of the Acts of Assembly of 2020, the general appropriation act in effect for the period 34 July 1, 2020, through June 30, 2022.
