## **SENATE RESOLUTION NO. 505**

Offered August 18, 2020 Prefiled August 17, 2020

Commending the Virginia Hospital & Healthcare Association, Virginia's hospitals, and hospital workers.

## Patrons-Saslaw and McClellan

7 WHEREAS, the COVID-19 pandemic has impacted every aspect of life throughout the United States, 8 and the Virginia Hospital & Healthcare Association, Virginia's hospitals, and hospital workers have been 9 on the frontlines of the struggle to protect and defend public health during this unprecedented crisis; and WHEREAS, between March and August 2020, more than 101,000 people in the Commonwealth 10 tested positive for COVID-19, and while hospitals in Virginia treated and discharged more than 13,000 11 COVID-19 patients during that period, at least 2,300 Virginians tragically died from the deadly virus in 12 13 that same period; and

14 WHEREAS, the Virginia Hospital & Healthcare Association (VHHA), an alliance of 110 hospitals 15 and 26 health delivery systems in the Commonwealth, has played a leading role in the response to the 16 COVID-19 pandemic by working with members and stakeholders to ensure coordination and efficient communication during a rapidly evolving crisis; and 17

WHEREAS, Virginia's hospitals have ably adapted to the crisis by addressing workforce challenges, 18 19 expanding treatment capacity, managing supply chain interruptions, delivering direct care, and pioneering 20 new innovations to meet patients' needs; and

21 WHEREAS, early in the COVID-19 pandemic, Virginia's hospitals implemented drive-through testing 22 sites to reduce exposure and preserve hospital space for seriously ill patients; many hospitals and health 23 systems developed in-house testing capabilities by April 2020 now conduct more than 20 percent of the 24 Commonwealth's overall testing; and

25 WHEREAS, to ensure accurate and timely information, Virginia's hospitals partnered with the VHHA to launch an online data dashboard that collects and aggregates vital clinical intelligence from around the 26 27 Commonwealth to provide up-to-date statistics on the COVID-19 pandemic; and

28 WHEREAS, the VHHA and Virginia's hospitals have consistently worked with long-term care 29 providers to address the lasting effects of the disease and ensure continuity of care for individuals with 30 persistent health challenges unrelated to the COVID-19 pandemic or individuals in need of mental health or substance abuse treatment and throughout the crisis have provided partnership and support to 31 32 long-term care providers; and

33 WHEREAS, the VHHA and Virginia's hospitals have coordinated with other local, state, and national 34 agencies to prepare for and respond to a wide range of emergency situations related to the COVID-19 35 pandemic, as well as unrelated events that place further strain on the health care delivery system in the 36 Commonwealth and across the nation; and

WHEREAS, during the COVID-19 pandemic, the VHHA has also facilitated collaboration with 37 Virginia's first responders through the Virginia Healthcare Emergency Management Program, which is 38 39 composed of six regional coalitions that plan and prepare for emergencies and disasters; and

40 WHEREAS, doctors, nurses, hospital administrative and janitorial staff members, and other health 41 care professionals have taken significant risks and made personal sacrifices to fulfill their duties, including those who have contracted the virus while treating patients and many others who have needed 42 to isolate themselves from family and loved ones to avoid spreading the virus; and 43

WHEREAS, Virginia's hospitals and health delivery systems have nimbly evaluated and updated 44 emergency protocols, plans, and procedures to ensure that the Commonwealth is well-prepared for 45 46 potential future waves of infection and hospitalization surges; now, therefore, be it

RESOLVED by the Senate of Virginia, That the Virginia Hospital & Healthcare Association, 47 Virginia's hospitals, and hospital workers hereby be commended for their outstanding coordination and 48 49 exceptional service on behalf of all Virginians during the COVID-19 pandemic; and, be it

RESOLVED FURTHER, That the Clerk of the Senate prepare a copy of this resolution for 50 51 presentation to representatives of the Virginia Hospital & Healthcare Association, Virginia's hospitals, 52 and hospital workers as an expression of the Senate of Virginia's admiration for their unvielding 53 commitment to the health and safety of their fellow Virginians and gratitude for their heroic efforts to

54 fight the COVID-19 pandemic. SR505
