| 11 | 1. That § 8.01-246 of the Code of Virginia is amended and reenacted as follows: |
| 12 | § 8.01-246. Personal actions based on contracts. |
| 13 | Subject to the provisions of § 8.01-243 regarding injuries to person and property and of § 8.01-245 |
| 14 | regarding the application of limitations to fiduciaries, and their bonds, actions founded upon a contract, |
| 15 16 | other than actions on a judgment or decree, shall be brought within the following number of years next after the cause of action shall have accrued: |
| 17 | 1. In actions or upon a recognizance, except recognizance of bail in a civil suit, within 10 years; and |
| 18 | in actions or motions upon a recognizance of bail in a civil suit, within three years, omitting from the |
| 1 9 | computation of such three years such time as the right to sue out such execution shall have been |
| 20 | suspended by injunction, supersedeas or other process; |
| 21 | 2. In actions on any contract that is not otherwise specified and that is in writing and signed by the |
