| 11 | Be it enacted by the General Assembly of Virginia: |
| 12 | 1. That §§ 32.1-46, as it is currently effective and as it shall become effective, and 32.1-48 of the |
| 13 14 | Code of Virginia are amended and reenacted as follows: § 32.1-46. (Effective until July 1, 2021) Immunization of patients against certain diseases. |
| 15 | A. The parent, guardian or person standing in loco parentis of each child within this Commonwealth |
| 16 | shall cause such child to be immunized in accordance with the Immunization Schedule developed and |
| 17 | published by the Centers for Disease Control and Prevention (CDC), Advisory Committee on |
| 18 | Îmmunization Practices (ACIP), the American Academy of Pediatrics (AAP), and the American |
| 19 | Academy of Family Physicians (AAFP). The required immunizations for attendance at a public or |
| 20 21 | private elementary, middle or secondary school, child care center, nursery school, family day care home |
| ²¹ 22 | or developmental center shall be those set forth in the State Board of Health Regulations for the Immunization of School Children. The Board's regulations shall at a minimum require: |

60 B. A physician, physician assistant, nurse practitioner, registered nurse, licensed practical nurse, pharmacist, or local health department administering a vaccine required by this section shall provide to 61 62 the person who presents the child for immunizations a certificate that shall state the diseases for which 63 the child has been immunized, the numbers of doses given, the dates when administered and any further 64 immunizations indicated.

65 C. The vaccines required by this section shall meet the standards prescribed in, and be administered in accordance with, regulations of the Board. 66

D. The provisions of this section shall not apply if:

1. The parent or guardian of the child objects thereto on the grounds that the administration of 68 immunizing agents conflicts with his religious tenets or practices, unless an emergency or epidemic of 69 70 disease has been declared by the Board;

71 2. The parent or guardian presents a statement from a physician licensed to practice medicine in Virginia, a licensed nurse practitioner, or a local health department that states that the physical condition 72 of the child is such that the administration of one or more of the required immunizing agents would be 73 74 detrimental to the health of the child; or

75 3. Because the human papillomavirus is not communicable in a school setting, a parent or guardian, at the parent's or guardian's sole discretion, may elect for the parent's or guardian's child not to receive 76 77 the human papillomavirus vaccine, after having reviewed materials describing the link between the 78 human papillomavirus and cervical cancer approved for such use by the Board.

E. For the purpose of protecting the public health by ensuring that each child receives age-appropriate immunizations, any physician, physician assistant, nurse practitioner, licensed institutional health care provider, local or district health department, the Virginia Immunization Information System, and the Department of Health may share immunization and patient locator 79 80 81 82 information without parental authorization, including, but not limited to, the month, day, and year of 83 each administered immunization; the patient's name, address, telephone number, birth date, and social 84 security number; and the parents' names. The immunization information; the patient's name, address, 85 telephone number, birth date, and social security number; and the parents' names shall be confidential 86 87 and shall only be shared for the purposes set out in this subsection.

88 F. The State Board of Health shall review this section annually and make recommendations for 89 revision by September 1 to the Governor, the General Assembly, and the Joint Commission on Health 90 Care. 91

§ 32.1-46. (Effective July 1, 2021) Immunization of patients against certain diseases.

92 A. The parent, guardian or person standing in loco parentis of each child within this Commonwealth shall cause such child to be immunized in accordance with the Immunization Schedule developed and published by the Centers for Disease Control and Prevention (CDC), Advisory Committee on Immunization Practices (ACIP), the American Academy of Pediatrics (AAP), and the American 93 94 95 Academy of Family Physicians (AAFP). The required immunizations for attendance at a public or 96 97 private elementary, middle or secondary school, child care center, nursery school, family day care home, 98 or developmental center shall be those set forth in the State Board of Health Regulations for the 99 Immunization of School Children. The Board's regulations shall at a minimum require: 100

1. A minimum of three properly spaced doses of hepatitis B vaccine (HepB).

101 2. A minimum of three or more properly spaced doses of diphtheria toxoid. One dose shall be administered on or after the fourth birthday. 102

3. A minimum of three or more properly spaced doses of tetanus toxoid. One dose shall be 103 administered on or after the fourth birthday. 104

4. A minimum of three or more properly spaced doses of acellular pertussis vaccine. One dose shall 105 be administered on or after the fourth birthday. A booster dose shall be administered prior to entry into 106 107 the seventh grade.

5. Two or three primary doses of Haemophilus influenzae type b (Hib) vaccine, depending on the 108 manufacturer, for children up to 60 months of age. 109

6. Two properly spaced doses of live attenuated measles (rubeola) vaccine. The first dose shall be 110 administered at age 12 months or older. 111 112

7. One dose of live attenuated rubella vaccine shall be administered at age 12 months or older.

8. One dose of live attenuated mumps vaccine shall be administered at age 12 months or older.

9. Two properly spaced doses of varicella vaccine. The first dose shall be administered at age 12 114 115 months or older.

116 10. Three or more properly spaced doses of oral polio vaccine (OPV) or inactivated polio vaccine (IPV). One dose shall be administered on or after the fourth birthday. A fourth dose shall be required if 117 the three dose primary series consisted of a combination of OPV and IPV. 118

119 11. One to four doses, dependent on age at first dose, of properly spaced pneumococcal conjugate (PCV) vaccine for children up to 60 months of age. 120

121 12. Two doses of properly spaced human papillomavirus (HPV) vaccine. The first dose shall be administered before the child enters the seventh grade.

123 13. Two or three properly spaced doses of rotavirus vaccine, depending on the manufacturer, for 124 children up to eight months of age.

125 14. Two properly spaced doses of hepatitis A vaccine (HAV). The first dose shall be administered at age 12 months or older.

127 15. Two properly spaced doses of meningococcal conjugate vaccine (MenACWY). The first dose128 shall be administered prior to entry to seventh grade. The second dose shall be administered prior to129 entry to twelfth grade.

130 The parent, guardian or person standing in loco parentis may have such child immunized by a 131 physician, physician assistant, nurse practitioner, registered nurse, or licensed practical nurse, or a 132 pharmacist who administers pursuant to a valid prescription, or may present the child to the appropriate 133 local health department, which shall administer the vaccines required by the State Board of Health 134 Regulations for the Immunization of School Children without charge to the parent of or person standing 135 in loco parentis to the child if (i) the child is eligible for the Vaccines for Children Program or (ii) the child is eligible for coverages issued pursuant to Title XVIII of the Social Security Act, 42 U.S.C. 136 137 § 1395 et seq. (Medicare), Title XIX of the Social Security Act, 42 U.S.C. § 1396 et seq. (Medicaid), 138 Title XXI of the Social Security Act, 42 U.S.C. § 1397aa et seq. (CHIP), or 10 U.S.C. § 1071 et seq. 139 (CHAMPUS). In all cases in which a child is covered by a health carrier, Medicare, Medicaid, CHIP, or 140 CHAMPUS, the Department shall seek reimbursement from the health carrier, Medicare, Medicaid, 141 CHIP, or CHAMPUS for all allowable costs associated with the provision of the vaccine. For the 142 purposes of this section, the Department shall be deemed a participating provider with a managed care 143 health insurance plan as defined in § 32.1-137.1.

B. A physician, physician assistant, nurse practitioner, registered nurse, licensed practical nurse,
pharmacist, or local health department administering a vaccine required by this section shall provide to
the person who presents the child for immunizations a certificate that shall state the diseases for which
the child has been immunized, the numbers of doses given, the dates when administered and any further
immunizations indicated.

149 C. The vaccines required by this section shall meet the standards prescribed in, and be administered 150 in accordance with, the State Board of Health Regulations for the Immunization of School Children. The 151 State Board of Health shall amend the State Board of Health Regulations for the Immunization of 152 School Children as necessary from time to time to maintain conformity with evidence-based, routinely 153 recommended vaccinations for children. The adoption of such regulations shall be exempt from the 154 requirements of Article 2 (§ 2.2-4006 et seq.) of the Administrative Process Act (§ 2.2-4000 et seq.). 155 However, the Department shall (i) provide a Notice of Intended Regulatory Action and (ii) provide for a 156 60-day public comment period prior to the Board's adoption of the regulations.

157 D. The provisions of this section shall not apply if:

158 1. The parent or guardian of the child objects thereto on the grounds that the administration of
immunizing agents conflicts with his religious tenets or practices, unless an emergency or epidemic of
disease has been declared by the Board;

161 2. The parent or guardian presents a statement from a physician licensed to practice medicine in
162 Virginia, a licensed nurse practitioner, or a local health department that states that the physical condition
163 of the child is such that the administration of one or more of the required immunizing agents would be
164 detrimental to the health of the child; or

3. Because the human papillomavirus is not communicable in a school setting, a parent or guardian, at the parent's or guardian's sole discretion, may elect for the parent's or guardian's child not to receive the human papillomavirus vaccine, after having reviewed materials describing the link between the human papillomavirus and cervical cancer approved for such use by the Board.

169 E. For the purpose of protecting the public health by ensuring that each child receives 170 age-appropriate immunizations, any physician, physician assistant, nurse practitioner, licensed 171 institutional health care provider, local or district health department, the Virginia Immunization Information System, and the Department of Health may share immunization and patient locator 172 173 information without parental authorization, including, but not limited to, the month, day, and year of 174 each administered immunization; the patient's name, address, telephone number, birth date, and social 175 security number; and the parents' names. The immunization information; the patient's name, address, 176 telephone number, birth date, and social security number; and the parents' names shall be confidential 177 and shall only be shared for the purposes set out in this subsection.

F. The State Board of Health shall review this section annually and make recommendations for revision by September 1 to the Governor, the General Assembly, and the Joint Commission on Health Care.

181 § 32.1-48. Powers of Commissioner in epidemic.

SB1116

A. Nothing in this article shall preclude the Commissioner from requiring immediate immunization of all persons in case of an epidemic of any disease of public health importance for which a vaccine exists other than (i) a person to whose health the administration of a vaccine would be detrimental as certified in writing by a physician licensed to practice medicine in this Commonwealth or (ii) a person, including a parent or guardian on behalf of a child, who objects on the grounds that the administration of the vaccine conflicts with his religious tenets or practices.

188 B. In addition, the State Health Commissioner shall hold the powers conferred pursuant to Article 3.02 (§ 32.1-48.05 et seq.) of this chapter to issue orders of quarantine or prepare orders of isolation for

190 a communicable disease of public health threat.
