11	Be it enacted by the General Assembly of Virginia:
12	1. That § 3.2-6591 of the Code of Virginia is amended and reenacted and that the Code of Virginia
13	is amended by adding in Article 13 of Chapter 65 of Title 3.2 a section numbered 3.2-6593.1 as
14	follows:
15	§ 3.2-6591. Definitions.
16	As used in this article, unless the context requires a different meaning:
17	"Alternative test method" means a test method that (i) provides information of equivalent or better
18	scientific quality and relevance than animal test methods, (ii) has been identified by a validation body
19	and adopted by the relevant federal agency or program within an agency responsible for regulating the
20	specific product or activity for which the test is being conducted, and (iii) does not use animals, or,
21	when there is no test method available that does not use animals, uses the fewest animals possible and
22 23	reduces the level of suffering or stress, to the greatest extent possible, of an animal used for testing. "Alternative test method" includes computational toxicology and bioinformatics, high-throughput
23 24	screening methods, testing of categories of chemical substances, tiered testing methods, invitro studies,
25	and systems biology and new or revised methods.
26	"Animal" means any live vertebrate nonhuman animal.
27	"Animal test method" means a process or procedure that uses animals to obtain information on the
28	characteristics of a chemical or agent or the biological effect of exposure to a chemical or agent under
29	specified conditions.
30	"Animal testing facility" means any facility, including a private entity, state agency, or institution of
31	higher education, that confines and uses dogs or cats for research, education, testing, or other scientific
32	or medical purposes.
33 34	"Contract testing facility" means any partnership, corporation, association, or other legal relationship that tests chemicals, ingredients, product formulations, or products on behalf of another entity.
34 35	"Manufacturer" means any partnership, corporation, association, or other legal entity that produces
36	chemicals, ingredients, product formulations, or products.
37	"Validation body" means an organization that seeks to facilitate development, validation, and
38	regulatory acceptance of new and revised regulatory test methods that reduce, refine, or replace the use
39	of animals in testing, such as the Interagency Coordinating Committee on the Validation of Alternative
40	Methods or other similar organizations.
41	§ 3.2-6594. Animal testing facilities; adoption of dogs and cats.
42	Any animal testing facility that no longer has need for a dog or cat in its possession that does not
43 44	pose a health or safety risk to the public shall offer for release such dog or cat to a releasing agency for eventual adoption or for adoption through a private placement. Such animal testing facility shall
44 45	for eventual adoption or for adoption through a private placement. Such animal testing facility shall keep such offer for release open for a reasonable amount of time prior to euthanizing such dog or cat.
43 46	An animal testing facility may enter into an agreement with a releasing agency for the implementation
47	of the provisions of this section.
