20106090D 1 **SENATE BILL NO. 947** 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE 3 (Proposed by the Senate Committee on the Judiciary 4 on January 20, 2020) 5 (Patron Prior to Substitute—Senator Saslaw) 6 A BILL to amend and reenact §§ 19.2-392.1 and 19.2-392.2 of the Code of Virginia, relating to 7 expungement of police and court records; acquittals. 8 Be it enacted by the General Assembly of Virginia: 9 1. That §§ 19.2-392.1 and 19.2-392.2 of the Code of Virginia are amended and reenacted as 10 follows: 11 § 19.2-392.1. Statement of policy. The General Assembly finds that arrest records can be a hindrance to an innocent accused citizen's 12 13 ability to obtain employment, an education, and to obtain credit. It further finds that the police and court records of those of its citizens who have been absolutely pardoned for crimes for which they have been 14 15 unjustly convicted can also be a hindrance. This chapter is intended to protect such persons from the 16 unwarranted damage which that may occur as a result of being arrested and convicted. 17 § 19.2-392.2. Expungement of police and court records. 18 A. If a person is charged with the commission of a crime or any offense defined in Title 18.2, and 19 1. Is acquitted, or 20 2. A nolle prosequi is taken or the charge is otherwise dismissed, including dismissal by accord and 21 satisfaction pursuant to § 19.2-151, he may file a petition setting forth the relevant facts and requesting 22 expungement of the police records and the court records relating to the charge. 23 B. If any person whose name or other identification has been used without his consent or 24 authorization by another person who has been charged or arrested using such name or identification, he 25 may file a petition with the court disposing of the charge for relief pursuant to this section. Such person shall not be required to pay any fees for the filing of a petition under this subsection. A petition filed 26 27 under this subsection shall include one complete set of the petitioner's fingerprints obtained from a 28 law-enforcement agency. 29 C. The petition with a copy of the warrant or indictment if reasonably available shall be filed in the 30 circuit court of the county or city in which the case was disposed of by acquittal or being otherwise 31 dismissed and shall contain, except where not reasonably available, the date of arrest and the name of 32 the arresting agency. Where this information is not reasonably available, the petition shall state the 33 reason for such unavailability. The petition shall further state the specific criminal charge to be 34 expunged, the date of final disposition of the charge as set forth in the petition, the petitioner's date of 35 birth, and the full name used by the petitioner at the time of arrest. 36 D. A copy of the petition shall be served on the attorney for the Commonwealth of the city or 37 county in which the petition is filed. The attorney for the Commonwealth may file an objection or 38 answer to the petition or may give written notice to the court that he does not object to the petition 39 within 21 days after it is served on him. 40 E. The petitioner shall obtain from a law-enforcement agency one complete set of the petitioner's 41 fingerprints and shall provide that agency with a copy of the petition for expungement. The law-enforcement agency shall submit the set of fingerprints to the Central Criminal Records Exchange 42 (CCRE) with a copy of the petition for expungement attached. The CCRE shall forward under seal to 43 44 the court a copy of the petitioner's criminal history, a copy of the source documents that resulted in the CCRE entry that the petitioner wishes to expunge, and the set of fingerprints. Upon completion of the 45 hearing, the court shall return the fingerprint card to the petitioner. If no hearing was conducted, upon 46 the entry of an order of expungement or an order denying the petition for expungement, the court shall cause the fingerprint card to be destroyed unless, within 30 days of the date of the entry of the order, 47 **48** 49 the petitioner requests the return of the fingerprint card in person from the clerk of the court or provides 50 the clerk of the court with a self-addressed, stamped envelope for the return of the fingerprint card. 51 F. After receiving the criminal history record information from the CCRE, the court shall conduct a hearing on the petition. If the court finds that the continued existence and possible dissemination of 52 53 information relating to the arrest of the petitioner causes or may cause circumstances which constitute a 54 manifest injustice to the petitioner, it shall enter an order requiring the expungement of the police and court records, including electronic records, relating to the charge. Otherwise, it shall deny the petition. 55 However, if the petitioner has no prior criminal record and the arrest was for a misdemeanor violation, 56 the petitioner shall be entitled, in the absence of good cause shown to the contrary by the 57

58 Commonwealth, to expungement of the police and court records relating to the charge, and the court 59 shall enter an order of expungement. If the attorney for the Commonwealth of the county or city in

which the petition is filed (i) gives written notice to the court pursuant to subsection D that he does not
object to the petition and (ii) when the charge to be expunged is a felony, stipulates in such written
notice that the continued existence and possible dissemination of information relating to the arrest of the
petitioner causes or may cause circumstances which constitute a manifest injustice to the petitioner, the
court may enter an order of expungement without conducting a hearing.

65 G. The Commonwealth shall be made party defendant to the proceeding. Any party aggrieved by the decision of the court may appeal, as provided by law in civil cases.

67 H. Notwithstanding any other provision of this section, when the charge is dismissed because the 68 court finds that the person arrested or charged is not the person named in the summons, warrant, 69 indictment or presentment, the court dismissing the charge shall, upon motion of the person improperly 70 arrested or charged, enter an order requiring expungement of the police and court records relating to the 71 charge. Such order shall contain a statement that the dismissal and expungement are ordered pursuant to 72 this subsection and shall be accompanied by the complete set of the petitioner's fingerprints filed with 73 his petition. Upon the entry of such order, it shall be treated as provided in subsection K L.

74 I. Notwithstanding any other provision of this section, when the person is acquitted of a criminal 75 charge, the court entering a judgment of acquittal, on motion of the defendant and accompanied by one 76 complete set of the defendant's fingerprints obtained from a law-enforcement agency, shall enter an order requiring expungement of the police and court records relating to the charge. Such order shall 77 78 contain a statement that the dismissal and expungement are ordered pursuant to this subsection. Upon 79 the entry of such order, it shall be treated as provided in subsection L. Within 30 days of the date of the entry of the order, the court shall cause the fingerprint card to be destroyed unless the defendant 80 requests the return of the fingerprint card or provides the clerk of the court with a self-addressed, 81 82 stamped envelope for the return of the fingerprint card.

J. Notwithstanding any other provision of this section, upon receiving a copy pursuant to § 2.2-402
of an absolute pardon for the commission of a crime that a person did not commit, the court shall enter
an order requiring expungement of the police and court records relating to the charge and conviction.
Such order shall contain a statement that the expungement is ordered pursuant to this subsection. Upon
the entry of such order, it shall be treated as provided in subsection K L.

88 J. K. Upon receiving a copy of a writ vacating a conviction pursuant to § 19.2-327.5 or 19.2-327.13, **89** the court shall enter an order requiring expungement of the police and court records relating to the **90** charge and conviction. Such order shall contain a statement that the expungement is ordered pursuant to **91** this subsection. Upon the entry of the order, it shall be treated as provided in subsection K L.

92 K. L. Upon the entry of an order of expungement, the clerk of the court shall cause a copy of such order to be forwarded to the Department of State Police, which shall, pursuant to rules and regulations adopted pursuant to § 9.1-134, direct the manner by which the appropriate expungement or removal of such records shall be effected.

96 L. M. Costs shall be as provided by § 17.1-275, but shall not be recoverable against the
 97 Commonwealth. If the court enters an order of expungement, the clerk of the court shall refund to the
 98 petitioner such costs paid by the petitioner.

M. N. Any order entered where (i) the court or parties failed to strictly comply with the procedures
 set forth in this section or (ii) the court enters an order of expungement contrary to law, shall be
 voidable upon motion and notice made within three years of the entry of such order.
