32 33	2.§1. The following are hereby appropriated, for the current biennium, as set forth in succeeding parts, sections and items, for the purposes stated and for the years indicated:
33 34	A. The balances of appropriations made by previous acts of the General Assembly which are
35	recorded as unexpended, as of the close of business on the last day of the previous biennium, on the
36	final records of the State Comptroller; and
37	B. The public taxes and arrears of taxes, as well as moneys derived from all other sources, which
38	shall come into the state treasury prior to the close of business on the last day of the current biennium.

38 shall come into the state treasury prior to the close of business on the last day of the current biennium.
39 The term "moneys" means nontax revenues of all kinds, including but not limited to fees, licenses,
40 services and contract charges, gifts, grants, and donations, and projected revenues derived from proposed
41 legislation contingent upon General Assembly passage.

42 § 2. Such balances, public taxes, arrears of taxes, and monies derived from all other sources as are
43 not segregated by law to other funds, which funds are defined by the State Comptroller, pursuant to
44 § 2.2-803, Code of Virginia, shall establish and constitute the general fund of the state treasury.
