8 **Be it enacted by the General Assembly of Virginia:**

9 **1. That §§ 1 and 4 of the charter of the Town of Appomattox, which was granted by order of the**
10 **Circuit Court of the County of Appomattox on June 2, 1925, and as amended by Chapter 43 of**
11 **the Acts of Assembly of 1980, are amended and reenacted as follows:**

12 § 1. Election and appointment of officers, etc.

13 There shall be elected by the qualified voters of said town, every two years on the first Tuesday in
14 May of every even-numbered year, one elector thereof who shall be denominated the mayor, and six
15 electors, who shall be denominated the councilmen of said town. The mayor and six councilmen shall
16 constitute the council of said town. The town council ~~may appoint a treasurer, commissioner of the~~
17 ~~revenue and shall have the authority to appoint or employ a town clerk, a treasurer, a commissioner of~~
18 ~~revenue, a town manager, and the same person may serve in one or more of such capacities, and~~
19 ~~whenever deemed wise a health or sanitary officer, and such other officers as it may deem wise and~~
20 ~~necessary appropriate for the proper conduct of the government of said the town, and appoint~~
21 ~~committees and boards, and prescribe and fix their duties, and shall have power to fix the salary and~~
22 ~~compensation of said treasurer, town clerk, town manager and such other officers, necessary, but such~~
23 ~~compensation shall be fixed by said council before the officer chosen shall assume the duties of his~~
24 ~~office. The same person may serve in one or more of such capacities. The town council shall have the~~
25 ~~power to fix the salaries and compensation of said employees and appointees as necessary, but such~~
26 ~~compensation shall be fixed by said council before the individual chosen shall assume the duties of~~
27 ~~office. The town council may also appoint committees and boards and prescribe and fix their duties.~~

28 § 4. Terms of office - vacancy and how filled.

29 The mayor and members of council shall enter upon the duties of their office on the first day of
30 July, next succeeding their election, and shall continue in the office until their terms have expired, and
31 their successors shall have been elected and qualified in office on July 1, 2021, shall continue in office
32 until the expiration of the terms for which they were elected or until their successors are elected and
33 qualified. At the next election of members to the town council held on the first Tuesday in May 2022,
34 the three council candidates receiving the greatest number of votes shall be elected for
35 three-and-one-half year terms, and the three council candidates receiving the next greatest number of
36 votes and the mayor shall be elected for one-and-one-half year terms. Thereafter, the council members
37 shall be elected for terms of four years, and the mayor shall be elected for a term of two years, or until
38 their successors are elected and qualified. An election shall be held on the Tuesday following the first
39 Monday in November 2023 for the three council seats first expiring and for the mayor, and on the
40 Tuesday following the first Monday in November 2025 for the three council seats next expiring.
41 Elections thereafter shall be held every two years on the Tuesday following the first Monday in
42 November. The term of each person elected under this section at a November election shall begin on
43 January 1 next following the election. In case of a vacancy in the office of mayor, or councilmen,
44 elected by the electors of said town, caused by death, resignation or otherwise, such vacancy shall be
45 filled by a majority vote of the town council from the electors of the town for the unexpired term.
