10 11	Be it enacted by the General Assembly of Virginia:
12	1. That § 30-194 of the Code of Virginia is amended and reenacted as follows:
13	§ 30-194. Powers and duties of the Council; Chief Administrative Officer; annual report.
14 15	A. With regard to the architectural, historical, archeological, and landscape features of Capitol Square and antiquities contained therein, the Council shall:
16	1. Inventory and assess their condition;
17	2. Develop plans and recommendations for their maintenance and preservation and for the
18	enhancement of their historical and architectural integrity;
19 20	3. Develop recommendations for the promotion of activities and efforts that will enhance interpretive and educational opportunities; and
21	4. Review all plans or proposals for alterations, improvements, additions, renovations, or other
22	disposition that is structural or architectural in nature. No implementation of such plans or proposals
23 24	shall take place prior to review by the Council. The Council shall report its findings on each plan or proposal to the Governor and the agency responsible for the plan or proposal. However, the Council's
25	Chief Administrative Officer and the Director of the Department of General Services shall enter into a
26	memorandum of agreement describing the type of plans and proposals that are of such a routine or
27 28	5. Review and approve all plans or proposals for alterations, improvements, additions, or
<b>2</b> 9	renovations to, or other disposition of, any monuments, statuary, artwork, or other historical artifacts
30	contained within the Capitol Building, including within the old and new Senate chambers, the old and
31 32	new halls of the House of Delegates, and the Rotunda. B. The Council may employ a Chief Administrative Officer and determine his duties and
33	compensation within the amounts appropriated therefor. The Chief Administrative Officer shall be
34	qualified to carry out the duties to which he is assigned and shall work at the pleasure of the Council.
35 36	The Council may also obtain such assistance as it may deem necessary, and may employ, within the
30 37	amounts appropriated therefor, experts who have special knowledge of the issues before the Council. C. The Council may enter into partnerships, joint ventures, and other collaborative relationships with
38	organizations in furtherance of the Council's duties.
39 40	D. The Council may, unless otherwise restricted by the Governor or the General Assembly, under
40 41	terms approved by the Attorney General, accept gifts and grants in furtherance of its duties. This provision shall be deemed to be in addition to and not in conflict with any other powers or authorities
42	related to the acceptance of gifts and grants under other provisions of this Code.
43	E. The Council may enter into contracts in the furtherance of its duties in accordance with the Virginia Public Programment Act ( $S = 2, 4200$ at $s = 2$ )
44 45	Virginia Public Procurement Act (§ 2.2-4300 et seq.). F. Neither the Council nor its staff in fulfilling their responsibilities shall act in a manner inconsistent
46	with subsection A of § 2.2-1144.
47 48	G. The Council shall make a report on its activities and recommendations, if any, annually by
48 49	December 1 to the Governor and the General Assembly. The Council shall make such further interim reports to the Governor and the General Assembly as it deems advisable or as required by the General
50	Assembly.
