A BILL to amend and reenact §§ 18.2-36.1, 18.2-36.2, 20-108.1, and 20-108.2 of the Code of Virginia, relating to death of the parent or guardian of a child resulting from driving under the influence; child support.

Be it enacted by the General Assembly of Virginia:

1. That §§ 18.2-36.1, 18.2-36.2, 20-108.1, and 20-108.2 of the Code of Virginia are amended and reenacted as follows:

§ 18.2-36.1. Certain conduct punishable as involuntary manslaughter.

A. Any person who, as a result of driving under the influence in violation of clause (ii), (iii), or (iv) of § 18.2-266 or any local ordinance substantially similar thereto unintentionally causes the death of another person, shall be guilty of involuntary manslaughter.

B. If, in addition, the conduct of the defendant was so gross, wanton and culpable as to show a reckless disregard for human life, he shall be guilty of aggravated involuntary manslaughter, a felony punishable by a term of imprisonment of not less than one nor more than 20 years, one year of which shall be a mandatory minimum term of imprisonment.

C. *In any case where a person was convicted under the provisions of this section and the victim was the parent or legal guardian of a child, the person who has custody of such child may petition the sentencing court to order that the defendant pay child support. Upon such petition, the court shall determine such child support pursuant to the provisions in §§ 20-108.1 and 20-108.2.*

D. The provisions of this section shall not preclude prosecution under any other homicide statute. This section shall not preclude any other revocation or suspension required by law. The driver's license of any person convicted under this section shall be revoked pursuant to subsection B of § 46.2-391.

§ 18.2-36.2. Involuntary manslaughter; operating a watercraft while under the influence; penalties.

A. Any person who, as a result of operating a watercraft or motorboat in violation of clause (ii), (iii), or (iv) of subsection B of § 29.1-738 or a similar local ordinance, unintentionally causes the death of another person, is guilty of involuntary manslaughter.

B. If, in addition, the conduct of the defendant was so gross, wanton, and culpable as to show a reckless disregard for human life, he shall be guilty of aggravated involuntary manslaughter, a felony punishable by a term of imprisonment of not less than one nor more than 20 years, one year of which shall be a mandatory minimum term of imprisonment.

C. *In any case where a person was convicted under the provisions of this section and the victim was the parent or legal guardian of a child, the person who has custody of such child may petition the sentencing court to order that the defendant pay child support. Upon such petition, the court shall determine such child support pursuant to the provisions in §§ 20-108.1 and 20-108.2.*

D. The provisions of this section shall not preclude prosecution under any other homicide statute. The court shall order any person convicted under this section not to operate a watercraft or motorboat that is underway upon the waters of the Commonwealth. After five years have passed from the date of the conviction, the convicted person may petition the court that entered the conviction for the right to operate a watercraft or motorboat upon the waters of the Commonwealth. Upon consideration of such petition, the court may restore the right to operate a watercraft or motorboat subject to such terms and conditions as the court deems appropriate, including the successful completion of a water safety alcohol rehabilitation program described in § 29.1-738.5.

§ 20-108.1. Determination of child or spousal support.

A. In any proceeding on the issue of determining spousal support, the court shall consider all evidence presented relevant to any issues joined in that proceeding. The court's decision shall be rendered based upon the evidence relevant to each individual case.

B. In any proceeding on the issue of determining child support under this title, Title 16.1, or Title 63.2, or pursuant to a petition for child support filed pursuant to § 18.2-36.1 or 18.2-36.2, the court shall consider all evidence presented relevant to any issues joined in that proceeding. The court's decision in any such proceeding shall be rendered upon the evidence relevant to each individual case. However, there shall be a rebuttable presumption in any judicial or administrative proceeding for child

59 support, including cases involving split custody or shared custody, that the amount of the award that
60 would result from the application of the guidelines set out in § 20-108.2 is the correct amount of child
61 support to be awarded. Liability for support shall be determined retroactively for the period measured
62 from the date that the proceeding was commenced by the filing of an action with any court provided the
63 complainant exercised due diligence in the service of the respondent or, if earlier, the date an order of
64 the Department of Social Services entered pursuant to Title 63.2 and directing payment of support was
65 delivered to the sheriff or process server for service on the obligor.

66 In order to rebut the presumption, the court shall make written findings in the order, which findings
67 may be incorporated by reference, that the application of such guidelines would be unjust or
68 inappropriate in a particular case. The finding that rebuts the guidelines shall state the amount of support
69 that would have been required under the guidelines, shall give a justification of why the order varies
70 from the guidelines, and shall be determined by relevant evidence pertaining to the following factors
71 affecting the obligation, the ability of each party to provide child support, and the best interests of the
72 child:

- 73 1. Actual monetary support for other family members or former family members;
- 74 2. Arrangements regarding custody of the children, including the cost of visitation travel;
- 75 3. Imputed income to a party who is voluntarily unemployed or voluntarily under-employed;
76 provided that income may not be imputed to a custodial parent when a child is not in school, child care
77 services are not available and the cost of such child care services are not included in the computation
78 and provided further, that any consideration of imputed income based on a change in a party's
79 employment shall be evaluated with consideration of the good faith and reasonableness of employment
80 decisions made by the party, including to attend and complete an educational or vocational program
81 likely to maintain or increase the party's earning potential;
- 82 4. Any child care costs incurred on behalf of the child or children due to the attendance of a
83 custodial parent in an educational or vocational program likely to maintain or increase the party's
84 earning potential;
- 85 5. Debts of either party arising during the marriage for the benefit of the child;
- 86 6. Direct payments ordered by the court for maintaining life insurance coverage pursuant to
87 subsection D, education expenses, or other court-ordered direct payments for the benefit of the child;
- 88 7. Extraordinary capital gains such as capital gains resulting from the sale of the marital abode;
- 89 8. Any special needs of a child resulting from any physical, emotional, or medical condition;
- 90 9. Independent financial resources of the child or children;
- 91 10. Standard of living for the child or children established during the marriage;
- 92 11. Earning capacity, obligations, financial resources, and special needs of each parent;
- 93 12. Provisions made with regard to the marital property under § 20-107.3, where said property earns
94 income or has an income-earning potential;
- 95 13. Tax consequences to the parties including claims for exemptions, child tax credit, and child care
96 credit for dependent children;
- 97 14. A written agreement, stipulation, consent order, or decree between the parties which includes the
98 amount of child support; and
- 99 15. Such other factors as are necessary to consider the equities for the parents and children.

100 C. In any proceeding under this title, Title 16.1, or Title 63.2 on the issue of determining child
101 support, the court shall have the authority to order either party or both parties to provide health care
102 coverage or cash medical support, as defined in § 63.2-1900, or both, for dependent children if
103 reasonable under all the circumstances and health care coverage for a spouse or former spouse.

104 D. In any proceeding under this title, Title 16.1, or Title 63.2 on the issue of determining child
105 support, the court shall have the authority to order a party to (i) maintain any existing life insurance
106 policy on the life of either party provided the party so ordered has the right to designate a beneficiary
107 and (ii) designate a child or children of the parties as the beneficiary of all or a portion of such life
108 insurance for so long as the party so ordered has a statutory obligation to pay child support for the child
109 or children.

110 E. Except when the parties have otherwise agreed, in any proceeding under this title, Title 16.1, or
111 Title 63.2 on the issue of determining child support, the court shall have the authority to and may, in its
112 discretion, order one party to execute all appropriate tax forms or waivers to grant to the other party the
113 right to take the income tax dependency exemption and any credits resulting from such exemption for
114 any tax year or future years, for any child or children of the parties for federal and state income tax
115 purposes.

116 F. Notwithstanding any other provision of law, any amendments to this section shall not be
117 retroactive to a date before the effective date of the amendment, and shall not be the basis for a material
118 change in circumstances upon which a modification of child support may be based.

119 G. Child support payments, whether current or arrears, received by a parent for the benefit of and
120 owed to a child in the parent's custody, whether the payments were ordered under this title, Title 16.1,

or Title 63.2, or pursuant to a petition for child support filed pursuant to § 18.2-36.1 or 18.2-36.2, shall not be subject to garnishment. A depository wherein child support payments have been deposited on behalf of and traceable to an individual shall not be required to determine the portion of deposits that are subject to garnishment.

H. In any proceeding on the issue of determining child or spousal support or an action for separate maintenance under this title, Title 16.1, or Title 63.2, or pursuant to a petition for child support filed pursuant to § 18.2-36.1 or 18.2-36.2, when the earning capacity, voluntary unemployment, or voluntary under-employment of a party is in controversy, the court in which the action is pending, upon the motion of any party and for good cause shown, may order a party to submit to a vocational evaluation by a vocational expert employed by the moving party, including, but not limited to, any interviews and testing as requested by the expert. The order may permit the attendance of the vocational expert at the deposition of the person to be evaluated. The order shall specify the name and address of the expert, the scope of the evaluation, and shall fix the time for filing the report with the court and furnishing copies to the parties. The court may award costs or fees for the evaluation and the services of the expert at any time during the proceedings. The provisions of this section shall not preclude the applicability of any other rule or law.

§ 20-108.2. Guideline for determination of child support; quadrennial review by Child Support Guidelines Review Panel; executive summary.

A. There shall be a rebuttable presumption in any judicial or administrative proceeding for child support under this title or Title 16.1 or 63.2, including cases involving split custody, shared custody, or multiple custody arrangements pursuant to subdivisions G 4, 5, and 6, or pursuant to a petition for child support filed pursuant to § 18.2-36.1 or 18.2-36.2, that the amount of the award which would result from the application of the guidelines set forth in this section is the correct amount of child support to be awarded. In order to rebut the presumption, the court shall make written findings in the order as set out in § 20-108.1, which findings may be incorporated by reference, that the application of the guidelines would be unjust or inappropriate in a particular case as determined by relevant evidence pertaining to the factors set out in § 20-108.1. The Department of Social Services shall set child support at the amount resulting from computations using the guidelines set out in this section pursuant to the authority granted to it in Chapter 19 (§ 63.2-1900 et seq.) of Title 63.2 and subject to the provisions of § 63.2-1918.

B. For purposes of application of the guideline, a basic child support obligation shall be computed using the schedule set out below. For combined monthly gross income amounts falling between amounts shown in the schedule, basic child support obligation amounts shall be extrapolated. However, unless one of the following exemptions applies where the sole custody child support obligation as computed pursuant to subdivision G 1 is less than the statutory minimum per month, there shall be a presumptive minimum child support obligation of the statutory minimum per month payable by the payor parent. If the gross income of the obligor is equal to or less than 150 percent of the federal poverty level promulgated by the U.S. Department of Health and Human Services from time to time, then the court, upon hearing evidence that there is no ability to pay the presumptive statutory minimum, may set an obligation below the presumptive statutory minimum provided doing so does not create or reduce a support obligation to an amount which seriously impairs the custodial parent's ability to maintain minimal adequate housing and provide other basic necessities for the child. Exemptions from this presumptive minimum monthly child support obligation shall include: parents unable to pay child support because they lack sufficient assets from which to pay child support and who, in addition, are institutionalized in a psychiatric facility; are imprisoned for life with no chance of parole; are medically verified to be totally and permanently disabled with no evidence of potential for paying child support, including recipients of Supplemental Security Income (SSI); or are otherwise involuntarily unable to produce income. "Number of children" means the number of children for whom the parents share joint legal responsibility and for whom support is being sought. The guidelines worksheet relied upon by the court or the Department of Social Services to compute a child support obligation for a support order issued by such court or the Department shall be placed in the court's file or the Department's file, and a copy of such guidelines worksheet shall be provided to the parties.

877 C. For purposes of this section, "gross income" means all income from all sources, and shall include,
878 but not be limited to, income from salaries, wages, commissions, royalties, bonuses, dividends, severance
879 pay, pensions, interest, trust income, annuities, capital gains, social security benefits except as listed
880 below, workers' compensation benefits, unemployment insurance benefits, disability insurance benefits,
881 veterans' benefits, spousal support, rental income, gifts, prizes or awards.

882 If a parent's gross income includes disability insurance benefits, it shall also include any amounts
883 paid to or for the child who is the subject of the order and derived by the child from the parent's
884 entitlement to disability insurance benefits. To the extent that such derivative benefits are included in a
885 parent's gross income, that parent shall be entitled to a credit against his or her ongoing basic child
886 support obligation for any such amounts, and, if the amount of the credit exceeds the parent's basic child
887 support obligations, the credit may be used to reduce arrearages.

888 Gross income shall be subject to deduction of reasonable business expenses for persons with income
889 from self-employment, a partnership, or a closely held business. "Gross income" shall not include:

- 890 1. Benefits from public assistance and social services programs as defined in § 63.2-100;
- 891 2. Federal supplemental security income benefits;
- 892 3. Child support received; or
- 893 4. Income received by the payor from secondary employment income not previously included in
894 "gross income," where the payor obtained the income to discharge a child support arrearage established
895 by a court or administrative order and the payor is paying the arrearage pursuant to the order.
896 "Secondary employment income" includes but is not limited to income from an additional job, from
897 self-employment, or from overtime employment. The cessation of such secondary income upon the
898 payment of the arrearage shall not be the basis for a material change in circumstances upon which a
899 modification of child support may be based.

900 For purposes of this subsection: (i) spousal support received shall be included in gross income and
901 spousal support paid shall be deducted from gross income when paid pursuant to an order or written
902 agreement and (ii) one-half of any self-employment tax paid shall be deducted from gross income.

903 Where there is an existing court or administrative order or written agreement relating to the child or
904 children of a party to the proceeding, who are not the child or children who are the subject of the
905 present proceeding, then there is a presumption that there shall be deducted from the gross income of
906 the party subject to such order or written agreement, the amount that the party is actually paying for the
907 support of a child or children pursuant to such order or agreement.

908 Where a party to the proceeding has a natural or adopted child or children in the party's household
909 or primary physical custody, and the child or children are not the subject of the present proceeding, there
910 is a presumption that there shall be deducted from the gross income of that party the amount as shown
911 on the Schedule of Monthly Basic Child Support Obligations contained in subsection B that represents
912 that party's support obligation based solely on that party's income as being the total income available for
913 the natural or adopted child or children in the party's household or primary physical custody, who are
914 not the subject of the present proceeding. Provided, however, that the existence of a party's financial
915 responsibility for such a child or children shall not of itself constitute a material change in circumstances
916 for modifying a previous order of child support in any modification proceeding. Any adjustment to gross
917 income under this subsection shall not create or reduce a support obligation to an amount which
918 seriously impairs the custodial parent's ability to maintain minimal adequate housing and provide other
919 basic necessities for the child, as determined by the court.

920 In cases in which retroactive liability for support is being determined, the court or administrative
921 agency may use the gross monthly income of the parties averaged over the period of retroactivity.

922 D. Except for good cause shown or the agreement of the parties, in addition to any other child
923 support obligations established pursuant to this section, any child support order shall provide that the
924 parents pay in proportion to their gross incomes, as used for calculating the monthly support obligation,
925 any reasonable and necessary unreimbursed medical or dental expenses. The method of payment of those

expenses shall be contained in the support order. Each parent shall pay his respective share of expenses as those expenses are incurred. Any amount paid under this subsection shall not be adjusted by, nor added to, the child support calculated in accordance with subsection G. For the purposes of this section, medical or dental expenses shall include but not be limited to eyeglasses, prescription medication, prosthetics, orthodontics, and mental health or developmental disabilities services, including but not limited to services provided by a social worker, psychologist, psychiatrist, counselor, or therapist.

D1. In any initial child support proceeding commenced within six months of the birth of a child, except for good cause shown or the agreement of the parties, in addition to any other child support obligations established pursuant to this section, the child support order shall provide that the parents pay in proportion to their gross incomes, as used for calculating the monthly support obligation, any reasonable and necessary unpaid expenses of the mother's pregnancy and the delivery of such child. Any amount paid under this subsection shall not be adjusted by, nor added to, the child support calculated in accordance with subsection G.

E. The costs for health care coverage as defined in § 63.2-1900, vision care coverage, and dental care coverage for the child or children who are the subject of the child support order that are being paid by a parent or that parent's spouse shall be added to the basic child support obligation. To determine the cost to be added to the basic child support obligation, the cost per person shall be applied to the child or children who are subject of the child support order. If the per child cost is provided by the insurer, that is the cost per person. Otherwise, to determine the cost per person, the cost of individual coverage for the policy holder shall be subtracted from the total cost of the coverage, and the remaining amount shall be divided by the number of remaining covered persons.

F. Any child-care costs incurred on behalf of the child or children due to employment of the custodial parent shall be added to the basic child support obligation. Child-care costs shall not exceed the amount required to provide quality care from a licensed source. When requested by the noncustodial parent, the court may require the custodial parent to present documentation to verify the costs incurred for child care under this subsection. Where appropriate, the court shall consider the willingness and availability of the noncustodial parent to provide child care personally in determining whether child-care costs are necessary or excessive. Upon the request of either party, and upon a showing of the tax savings a party derives from child-care cost deductions or credits, the court shall factor actual tax consequences into its calculation of the child-care costs to be added to the basic child support obligation.

G. 1. Sole custody support. The sole custody total monthly child support obligation shall be established by adding (i) the monthly basic child support obligation, as determined from the schedule contained in subsection B, (ii) costs for health care coverage to the extent allowable by subsection E, and (iii) work-related child-care costs and taking into consideration all the factors set forth in subsection B of § 20-108.1. The total monthly child support obligation shall be divided between the parents in the same proportion as their monthly gross incomes bear to their monthly combined gross income. The monthly obligation of each parent shall be computed by multiplying each parent's percentage of the parents' monthly combined gross income by the total monthly child support obligation.

However, the monthly obligation of the noncustodial parent shall be reduced by the cost for health care coverage to the extent allowable by subsection E when paid directly by the noncustodial parent or that parent's spouse. Unreimbursed medical and dental expenses shall be calculated and allocated in accordance with subsection D.

2. Split custody support. In cases involving split custody, the amount of child support to be paid shall be the difference between the amounts owed by each parent as a noncustodial parent, computed in accordance with subdivision 1, with the noncustodial parent owing the larger amount paying the difference to the other parent. Unreimbursed medical and dental expenses shall be calculated and allocated in accordance with subsection D.

For the purpose of this section and § 20-108.1, split custody shall be limited to those situations where each parent has physical custody of a child or children born of the parents, born of either parent and adopted by the other parent or adopted by both parents. For the purposes of calculating a child support obligation where split custody exists, a separate family unit exists for each parent, and child support for that family unit shall be calculated upon the number of children in that family unit who are born of the parents, born of either parent and adopted by the other parent or adopted by both parents. Where split custody exists, a parent is a custodial parent to the children in that parent's family unit and is a noncustodial parent to the children in the other parent's family unit.

3. Shared custody support.

(a) Where a party has custody or visitation of a child or children for more than 90 days of the year, as such days are defined in subdivision G 3 (c), a shared custody child support amount based on the ratio in which the parents share the custody and visitation of any child or children shall be calculated in accordance with this subdivision. The presumptive support to be paid shall be the shared custody support amount, unless a party affirmatively shows that the sole custody support amount calculated as

provided in subdivision G 1 is less than the shared custody support amount. If so, the lesser amount shall be the support to be paid. For the purposes of this subsection, the following shall apply:

(i) Income share. "Income share" means a parent's percentage of the combined monthly gross income of both parents. The income share of a parent is that parent's gross income divided by the combined gross incomes of the parties.

(ii) Custody share. "Custody share" means the number of days that a parent has physical custody, whether by sole custody, joint legal or joint residential custody, or visitation, of a shared child per year divided by the number of days in the year. The actual or anticipated "custody share" of the parent who has or will have fewer days of physical custody shall be calculated for a one-year period. The "custody share" of the other parent shall be presumed to be the number of days in the year less the number of days calculated as the first parent's "custody share." For purposes of this calculation, the year may begin on such date as is determined in the discretion of the court, and the day may begin at such time as is determined in the discretion of the court. For purposes of this calculation, a day shall be as defined in subdivision G 3 (c).

(iii) Shared support need. "Shared support need" means the presumptive guideline amount of needed support for the shared child or children calculated pursuant to subsection B of this section, for the combined gross income of the parties and the number of shared children, multiplied by 1.4.

(iv) Sole custody support. "Sole custody support" means the support amount determined in accordance with subdivision G 1.

(b) Support to be paid. The shared support need of the shared child or children shall be calculated pursuant to subdivision G 3 (a) (iii). This amount shall then be multiplied by the other parent's custody share. To that sum for each parent shall be added the other parent's or that parent's spouse's cost of health care coverage to the extent allowable by subsection E, plus the other parent's work-related child-care costs to the extent allowable by subsection F. This total for each parent shall be multiplied by that parent's income share. The support amounts thereby calculated that each parent owes the other shall be subtracted one from the other and the difference shall be the shared custody support one parent owes to the other, with the payor parent being the one whose shared support is the larger. Unreimbursed medical and dental expenses shall be calculated and allocated in accordance with subsection D.

(c) Definition of a day. For the purposes of this section, "day" means a period of 24 hours; however, where the parent who has the fewer number of overnight periods during the year has an overnight period with a child, but has physical custody of the shared child for less than 24 hours during such overnight period, there is a presumption that each parent shall be allocated one-half of a day of custody for that period.

(d) Minimum standards. Any calculation under this subdivision shall not create or reduce a support obligation to an amount which seriously impairs the custodial parent's ability to maintain minimal adequate housing and provide other basic necessities for the child. If the gross income of either party is equal to or less than 150 percent of the federal poverty level promulgated by the U.S. Department of Health and Human Services from time to time, then the shared custody support calculated pursuant to this subsection shall not be the presumptively correct support and the court may consider whether the sole custody support or the shared custody support is more just and appropriate.

(e) Support modification. When there has been an award of child support based on the shared custody formula and one parent consistently fails to exercise custody or visitation in accordance with the parent's custody share upon which the award was based, there shall be a rebuttable presumption that the support award should be modified.

(f) In the event that the shared custody support calculation indicates that the net support is to be paid to the parent who would not be the parent receiving support pursuant to the sole custody calculation, then the shared support shall be deemed to be the lesser support.

4. Multiple shared custody support. In cases with different shared custody arrangements for two or more minor children of the parties, the procedures in subdivision G 3 shall apply, except that one shared guideline shall be used to determine the total amount of child support owed by one parent to the other by:

(a) Calculating each parent's custody share by adding the total number of days, as defined in subdivision G 3 (c), that each parent has with each child and dividing such total number of days by the number of children of the parties to determine the average number of shared custody days; and

(b) Using each parent's custody share as determined in subdivision G 4 (a) for each parent to calculate the child support owed, in accordance with the provisions of subdivision G 3.

5. Sole and shared custody support. In cases where one parent has sole custody of one or more minor children of the parties, and the parties share custody of one or more other minor children of the parties, the procedures in subdivisions G 1 and 3 shall apply, except that one sole custody support guideline calculation and one shared custody support guideline calculation shall be used to determine the total amount of child support owed by one parent to the other by:

(a) Calculating the sole custody support obligation by:

(i) Calculating the per child monthly basic child support obligation by determining, for the number of children of the parties, the scheduled monthly basic child support obligation and dividing that amount by the number of children of the parties;

(ii) Calculating the sole custody pro rata monthly basic child support obligation by multiplying the per child monthly basic child support obligation determined in subdivision G 5 (a) (i) by the number of children subject to the sole custody support obligation; and

(iii) Applying the sole custody pro rata monthly basic child support obligation determined in subdivision G 5 (a) (ii) to the procedures in subdivision G 1.

(b) Calculating the shared custody child support obligation by:

(i) Calculating the per child monthly basic child support obligation by determining, for the number of children of the parties, the scheduled monthly basic child support obligation and dividing that amount by the number of children of the parties;

(ii) Calculating the shared custody pro rata monthly basic child support obligation by multiplying the per child monthly basic child support obligation determined in subdivision G 5 (b) (i) by the number of children subject to the shared custody support obligation; and

(iii) Applying the shared custody pro rata monthly basic child support obligation determined in subdivision G 5 (b) (ii) to the procedures in subdivision G 3.

(c) Determining the total amount of child support owed by one parent to the other. Where one parent owes both the sole custody support obligation and the shared custody support obligation to the other parent, the total of both such obligations calculated pursuant to subdivisions G 5 (a) and G 5 (b) shall be added to determine the total amount of child support owed by one parent to the other. Where one parent owes one such obligation to the other parent, and such other parent owes the other such obligation to the other such parent, the parent owing the greater obligation amount to the other parent shall pay the difference between the obligations to such other parent.

6. Split and shared custody support. In cases where the parents have split custody of two or more children, and there is a shared custody arrangement with one or more other minor children of the parties, the procedures set forth in subdivisions G 2 and G 3 shall apply, except that one split custody child support guideline calculation and one shared custody child support guideline calculation shall be used to calculate the total amount of child support owed by one parent to the other by:

(a) Calculating the split custody child support obligation by:

(i) Calculating the per child monthly basic child custody support obligation by determining, for the number of children of the parties, the scheduled monthly basic child support obligation and dividing that amount by the number of children of the parties;

(ii) Calculating the split custody pro rata monthly basic child support obligation by multiplying the per child monthly basic child support obligation determined in subdivision G 6 (a) (i) by the number of children subject to the split custody support obligation; and

(iii) Applying the split custody pro rata monthly basic child support obligation determined in subdivision G 6 (a) (ii) for each parent to the procedures in subdivision G 2.

(b) Calculating the shared custody child support obligation by:

(i) Calculating the per child monthly basic child custody support obligation by determining, for the number of children of the parties, the scheduled monthly basic child support obligation and dividing that amount by the number of children of the parties;

(ii) Calculating the shared custody pro rata monthly basic child custody support obligation by multiplying the per child monthly basic child support obligation determined in subdivision G 6 (b) (i) by the number of children subject to the shared custody support obligation; and

(iii) Applying the shared custody pro rata monthly basic child support obligation determined in subdivision G 6 (b) (ii) to the procedures in subdivision G 3.

(c) Determining the total amount of child support owed by one parent to the other. Where one parent owes both the split custody support obligation and the shared custody support obligation to the other parent, the total of both such obligations calculated pursuant to subdivisions G 6 (a) and G 6 (b) shall be added to determine the total amount of child support owed by one parent to the other. Where one parent owes one such obligation to the other parent, and such other parent owes the other such obligation to the other such parent, the parent owing the greater obligation amount to the other parent shall pay the difference between the obligations to such other parent.

H. The Secretary of Health and Human Resources shall ensure that the guideline set out in this section is reviewed by October 31, 2001, and every four years thereafter, by the Child Support Guidelines Review Panel, consisting of 15 members comprised of four legislative members and 11 nonlegislative citizen members. Members shall be appointed as follows: three members of the House Committee for Courts of Justice, upon the recommendation of the chairman of such committee, to be appointed by the Speaker of the House of Delegates in accordance with the principles of proportional representation contained in the Rules of the House of Delegates; one member of the Senate Committee

1110 for Courts of Justice, upon the recommendation of the chairman of such committee, to be appointed by
1111 the Senate Committee on Rules; and one representative of a juvenile and domestic relations district
1112 court, one representative of a circuit court, one representative of the Department of Social Services'
1113 Division of Child Support Enforcement, three members of the Virginia State Bar, two custodial parents,
1114 two noncustodial parents, and one child advocate, upon the recommendation of the Secretary of Health
1115 and Human Resources, to be appointed by the Governor. The Panel shall determine the adequacy of the
1116 guideline for the determination of appropriate awards for the support of children by considering current
1117 research and data on the cost of and expenditures necessary for rearing children, and any other resources
1118 it deems relevant to such review. The Panel shall report its findings to the General Assembly as
1119 provided in the procedures of the Division of Legislative Automated Systems for the processing of
1120 legislative documents and reports before the General Assembly next convenes following such review.

1121 Legislative members shall serve terms coincident with their terms of office. Nonlegislative citizen
1122 members shall serve at the pleasure of the Governor. All members may be reappointed. Appointments to
1123 fill vacancies, other than by expiration of a term, shall be made for the unexpired terms. Vacancies shall
1124 be filled in the same manner as the original appointments.

1125 Legislative members shall receive such compensation as provided in § 30-19.12, and nonlegislative
1126 citizen members shall receive such compensation for the performance of their duties as provided in
1127 § 2.2-2813. All members shall be reimbursed for all reasonable and necessary expenses incurred in the
1128 performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the costs of
1129 compensation and expenses of the members shall be provided by the Department of Social Services.

1130 The Department of Social Services shall provide staff support to the Panel. All agencies of the
1131 Commonwealth shall provide assistance to the Panel, upon request.

1132 The chairman of the Panel shall submit to the Governor and the General Assembly a quadrennial
1133 executive summary of the interim activity and work of the Panel no later than the first day of 2006
1134 regular session of the General Assembly and every four years thereafter. The executive summary shall
1135 be submitted as provided in the procedures of the Division of Legislative Automated Systems for the
1136 processing of legislative documents and reports and shall be posted on the General Assembly's website.
