16	§ 16.1-229.2. Best interests of the child.
17	In determining the best interests of a child, the court shall, as applicable, consider the child's
18	attachment to the parent or guardian.
19	For the purposes of this section, "attachment" means an aspect of the child's relationship with a
20	parent or guardian that promotes the child's use of the parent or guardian as a secure base from which
21	to explore, learn, and relate and to feel value, security, comfort, familiarity, and continuity.
22	§ 20-124.3. Best interests of the child; visitation.
23	A. In determining the best interests of a child for purposes of determining custody or visitation
24	arrangements, including any pendente lite orders pursuant to § 20-103, the court shall consider the
25	following:
26 27	1. The age and physical and mental condition of the child, giving due consideration to the child's changing developmental needs;
28	2. The age and physical and mental condition of each parent;
29	3. The relationship existing between each parent and each child, giving due consideration to the
30	child's attachment to the parent and the parent's positive involvement with the child's life, the and
31	ability to accurately assess and meet the emotional, intellectual, and physical needs of the child;
32	4. The needs of the child, giving due consideration to other important relationships of the child,
33	including but not limited to siblings, peers, and extended family members;
34	5. The role that each parent has played and will play in the future, in the upbringing and care of the
35	child;
36	6. The propensity of each parent to actively support the child's contact and relationship with the other
37 38	parent, including whether a parent has unreasonably denied the other parent access to or visitation with the child;
39	7. The relative willingness and demonstrated ability of each parent to maintain a close and
4 0	continuing relationship with the child, and the ability of each parent to cooperate in and resolve disputes
41	regarding matters affecting the child;
42	8. The reasonable preference of the child, if the court deems the child to be of reasonable
43	intelligence, understanding, age, and experience to express such a preference;
44	9. Any history of (i) family abuse as that term is defined in § 16.1-228; (ii) sexual abuse; (iii) child
45	abuse; or (iv) an act of violence, force, or threat as defined in § 19.2-152.7:1 that occurred no earlier
