That § 51.5-135 of the Code of Virginia is amended and reenacted as follows: 11 § 51.5-135. Powers and duties of Department with respect to aging persons; area agencies on 12 13 aging. 14 A. The Department shall provide aging services to improve the quality of life for and meet the needs 15 of older persons in the Commonwealth and shall act as a focal point among state agencies for research, 16 policy analysis, long-range planning, and education on aging issues. In providing aging services, the The Department shall use available resources to provide services to older persons with the greatest economic 17 18 needs and those with the greatest social needs. In allocating resources to provide aging services, the Department (i) shall prioritize providing services to those with the greatest economic need and (ii) 19 20 among individuals with comparable levels of economic need, may prioritize providing services to individuals with the greatest social need. The Department shall also serve as the lead agency in 21 22 coordinating the work of state agencies on meeting the needs of an aging society. The Department's 23 policies and programs shall be designed to enable older persons to be as independent and self-sufficient 24 as possible. The Department shall promote local participation in programs for older persons, evaluate 25 and monitor aging services, and provide information to the general public. In furtherance of this mission, the Department shall have, without limitation, the following duties to: 26 27 1. Study the economic, social, and physical condition of the residents in the Commonwealth whose 28 age qualifies them for coverage under the Older Americans Act, 42 U.S.C. § 3001 et seq., or any law 29 amendatory or supplemental thereto, and the employment, medical, educational, recreational, and housing 30 facilities available to them, with the view of determining the needs and problems of such persons; 31 2. Determine the services and facilities, private and governmental and state and local, provided for and available to older persons and recommend to the appropriate persons such coordination of and 32 33 changes in such services and facilities as will make them of greater benefit to older persons and more 34 responsive to their needs: 35 3. Act as the designated state unit on aging for the purposes of carrying out the requirements under 36 P.L. 89-73 or any law amendatory or supplemental thereto, and as the sole agency for administering or 37 supervising the administration of such plans as may be adopted in accordance with the provisions of 38 such laws. The Department may prepare, submit, and carry out state plans and shall be the agency 39 primarily responsible for coordinating state programs and activities related to the purposes of, or 40 undertaken under, such plans or laws; 41 4. Apply, with the approval of the Governor, for and expend such grants, gifts, or bequests from any 42 source that becomes available in connection with its duties under this section, and may comply with such conditions and requirements as may be imposed in connection therewith; 43 5. Hold hearings and conduct investigations necessary to pass upon applications for approval of a 44 project under the plans and laws set out in subdivision 3, and shall make reports to the U.S. Secretary 45 46 of Health and Human Services as may be required; 6. Designate area agencies on aging pursuant to P.L. 89-73 or any law amendatory or supplemental 47 thereto of the Congress of the United States and to adopt regulations for the composition and operation 48 49 of such area agencies on aging, each of which shall be designated as the lead agency in each respective 50 area for the No Wrong Door system of aging and disability resource centers; 51 7. Provide staff support to the Commonwealth Council on Aging; 52 8. Assist state, local, and nonprofit agencies, including, but not limited to, area agencies on aging, in 53 identifying grant and public-private partnership opportunities for improving services to older Virginians; 9. Provide or contract for the administration of the state long-term care ombudsman program. Such 54 55 program or contract shall provide a minimum staffing ratio of one ombudsman to every 2,000 long-term care beds, subject to sufficient appropriations by the General Assembly. The Department may also 56 contract with such entities for the administration of elder rights programs as authorized under P.L. 57

89-73, such as insurance counseling and assistance, and the creation of an elder information/elder rights

60 10. Serve as the focal point for the rights of older persons and their families by establishing,
61 maintaining, and publicizing (i) a toll-free number and (ii) a means of electronic access to provide
62 resource and referral information and other assistance and advice as may be requested; and

63 11. Develop and maintain a four-year plan for aging services in the Commonwealth, pursuant to § 51.5-136.

65 B. The governing body of any county, city, or town may appropriate funds for support of area 66 agencies on aging designated pursuant to subdivision A 6.

67 C. All agencies of the Commonwealth shall assist the Department in effectuating its functions in 68 accordance with its designation as the single state agency as required in subdivision A 3.
