10	Be it enacted by the General Assembly of Virginia:
11	1. That the Code of Virginia is amended by adding in Title 30 a chapter numbered 64, consisting
12	of sections numbered 30-409 through 30-413, as follows:
13	CHAPTER 64.
14 15	SCHOOL HEALTH SERVICES COMMITTEE. § 30-409. School Health Services Committee; purpose.
15 16	The School Health Services Commutee, purpose. The School Health Services Committee (the Committee) is established in the legislative branch of
17	state government. The purpose of the Committee is to review and provide advice to the General
18	Assembly and other policy makers regarding proposals that require local school boards to offer certain
19	health services in a school setting. The Committee shall submit its findings and recommendations to the
20	General Assembly and the Governor by October 1 of each year.
2 ľ	§ 30-410. Membership; terms; quorum; meetings.
22	A. The Committee shall have a total membership of 14 members that shall consist of 8 legislative
23	members, four nonlegislative citizen members, and two ex officio members. Members shall be appointed
24	as follows: three members of the Senate, each of whom shall be a member of the Senate Committee on
25	Education and Health, to be appointed by the Senate Committee on Rules; five members of the House of
26	Delegates, each of whom shall be a member of either the House Committee on Health, Welfare and
27	Institutions or a member of the House Committee on Education, to be appointed by the Speaker of the
28	House of Delegates in accordance with the principles of proportional representation contained in the
29	Rules of the House of Delegates; two nonlegislative citizen members, one of whom shall be an educator
30	at a public school in the Commonwealth and one of whom shall be a public health expert, to be
31	appointed by the Senate Committee on Rules; and two nonlegislative citizen members, one of whom
32 33	shall be an educator at a public school in the Commonwealth and one of whom shall be a public health expert, to be appointed by the Speaker of the House of Delegates. The Superintendent of Public
33 34	Instruction and the State Health Commissioner, or their designees, shall serve ex officio with nonvoting
35	privileges. Nonlegislative citizen members of the Committee shall be citizens of the Commonwealth.
36	Unless otherwise approved in writing by the chairman of the Committee and the respective Clerk,
37	nonlegislative citizen members shall only be reimbursed for travel originating and ending within the
38	Commonwealth for the purpose of attending meetings.
39	Legislative members and ex officio members of the Committee shall serve terms coincident with their
40	terms of office.
41	Appointments to fill vacancies, other than by expiration of a term, shall be for the unexpired terms.
42	Vacancies shall be filled in the same manner as the original appointments. All members may be
43	reappointed.
44	Nonlegislative citizen members shall be appointed for a term of two years.
45	B. A majority of the members shall constitute a quorum. The meetings of the Committee shall be held
46	at the call of the chairman or whenever the majority of the members so request.
47	No recommendation of the Committee shall be adopted if a majority of the Senate members or a
48	majority of the House members appointed to the Committee (i) vote against the recommendation and (ii)
49 50	vote for the recommendation to fail notwithstanding the majority vote of the Committee.
50 51	§ 30-411. Compensation; expenses; annual report. A. Legislative members of the Committee shall receive such compensation as provided in § 30-19.12,
51 52	and nonlegislative citizen members shall receive such compensation for the performance of their duties
52 53	as provided in § 2.2-2813. All members shall be reimbursed for all reasonable and necessary expenses
53 54	incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Compensation to
55	members of the General Assembly for attendance at official meetings of the Committee shall be paid by
56	the offices of the Clerk of the House of Delegates or Clerk of the Senate, as applicable. All other

59 The Committee shall submit to the General Assembly and the Governor an annual report for 60 publication as a report document as provided in the procedures of the Division of Legislative Automated 61 Systems for the processing of legislative documents and reports. The chairman of the Committee shall 62 submit to the General Assembly and the Governor an annual executive summary of the interim activity 63 and work of the Committee no later than the first day of each regular session of the General Assembly. 64 The executive summary shall be submitted for publication as a report document as provided in the 65 procedures of the Division of Legislative Automated Systems for the processing of legislative documents and reports and shall be posted on the General Assembly's website. 66
