That § 10.1-1307 of the Code of Virginia is amended and reenacted as follows: 11 § 10.1-1307. Further powers and duties of Board. 12 13 A. The Board shall have the power to control and regulate its internal affairs; initiate and supervise 14 research programs to determine the causes, effects, and hazards of air pollution; initiate and supervise 15 statewide programs of air pollution control education; cooperate with and receive money from the federal government or any county or municipal government, and receive money from any other source, 16 whether public or private; develop a comprehensive program for the study, abatement, and control of all 17 sources of air pollution in the Commonwealth; and advise, consult, and cooperate with agencies of the 18 19 United States and all agencies of the Commonwealth, political subdivisions, private industries, and any 20 other affected groups in furtherance of the purposes of this chapter. 21 B. The Board may adopt by regulation emissions standards controlling the release into the atmosphere of air pollutants from motor vehicles, only as provided in § 10.1-1307.05 and Article 22 22 23 (§ 46.2-1176 et seq.) of Chapter 10 of Title 46.2. 24 C. After any regulation has been adopted by the Board pursuant to § 10.1-1308, it may in its 25 discretion grant local variances therefrom, if it finds after an investigation and hearing that local conditions warrant. If local variances are permitted, the Board shall issue an order to this effect. Such 26 27 order shall be subject to revocation or amendment at any time if the Board after a hearing determines 28 that the amendment or revocation is warranted. Variances and amendments to variances shall be adopted 29 only after a public hearing has been conducted pursuant to the public advertisement of the subject, date, 30 time, and place of the hearing at least 30 days prior to the scheduled hearing. The hearing shall be 31 conducted to give the public an opportunity to comment on the variance. D. After the Board has adopted the regulations provided for in § 10.1-1308, it shall have the power 32 33 to: (i) initiate and receive complaints as to air pollution; (ii) hold or cause to be held hearings and enter orders diminishing or abating the causes of air pollution and orders to enforce its regulations pursuant to 34 35 § 10.1-1309; and (iii) institute legal proceedings, including suits for injunctions for the enforcement of 36 its orders, regulations, and the abatement and control of air pollution and for the enforcement of 37 penalties. 38 E. The Board in making regulations and in approving variances, control programs, or permits, and 39 the courts in granting injunctive relief under the provisions of this chapter, shall consider facts and circumstances relevant to the reasonableness of the activity involved and the regulations proposed to 40 41 control it, including: 1. The character and degree of injury to, or interference with, safety, health, or the reasonable use of 42 43 property which is caused or threatened to be caused; 44 2. The social and economic value of the activity involved; 45 3. The suitability of the activity to the area in which it is located; and 4. The scientific and economic practicality of reducing or eliminating the discharge resulting from 46 47 such activity. 48 F. The Board may designate one of its members, the Director, or a staff assistant to conduct the 49 hearings provided for in this chapter. A record of the hearing shall be made and furnished to the Board 50 for its use in arriving at its decision. 51 G. The Board shall not: 52 1. Adopt any regulation limiting emissions from wood heaters; or 53 2. Enforce against a manufacturer, distributor, or consumer any federal regulation limiting emissions 54 from wood heaters adopted after May 1, 2014. 55 H. The Board shall submit an annual report to the Governor and General Assembly on or before October 1 of each year on matters relating to the Commonwealth's air pollution control policies and on 56 the status of the Commonwealth's air quality. 57
