**3. Committee:** Agriculture, Chesapeake and Natural Resources

**4. Title:** Flood resiliency and protection.

**5. Summary:** Implements recommendations from the first Virginia Coastal Resilience Master Plan. The bill provides guidelines for the development of a Virginia Flood Protection Master Plan for the Commonwealth and requires that the Coastal Resilience Master Plan be updated by December 31, 2022, and every five years thereafter. The bill establishes the Virginia Coastal Resilience Technical Advisory Committee to assist with the updates and requires the development of a community outreach and engagement plan to ensure meaningful involvement by affected and vulnerable community residents. The bill also requires that the Chief Resilience Officer report every two years, beginning July 1, 2023, on the status of flood resilience in the Commonwealth.

**7. Fiscal Impact Estimates:** Preliminary.

**8. Fiscal Implications:** This bill amends the Code of Virginia to incorporate recommendations from the first Virginia Coastal Resilience Master Plan. The Department of Conservation and Recreation (DCR), the agency that serves as the lead administrator for the implementation of the Virginia Coastal Resilience Plan and the Virginia Flood Protection Master Plan, anticipates that any costs associated with the provisions of this bill can be absorbed within current resources. Presently, DCR is authorized to utilize nongeneral fund appropriation from the Virginia Community Flood Preparedness Fund, established pursuant to § 10.1-603.25, Code of Virginia, for development of or updates to the Virginia Coastal Resilience Master Plan. The fourth enactment clause of this bill expands that authorization to include development and updates to the flood protection plan and the Community Outreach and Engagement Plan described in the third enactment of the bill.

The bill also codifies the Coastal Resilience Master Plan Technical Advisory Committee (TAC) which was established through Executive Order 71 of the Northam Administration. TAC members serve in an advisory role without compensation. As such, it is anticipated that any costs associated with this bill can be absorbed within current resources of the affected agencies.
