Be it enacted by the General Assembly of Virginia: 9 1. That §§ 10.1-1425.17, 62.1-256.2, and 62.1-69.35:2 of the Code of Virginia are amended and 10 11 reenacted as follows: § 10.1-1425.17. Evaluation report. 12 13 The Department shall submit post an annual report to the Governor and the appropriate committees 14 of the General Assembly. The report shall include regarding an evaluation of its pollution prevention 15 activities on its website. The report shall be submitted by December 1 of each year, beginning in 1994. 16 The report shall include, to the extent available, information regarding progress in expanding pollution 17 prevention activities in the Commonwealth. 18 § 62.1-256.2. (Expires July 1, 2025) Eastern Virginia Groundwater Management Advisory 19 Committee established; sunset. 20 A. The Department of Environmental Quality (the Department) shall establish the Eastern Virginia 21 Groundwater Management Advisory Committee (the Committee) as an advisory committee to assist the 22 State Water Commission and the Department in the management of groundwater in the Eastern Virginia 23 Groundwater Management Area. Members of the Committee shall be appointed by the Director of the 24 Department and shall be composed of nonlegislative citizen members consisting of representatives of 25 industrial and municipal water users; representatives of public and private water providers; developers and representatives from the economic development community; representatives of agricultural, 26 27 conservation, and environmental organizations; state and federal agency officials; and university faculty 28 and citizens with expertise in water resources-related issues. The Department shall convene the 29 Committee at least four times each fiscal year. Members of the Committee shall receive no 30 compensation for their service and shall not be entitled to reimbursement for expenses incurred in the 31 performance of their duties. 32 B. During each meeting of the Committee, the Department shall (i) update the Committee on 33 activities pertaining to groundwater management in the Eastern Virginia Groundwater Management Area 34 and (ii) solicit members to present topics and analysis for examination at future meetings. The 35 Committee may develop specific statutory, budgetary, and regulatory recommendations, as necessary, to 36 enhance the effectiveness of groundwater management in the Eastern Virginia Groundwater Management 37 Area. 38 C. The Department shall annually report the results of the Committee's examinations and related 39 recommendations, and any responses from the Department, to the State Water Commission, the 40 Governor, and the General Assembly post a copy of such report on its website no later than November 41 1 of each year. 42 D. The provisions of this section shall expire on July 1, 2025. § 62.1-69.35:2. Chairman's executive summary of activity and work of the advisory committee. 43 44 The chairman of the advisory committee shall submit to the Governor and the General Assembly 45 post on its website an annual executive summary of the interim activity and work of the advisory committee no later than the first day of each regular session of the General Assembly. The executive 46 47 summary shall be submitted as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents and reports and shall be posted on the General **48** 49 Assembly's website.
