10	Be it enacted by the General Assembly of Virginia:
11	1. That § 46.2-772 of the Code of Virginia is amended and reenacted as follows:
12	§ 46.2-772. (For contingent expiration, see Acts 2020, cc. 1230 and 1275) Highway use fee.
13	A. Except as provided in subsection C, there is hereby imposed an annual highway use fee on any
14	motor vehicle registered in the Commonwealth under § 46.2-694 or 46.2-697 that is an alternative fuel
15	vehicle, an electric motor vehicle, or a fuel-efficient vehicle. The fee shall be collected by the
16	Department at the time of vehicle registration. If the vehicle is registered for a period of other than one
17	year as provided in § 46.2-646, the highway use fee shall be multiplied by the number of years or
18 19	fraction thereof that the vehicle will be registered. B. <i>1</i> . For an electric motor vehicle, the highway use fee shall be 85 percent of the amount of taxes
20	paid under subsection A of § 58.1-2217 on fuel used by a vehicle with a combined fuel economy of
2 0 2 1	23.7 miles per gallon for the average number of miles traveled by a passenger vehicle in the
22	Commonwealth, as determined by the Commissioner. For all other fuel-efficient vehicles, the highway
23	use fee shall be 85 percent of the difference between the tax paid under subsection A of § 58.1-2217 on
24	the fuel used by a vehicle with a combined fuel economy of 23.7 miles per gallon for the average
25	number of miles traveled by a passenger vehicle in the Commonwealth in a year, as determined by the
26	Commissioner, and the tax paid under subsection A of § 58.1-2217 on the fuel used by the vehicle being
27	registered for the average number of miles traveled by a passenger vehicle in the Commonwealth in a
28	year, as determined by the Commissioner.
29	For purposes of this chapter, the Commissioner shall use combined fuel economy as determined by
30	the manufacturer of the vehicle. If the Commissioner is unable to obtain the manufacturer's fuel
31	economy for a vehicle, then the Commissioner shall use the final estimate of average fuel economy, as
32	determined by the U.S. Environmental Protection Agency, of (i) all trucks having the same model year
33	as the vehicle being registered, if the vehicle has a gross weight between 6,000 pounds and 10,000
34	pounds, or (ii) all cars having the same model year as the vehicle. If data is not available for the model
35	year of the vehicle being registered, then the Commissioner shall use available data for the model year
36	that is closest to the model year of the vehicle being registered.
37	The Commissioner shall update the fees calculated under this section by July 1 of each year.
38	2. The Department shall establish and administer a process whereby a vehicle owner may contest the
39 40	fee assessed pursuant to this section. The Department shall reimburse the vehicle owner for any contested fee or portion thereof incorrectly collected pursuant to this section.
40 41	C. This section shall not apply to:
42	1. An autocycle, moped, or motorcycle;
43	2. A vehicle with a gross weight over 10,000 pounds;
4 4	3. A vehicle that is owned by a governmental entity as defined in § 58.1-2201; or
45	4. A vehicle that is registered under the International Registration Plan.
46	A vehicle shall not be subject to the fee set forth in this section in any year in which such vehicle is
47	registered to participate in the mileage-based user fee program established pursuant to § 46.2-773.
48	D. In any case where an applicant has requested and is eligible for a refund pursuant to § 46.2-688,
49	the Commissioner shall refund to the applicant the cost of the highway use fee, prorated in six-month
50	increments, if such application is made when six or more months remain in the registration period.
