A BILL to amend and reenact §§ 2.2-3705.5, 32.1-372, 54.1-2523, and 54.1-2525 of the Code of
 Virginia, relating to smartCHaRt network Program.

Patrons—Head, Hope, Hayes and Kory

Referred to Committee on Health, Welfare and Institutions

Be it enacted by the General Assembly of Virginia:

10 1. That §§ 2.2-3705.5, 32.1-372, 54.1-2523, and 54.1-2525 of the Code of Virginia are amended and 11 reenacted as follows:

§ 2.2-3705.5. Exclusions to application of chapter; health and social services records.

The following information contained in a public record is excluded from the mandatory disclosure provisions of this chapter but may be disclosed by the custodian in his discretion, except where such disclosure is prohibited by law. Redaction of information excluded under this section from a public record shall be conducted in accordance with § 2.2-3704.01.

17 1. Health records, except that such records may be personally reviewed by the individual who is the subject of such records, as provided in subsection F of § 32.1-127.1:03.

19 Where the person who is the subject of health records is confined in a state or local correctional 20 facility, the administrator or chief medical officer of such facility may assert such confined person's right 21 of access to the health records if the administrator or chief medical officer has reasonable cause to 22 believe that such confined person has an infectious disease or other medical condition from which other 23 persons so confined need to be protected. Health records shall only be reviewed and shall not be copied 24 by such administrator or chief medical officer. The information in the health records of a person so 25 confined shall continue to be confidential and shall not be disclosed by the administrator or chief medical officer of the facility to any person except the subject or except as provided by law. 26

Where the person who is the subject of health records is under the age of 18, his right of access may be asserted only by his guardian or his parent, including a noncustodial parent, unless such parent's parental rights have been terminated, a court of competent jurisdiction has restricted or denied such access, or a parent has been denied access to the health record in accordance with § 20-124.6. In instances where the person who is the subject thereof is an emancipated minor, a student in a public institution of higher education, or is a minor who has consented to his own treatment as authorized by § 16.1-338 or 54.1-2969, the right of access may be asserted by the subject person.

For the purposes of this chapter, statistical summaries of incidents and statistical data concerning
 abuse of individuals receiving services compiled by the Commissioner of Behavioral Health and
 Developmental Services shall be disclosed. No such summaries or data shall include any information
 that identifies specific individuals receiving services.

38 2. Applications for admission to examinations or for licensure and scoring records maintained by the 39 Department of Health Professions or any board in that department on individual licensees or applicants; 40 information required to be provided to the Department of Health Professions by certain licensees 41 pursuant to § 54.1-2506.1; information held by the Health Practitioners' Monitoring Program Committee within the Department of Health Professions that identifies any practitioner who may be, or who is 42 actually, impaired to the extent that disclosure is prohibited by § 54.1-2517; and information relating to 43 the prescribing and dispensing of covered substances to recipients and any abstracts from such 44 information that are in the possession of the Prescription Monitoring Program (Program) pursuant to 45 46 Chapter 25.2 (§ 54.1-2519 et seq.) of Title 54.1 and any material relating to the operation or security of 47 the Program.

3. Reports, documentary evidence, and other information as specified in §§ 51.5-122 and 51.5-184
and Chapter 1 (§ 63.2-100 et seq.) of Title 63.2 and information and statistical registries required to be kept confidential pursuant to Chapter 1 (§ 63.2-100 et seq.) of Title 63.2.

Investigative notes; proprietary information not published, copyrighted or patented; information 52 obtained from employee personnel records; personally identifiable information regarding residents, 53 clients or other recipients of services; other correspondence and information furnished in confidence to 54 the Department of Education in connection with an active investigation of an applicant or licensee 55 pursuant to Chapter 14.1 (§ 22.1-289.02 et seq.) of Title 22.1; other correspondence and information furnished in confidence to the Department of Social Services in connection with an active investigation 56 of an applicant or licensee pursuant to Chapters 17 (§ 63.2-1700 et seq.) and 18 (§ 63.2-1800 et seq.) of 57 Title 63.2; and information furnished to the Office of the Attorney General in connection with an 58

59 investigation or litigation pursuant to Article 19.1 (§ 8.01-216.1 et seq.) of Chapter 3 of Title 8.01 and

60 Chapter 9 (§ 32.1-310 et seq.) of Title 32.1. However, nothing in this subdivision shall prevent the 61 disclosure of information from the records of completed investigations in a form that does not reveal the 62 identity of complainants, persons supplying information, or other individuals involved in the

63 investigation.

5. Information collected for the designation and verification of trauma centers and other specialty care centers within the Statewide Emergency Medical Services System and Services pursuant to Article
2.1 (§ 32.1-111.1 et seq.) of Chapter 4 of Title 32.1.

67 6. Reports and court documents relating to involuntary admission required to be kept confidential pursuant to § 37.2-818.

69 7. Information acquired (i) during a review of any child death conducted by the State Child Fatality 70 Review Team established pursuant to § 32.1-283.1 or by a local or regional child fatality review team 71 to the extent that such information is made confidential by § 32.1-283.2; (ii) during a review of any death conducted by a family violence fatality review team to the extent that such information is made 72 73 confidential by § 32.1-283.3; (iii) during a review of any adult death conducted by the Adult Fatality 74 Review Team to the extent made confidential by § 32.1-283.5 or by a local or regional adult fatality 75 review team to the extent that such information is made confidential by § 32.1-283.6; (iv) by a local or regional overdose fatality review team to the extent that such information is made confidential by 76 77 § 32.1-283.7; (v) during a review of any death conducted by the Maternal Mortality Review Team to the 78 extent that such information is made confidential by § 32.1-283.8; or (vi) during a review of any death 79 conducted by the Developmental Disabilities Mortality Review Committee to the extent that such 80 information is made confidential by § 37.2-314.1.

81 8. Patient level data collected by the Board of Health and not yet processed, verified, and released, pursuant to § 32.1-276.9, to the Board by the nonprofit organization with which the Commissioner of Health has contracted pursuant to § 32.1-276.4.

9. Information relating to a grant application, or accompanying a grant application, submitted to the
Commonwealth Neurotrauma Initiative Advisory Board pursuant to Article 12 (§ 51.5-178 et seq.) of
Chapter 14 of Title 51.5 that would (i) reveal (a) medical or mental health records or other data
identifying individual patients or (b) proprietary business or research-related information produced or
collected by the applicant in the conduct of or as a result of study or research on medical, rehabilitative,
scientific, technical, or scholarly issues, when such information has not been publicly released,
published, copyrighted, or patented, and (ii) be harmful to the competitive position of the applicant.

91 10. Any information copied, recorded, or received by the Commissioner of Health in the course of an examination, investigation, or review of a managed care health insurance plan licensee pursuant to \$\$ 32.1-137.4 and 32.1-137.5, including books, records, files, accounts, papers, documents, and any or all computer or other recordings.

95 11. Records of the Virginia Birth-Related Neurological Injury Compensation Program required to be kept confidential pursuant to § 38.2-5002.2.

97 12. Information held by the State Health Commissioner relating to the health of any person subject to

CHAPTER 19.

EMERGENCY DEPARTMENT CARE COORDINATIONSMARTCHART NETWORK PROGRAM.

§ 32.1-372. smartCHaRt network Program established; purpose.

A. The Emergency Department Care Coordination smartCHaRt network Program (the Program) is hereby created to provide a single, statewide technology solution that connects all hospital emergency departments health care providers, insurance carriers, and other organizations with a treatment, payment, or operations relationship with a patient in the Commonwealth to facilitate real-time communication and collaboration among physicians, other health care providers, and elinical and care management personnel for patients receiving services in hospital emergency departments, for the purpose of improving and improve the quality of patient care services. 121 B. In developing and implementing the Program, the *The* Commissioner shall ensure that the 122 Program:

123 1. Receives real-time patient visit information from, and shares such information with, every hospital
 124 emergency department in the Commonwealth through integrations that enable receiving information from
 125 and delivering information into electronic health records systems utilized by such hospital emergency
 126 departments hospitals;

127 2. Requires that all participants in the Program *share patient information and* have fully executed
128 health care data exchange contracts that to ensure that the secure and reliable exchange of patient
129 information fully complies in compliance with the patient privacy and security requirements of
130 applicable state and federal laws and regulations, including the Health Insurance Portability and
131 Accountability Act (42 U.S.C. § 1320d et seq.);

132 3. Enables health care providers, health care entities, and insurance carriers to access information
133 necessary to evaluate and monitor the care and treatment of a patient in accordance with the patient
134 privacy and security requirements of applicable state and federal laws and regulations, including the
135 Health Insurance Portability and Accountability Act (42 U.S.C. § 1320d et seq.);

4. Allows hospital emergency departments health care providers in the Commonwealth to receive
 real-time alerts triggered by analytics to identify patient-specific risks, to create and share care
 coordination plans and other care recommendations, and to access other clinically beneficial information
 related to patients receiving health care services in hospital emergency departments in the
 Commonwealth;

4. 5. Provides a patient's designated primary care physician and supporting clinical and care management personnel with treatment and care coordination information about a patient receiving *health care* services in a hospital emergency department in the Commonwealth, including care plans, *lab results, images,* and hospital admissions, transfers, and discharges;

5. 6. Provides a patient's designated managed care organization and supporting clinical and care management personnel with care coordination plans, *lab results, images,* and discharge and other treatment and care coordination information about a member receiving *health care* services in a hospital emergency department in the Commonwealth; and

6. 7. Is integrated with the Prescription Monitoring Program established pursuant to Chapter 25.2 (§
54.1-2519 et seq.) of Title 54.1 and the Advance Health Care Directive Registry established pursuant to Article 9 (§ 54.1-2994 et seq.) of Chapter 29 of Title 54.1 to enable automated query and automatic delivery of relevant information from such sources into the existing work flow of health care providers in the emergency department.

154 C. The Commissioner shall enter into a contract with a third party to create, operate, maintain, or 155 administer the Program in accordance with this section, which shall include provisions for the protection 156 of patient privacy and data security pursuant to state and federal law and regulations, including the Health Insurance Portability and Accountability Act (42 U.S.C. § 1320d et seq.). The third-party 157 contractor shall establish an advisory council, which shall consist of representatives of the Department, 158 159 the Department of Medical Assistance Services, the Department of Health Professions, the Virginia 160 Hospital and Healthcare Association, the Virginia Association of Health Plans, the Medical Society of 161 Virginia, the Virginia College of Emergency Physicians, the Virginia Chapter of the American Academy of Pediatricians, and the Virginia Academy of Family Physicians, to advise the Commissioner and the 162 163 third-party contractor regarding the establishment and operation of the Program, changes to the Program, 164 and outcome measures for the Program.

165 D. Information submitted to the Program shall be confidential and shall be exempt from disclosure 166 under the Virginia Freedom of Information Act (§ 2.2-3700 et seq.).

167 § 54.1-2523. Confidentiality of data; disclosure of information; discretionary authority of 168 Director.

169 A. All data, records, and reports relating to the prescribing and dispensing of covered substances to 170 recipients and any abstracts from such data, records, and reports that are in the possession of the 171 Prescription Monitoring Program pursuant to this chapter and any material relating to the operation or 172 security of the program shall be confidential and shall be exempt from the Virginia Freedom of 173 Information Act (§ 2.2-3700 et seq.) pursuant to subdivision 2 of § 2.2-3705.5. Records in possession of 174 the Prescription Monitoring Program shall not be available for civil subpoena, nor shall such records be 175 disclosed, discoverable, or compelled to be produced in any civil proceeding, nor shall such records be 176 deemed admissible as evidence in any civil proceeding for any reason. Further, the Director shall only 177 have discretion to disclose any such information as provided in subsections B and C.

B. Upon receiving a request for information in accordance with the Department's regulations and in compliance with applicable federal law and regulations, the Director shall disclose the following:

180 1. Information relevant to a specific investigation of a specific recipient or of a specific dispenser or
 181 prescriber to an agent who has completed the Virginia State Police Drug Diversion School designated by

the superintendent of the Department of State Police or designated by the chief law-enforcement officer
of any county, city, or town or campus police department to conduct drug diversion investigations
pursuant to § 54.1-3405.

2. Information relevant to an investigation or inspection of or allegation of misconduct by a specific person licensed, certified, or registered by or an applicant for licensure, certification, or registration by a health regulatory board; information relevant to a disciplinary proceeding before a health regulatory board or in any subsequent trial or appeal of an action or board order to designated employees of the Department of Health Professions; or to designated persons operating the Health Practitioners' Monitoring Program pursuant to Chapter 25.1 (§ 54.1-2515 et seq.).

191 3. Information relevant to the proceedings of any investigatory grand jury or special grand jury that
192 has been properly impaneled in accordance with the provisions of Chapter 13 (§ 19.2-191 et seq.) of
193 Title 19.2.

4. Information relevant to a specific investigation of a specific recipient, dispenser, or prescriber toan agent of a federal law-enforcement agency with authority to conduct drug diversion investigations.

5. Information relevant to a specific investigation, supervision, or monitoring of a specific recipient for purposes of the administration of criminal justice pursuant to Chapter 1 (§ 9.1-100 et seq.) of Title 9.1 to a probation or parole officer as described in Article 2 (§ 53.1-141 et seq.) of Chapter 4 of Title 53.1 or a local community-based probation officer as described in § 9.1-176.1 who has completed the Virginia State Police Drug Diversion School designated by the Director of the Department of Corrections or his designee.

6. Information relevant to a specific investigation of a specific individual into a possible delivery of a controlled substance in violation of § 18.2-474.1 to an investigator for the Department of Corrections who has completed the Virginia State Police Drug Diversion School and who has been designated by the Director of the Department of Corrections or his designee.

206 7. Information about a specific recipient to the Emergency Department Care Coordination
 207 smartCHaRt network Program in accordance with subdivision B 6 7 of § 32.1-372.

208 C. In accordance with the Department's regulations and applicable federal law and regulations, the209 Director may, in his discretion, disclose:

1. Information in the possession of the Prescription Monitoring Program concerning a recipient who
is over the age of 18 to that recipient. The information shall be mailed to the street or mailing address
indicated on the recipient request form.

213 2. Information on a specific recipient to a prescriber, as defined in this chapter, for the purpose of
214 establishing the treatment history of the specific recipient when such recipient is either under care and
215 treatment by the prescriber or the prescriber is consulting on or initiating treatment of such recipient. In
216 a manner specified by the Director in regulation, notice shall be given to patients that information may
217 be requested by the prescriber from the Prescription Monitoring Program.

3. Information on a specific recipient to a dispenser for the purpose of establishing a prescription
history to assist the dispenser in (i) determining the validity of a prescription in accordance with
§ 54.1-3303 or (ii) providing clinical consultation on the care and treatment of the recipient. In a manner
specified by the Director in regulation, notice shall be given to patients that information may be
requested by the dispenser from the Prescription Monitoring Program.

4. Information relevant to an investigation or regulatory proceeding of a specific dispenser or prescriber to other regulatory authorities concerned with granting, limiting or denying licenses, certificates or registrations to practice a health profession when such regulatory authority licenses such dispenser or prescriber or such dispenser or prescriber is seeking licensure by such other regulatory authority.

5. Information relevant to an investigation relating to a specific dispenser or prescriber who is a participating provider in the Virginia Medicaid program or information relevant to an investigation relating to a specific recipient who is currently eligible for and receiving or who has been eligible for and has received medical assistance services to the Medicaid Fraud Control Unit of the Office of the Attorney General or to designated employees of the Department of Medical Assistance Services, as appropriate.

6. Information relevant to determination of the cause of death of a specific recipient to the designatedemployees of the Office of the Chief Medical Examiner.

7. Information for the purpose of bona fide research or education to qualified personnel; however,
data elements that would reasonably identify a specific recipient, prescriber, or dispenser shall be deleted
or redacted from such information prior to disclosure. Further, release of the information shall only be
made pursuant to a written agreement between such qualified personnel and the Director in order to
ensure compliance with this subdivision.

8. Information relating to prescriptions for covered substances issued by a specific prescriber, whichhave been dispensed and reported to the Prescription Monitoring Program, to that prescriber.

243 9. Information about a specific recipient who is a member of a Virginia Medicaid managed care

244 program to a physician or pharmacist licensed in the Commonwealth and employed by the Virginia 245 Medicaid managed care program or to his clinical designee who holds a multistate licensure privilege to 246 practice nursing or a license issued by a health regulatory board within the Department of Health 247 Professions and is employed by the Virginia Medicaid managed care program. Such information shall 248 only be used to determine eligibility for and to manage the care of the specific recipient in a Patient 249 Utilization Management Safety or similar program. Notice shall be given to recipients that information 250 may be requested by a licensed physician or pharmacist employed by the Virginia Medicaid managed 251 care program from the Prescription Monitoring Program.

252 10. [Expired.]

11. Information about a specific recipient who is currently eligible for and receiving medical 253 254 assistance from the Department of Medical Assistance Services to a physician or pharmacist licensed in 255 the Commonwealth or to his clinical designee who holds a multistate licensure privilege to practice 256 nursing or a license issued by a health regulatory board within the Department of Health Professions and 257 is employed by the Department of Medical Assistance Services.

258 Such information shall be used only to determine eligibility for and to manage the care of the 259 specific recipient in a Patient Utilization Management Safety or similar program. Notice shall be given 260 to recipients that information may be requested by a licensed physician or pharmacist employed by the Department of Medical Assistance Services from the Prescription Monitoring Program. 261

262 D. The Director may enter into agreements for mutual exchange of information among prescription 263 monitoring programs in other jurisdictions, which shall only use the information for purposes allowed by 264 this chapter.

265 E. This section shall not be construed to supersede the provisions of § 54.1-3406 concerning the 266 divulging of confidential records relating to investigative information.

267 F. Confidential information that has been received, maintained or developed by any board or 268 disclosed by the board pursuant to subsection A shall not, under any circumstances, be available for 269 discovery or court subpoena or introduced into evidence in any medical malpractice suit or other action 270 for damages arising out of the provision of or failure to provide services. However, this subsection shall 271 not be construed to inhibit any investigation or prosecution conducted pursuant to Article 1 (§ 18.2-247 272 et seq.) of Chapter 7 of Title 18.2. 273

§ 54.1-2525. Unlawful disclosure of information; disciplinary action authorized; penalties.

274 A. It shall be unlawful for any person having access to the confidential information in the possession 275 of the program or any data or reports produced by the program to disclose such confidential information 276 except as provided in this chapter. Any person having access to the confidential information in the 277 possession of the program or any data or reports produced by the program who discloses such 278 confidential information in violation of this chapter shall be guilty of a Class 1 misdemeanor upon 279 conviction.

280 B. It shall be unlawful for any person who lawfully receives confidential information from the 281 Prescription Monitoring Program to redisclose or use such confidential information in any way other 282 than the authorized purpose for which the request was made. Any person who lawfully receives 283 information from the Prescription Monitoring Program and discloses such confidential information in 284 violation of this chapter shall be guilty of a Class 1 misdemeanor upon conviction.

285 C. Nothing in this section shall prohibit (i) a person who prescribes or dispenses a covered substance 286 to a recipient required to be reported to the program from redisclosing information obtained from the Prescription Monitoring Program to another prescriber or dispenser who has responsibility for treating 287 288 the recipient or (ii) a person who prescribes a covered substance from placing information obtained from 289 the Prescription Monitoring Program in the recipient's medical record.

290 D. Information obtained from the Prescription Monitoring Program pursuant to subdivision B 6 7 of 291 § 32.1-372 shall become part of the patient's medical record.

292 E. Unauthorized use or disclosure of confidential information received from the Prescription 293 Monitoring Program shall also be grounds for disciplinary action by the relevant health regulatory board. 294 2. That the State Health Commissioner (the Commissioner) shall convene a work group to study 295 and establish a plan to develop and implement a system to share information regarding a patient's 296 prescription history. The work group shall include relevant stakeholders, including representatives 297 of the Virginia Hospital and Healthcare Association, the Medical Society of Virginia, the Virginia 298 Association of Health Plans, the Virginia Pharmacists Association, Virginia Health Information, 299 and the Department of Health Professions. The Commissioner shall report his findings and 300 recommendations to the Chairmen of the Joint Commission on Health Care, Senate Committee on 301 Education and Health, and House Committee on Health, Welfare and Institutions by October 1, 302 2023.
