## **HOUSE JOINT RESOLUTION NO. 571**

3 Commending Historic Huntley. 4

## Patrons—Krizek and Sickles: Senator: Surovell

WHEREAS, Historic Huntley, a 19th century Federal-style villa in Fairfax County, celebrates its 50th anniversary on the Virginia Landmarks Register and the National Register of Historic Places; and

8 WHEREAS, Historic Huntley was built in the 1820s to serve as a summer retreat for Thomson Francis Mason, mayor of the City of Alexandria from 1827 to 1830 and grandson of founding father 9 10 George Mason; and

WHEREAS, originally, Historic Huntley was a retreat in the form of a country villa, with associated 11 12 farmlands tended year-round by African Americans enslaved by the Mason family; and

13 WHEREAS, in later years, Historic Huntley served as a grain farm, an encampment for troops of the 14 3rd Michigan Infantry during the Civil War, and a dairy farm; and

WHEREAS, following an advocacy campaign by local preservationists and historians and the home's 15 owner at the time, Marguerite Amlong, Historic Huntley was added to the Virginia Landmarks Register 16 on March 21, 1972, and the National Register of Historic Places on November 3, 1972; and 17

WHEREAS, Historic Huntley was ultimately acquired by the Fairfax County Park Authority in 1989 18 19 and was used in a limited capacity for semiannual events and school and scout trips for many years; and 20 WHEREAS, following a renovation of the manor house in 2012, Historic Huntley is now regularly open for scheduled programs and tours, including Saturday tours from late April through October, 21 22 offering visitors the opportunity to appreciate the estate's Federal-period architecture and to imagine life 23 as it was in the early years of the nation's history; and

WHEREAS, the renovation of Historic Huntley was made possible in part by a \$100,000 grant from 24 25 the National Park Service's Save America's Treasures program, which helped to fund extensive structural restoration work at the site, as well as two bond programs managed by the Fairfax County Park 26 27 Authority, which raised several million dollars for the preservation and redevelopment of the site; and

28 WHEREAS, in 2017, the tenant house at Historic Huntley was renovated and adapted to serve as a 29 visitor center, enhancing the site's ability to support meaningful historic and cultural programming for 30 the benefit of visitors; and

31 WHEREAS, during the renovation of the tenant house at Historic Huntley, signs were discovered 32 suggesting that the building may have originally served as quarters for enslaved people; this supposition 33 was confirmed following an investigation by then University of Maryland School of Architecture, Planning, and Preservation associate research professor Dr. Dennis Pogue and the site was listed in the 34 35 Virginia Slave Housing project database in August 2022; and

36 WHEREAS, for more than 30 years, the nonprofit organization Friends of Historic Huntley has 37 worked tirelessly to preserve and protect Historic Huntley for the enjoyment of future generations; now, 38 therefore. be it

39 RESOLVED by the House of Delegates, the Senate concurring. That the General Assembly hereby 40 commend Historic Huntley on the occasion of its 50th anniversary on the Virginia Landmarks Register 41 and the National Register of Historic Places; and, be it

RESOLVED FURTHER, That the Clerk of the House of Delegates prepare a copy of this resolution 42 for presentation to Friends of Historic Huntley as an expression of the General Assembly's admiration 43 for the site's place in the history of the Commonwealth. 44
