11	Be it enacted by the General Assembly of Virginia:
12	1. That the Code of Virginia is amended by adding in Chapter 5 of Title 32.1 an article numbered
13 14	9, consisting of a section numbered 32.1-162.15.12, as follows:
14	Article 9. In-person Visitation.
16	§ 32.1-162.15:12. In-person visitation.
17	A. As used in this article, "facility" means any (i) training center as defined in § 37.2-100; (ii)
18	hospital, nursing home, or certified nursing facility licensed under § 32.1-126; (iii) hospice or hospice
19	facility licensed under § 32.1-162.3; (iv) assisted living facility licensed under § 63.2-1800; or (v)
20	intermediate care facility for individuals with intellectual disability established pursuant to 42 C.F.R.
21	§ 440.150.
22 23	B. Each facility shall establish in-person visitation policies and procedures that shall, at a minimum, include (i) infection control and education policies for visitors; (ii) screening, personal protective
23 24	equipment, and other infection control protocols for visitors; (ii) permissible length of visits and
25	number of visitors; and (iv) designation of a person responsible for ensuring that staff adhere to such
26	policies and procedures. Safety-related policies shall not be more stringent than those established for
27	the facility's staff and shall not require visitors to submit proof of any vaccination or immunization. The
28	policies and procedures shall allow consensual physical contact between the visitor and the resident,
29	client, or patient of the facility.
30 31	C. A resident, client, or patient of a facility may designate a visitor who is a family member, friend, guardian, or other individual as an essential caregiver. The facility shall allow in-person visitation by
32	the essential caregiver for at least two hours daily in addition to any other visitation authorized by the
33	facility. An essential caregiver shall not be required to provide necessary care to a resident, client, or
34	patient of a facility, and facilities may not require an essential caregiver to provide such care.
35	D. The in-person visitation policies and procedures required by this section shall allow in-person
36	visitation in any of the following circumstances, unless the resident, client, or patient objects:
37 38	1. End-of-life situations; 2. The resident, client, or patient was living with a family member before being admitted to the
	facility's care and is struggling with the change in environment and lack of in-person family support;
40	<i>3. The resident, client, or patient is making one or more major medical decisions;</i>
41	4. The resident, client, or patient is experiencing emotional distress or grieving the recent death of a
42	friend or family member;
43	5. The resident, client, or patient needs cueing or encouragement to eat or drink that was previously
44 45	provided by a family member or caregiver;6. The resident, client, or patient used to talk and interact with others but now is seldom speaking;
45 46	7. In the case of a hospital, childbirth, including labor and delivery; or
47	8. The resident, client, or patient is a child.
48	E. The policies and procedures may require a visitor to agree in writing to follow the facility's
49	policies and procedures. A facility may suspend in-person visitation of any visitor who violates the
50	facility's policies and procedures after signing such agreement.
51 52	F. The facility shall provide the visitation policies and procedures required pursuant to this section
52 53	to the Department when applying for initial licensure, licensure renewal, or change of ownership. The facility shall make the visitation policies and procedures available to the Department for review at any
55 54	time, upon request.
55	<i>G.</i> Within 24 hours of establishing the policies and procedures required under this section, each
56	facility shall make such policies and procedures easily accessible from its website homepage. The
57	Department shall dedicate a stand-alone page on its website to explain the in-person visitation
58	requirements of this article and provide a link to the Department's webpage to report complaints.
