15	Be it enacted by the General Assembly of Virginia:
16	1. That §§ 4.1-604, 4.1-605, 4.1-627, 18.2-251.1:1, 18.2-251.1:2, 22.1-277, 32.1-127, 32.1-162.6:1,
17	40.1-27.4, 46.2-341.20:7, 54.1-2522.1, as it is currently effective and as it shall become effective,
18	54.1-2903, 54.1-3408.3, 59.1-200, and 63.2-1803.01 of the Code of Virginia are amended and
19 20	reenacted and that the Code of Virginia is amended by adding in Title 4.1 a chapter numbered 16,
20	consisting of sections numbered 4.1-1600 through 4.1-1605, as follows:
21 22	§ 4.1-604. Powers and duties of the Board. The Board shall have the following powers and duties:
23	1. Promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) and
24 24	§ 4.1-606;
25	2. Control the possession, sale, transportation, and delivery of marijuana and marijuana products;
26	3. Grant, suspend, and restrict, revoke licenses for the cultivation, manufacture, distribution, sale, and
27	testing of marijuana and marijuana products as provided by law, or refuse to grant or renew any license
28	or permit issued or authorized pursuant to this subtitle;
29	4. Determine the nature, form, and capacity of all containers used for holding marijuana products to
30	be kept or sold and prescribe the form and content of all labels and seals to be placed thereon;
31 32	5. Maintain actions to enjoin common nuisances as defined in § 4.1-1113;6. Establish standards and implement an online course for employees of retail marijuana stores that
32 33	trains employees on how to educate consumers on the potential risks of marijuana use;
34	7. Establish a plan to develop and disseminate to retail marijuana store licensees a pamphlet or
35	similar document regarding the potential risks of marijuana use to be prominently displayed and made
36	available to consumers;
37	8. Establish a position for a Cannabis Social Equity Liaison who shall lead the Cannabis Business
38	Equity and Diversity Support Team and liaise with the Director of Diversity, Equity, and Inclusion on
39	matters related to diversity, equity, and inclusion standards in the marijuana industry;
40	9. Establish a Cannabis Business Equity and Diversity Support Team, which shall (i) develop
41	requirements for the creation and submission of diversity, equity, and inclusion plans by persons who
42 43	wish to possess a license in more than one license category pursuant to subsection C of § 4.1-805, which may include a requirement that the licensee participate in social equity apprenticeship plan, and
44	an approval process and requirements for implementation of such plans; (ii) be responsible for
45	conducting an analysis of potential barriers to entry for small, women-owned, and minority-owned
46	businesses and veteran-owned businesses interested in participating in the marijuana industry and
47	recommending strategies to effectively mitigate such potential barriers; (iii) provide assistance with
48	business planning for potential marijuana establishment licensees; (iv) spread awareness of business
49	opportunities related to the marijuana marketplace in areas disproportionately impacted by marijuana
50	prohibition and enforcement; (v) provide technical assistance in navigating the administrative process to
51	potential marijuana establishment licensees; and (vi) conduct other outreach initiatives in areas
52 53	disproportionately impacted by marijuana prohibition and enforcement as necessary;
53 54	10. Establish a position for an individual with professional experience in a health related field who shall staff the Cannabis Public Health Advisory Council, established pursuant to § 4.1-603, liaise with
54 55	the Office of the Secretary of Health and Human Resources and relevant health and human services
56	agencies and organizations, and perform other duties as needed.
57	11. Establish and implement a plan, in coordination with the Cannabis Social Equity Liaison and the
58	Director of Diversity, Equity, and Inclusion to promote and encourage participation in the marijuana
59	industry by people from communities that have been disproportionately impacted by marijuana

60 prohibition and enforcement and to positively impact those communities;

61 12. Sue and be sued, implead and be impleaded, and complain and defend in all courts;

62 13. Adopt, use, and alter at will a common seal;

63 14. Fix, alter, charge, and collect rates, rentals, fees, and other charges for the use of property of, the
64 sale of products of, or services rendered by the Authority at rates to be determined by the Authority for
65 the purpose of providing for the payment of the expenses of the Authority;

66 15. Make and enter into all contracts and agreements necessary or incidental to the performance of
67 its duties, the furtherance of its purposes, and the execution of its powers under this subtitle, including
68 agreements with any person or federal agency;

69 16. Employ, at its discretion, consultants, researchers, architects, engineers, accountants, financial
70 experts, investment bankers, superintendents, managers, and such other employees and special agents as
71 may be necessary and fix their compensation to be payable from funds made available to the Authority.
72 Legal services for the Authority shall be provided by the Attorney General in accordance with Chapter 5

73 (§ 2.2-500 et seq.) of Title 2.2;

74 17. Receive and accept from any federal or private agency, foundation, corporation, association, or 75 person grants or other aid to be expended in accomplishing the objectives of the Authority, and receive and accept from the Commonwealth or any state and any municipality, county, or other political 76 subdivision thereof or from any other source aid or contributions of either money, property, or other 77 78 things of value, to be held, used, and applied only for the purposes for which such grants and 79 contributions may be made. All federal moneys accepted under this section shall be accepted and 80 expended by the Authority upon such terms and conditions as are prescribed by the United States and as 81 are consistent with state law, and all state moneys accepted under this section shall be expended by the Authority upon such terms and conditions as are prescribed by the Commonwealth; 82

83 18. Adopt, alter, and repeal bylaws, rules, and regulations governing the manner in which its business shall be transacted and the manner in which the powers of the Authority shall be exercised and 84 its duties performed. The Board may delegate or assign any duty or task to be performed by the 85 86 Authority to any officer or employee of the Authority. The Board shall remain responsible for the 87 performance of any such duties or tasks. Any delegation pursuant to this subdivision shall, where 88 appropriate, be accompanied by written guidelines for the exercise of the duties or tasks delegated. 89 Where appropriate, the guidelines shall require that the Board receive summaries of actions taken. Such 90 delegation or assignment shall not relieve the Board of the responsibility to ensure faithful performance 91 of the duties and tasks;

92 19. Conduct or engage in any lawful business, activity, effort, or project consistent with the93 Authority's purposes or necessary or convenient to exercise its powers;

20. Develop policies and procedures generally applicable to the procurement of goods, services, and construction, based upon competitive principles;

96 21. Develop policies and procedures consistent with Article 4 (§ 2.2-4347 et seq.) of Chapter 43 of
97 Title 2.2;

98 22. Acquire, purchase, hold, use, lease, or otherwise dispose of any property, real, personal or mixed, 99 tangible or intangible, or any interest therein necessary or desirable for carrying out the purposes of the 100 Authority; lease as lessee any property, real, personal or mixed, tangible or intangible, or any interest 101 therein, at such annual rental and on such terms and conditions as may be determined by the Board; 102 lease as lessor to any person any property, real, personal or mixed, tangible or intangible, or any interest 103 therein, at any time acquired by the Authority, whether wholly or partially completed, at such annual rental and on such terms and conditions as may be determined by the Board; sell, transfer, or convey 104 any property, real, personal or mixed, tangible or intangible, or any interest therein, at any time acquired 105 106 or held by the Authority on such terms and conditions as may be determined by the Board; and occupy 107 and improve any land or building required for the purposes of this subtitle;

108 23. Purchase, lease, or acquire the use of, by any manner, any plant or equipment that may be
109 considered necessary or useful in carrying into effect the purposes of this subtitle, including rectifying,
110 blending, and processing plants;

24. Appoint every agent and employee required for its operations, require any or all of them to give
bonds payable to the Commonwealth in such penalty as shall be fixed by the Board, and engage the
services of experts and professionals;

114 25. Hold and conduct hearings, issue subpoenas requiring the attendance of witnesses and the 115 production of records, memoranda, papers, and other documents before the Board or any agent of the 116 Board, and administer oaths and take testimony thereunder. The Board may authorize any Board member or agent of the Board to hold and conduct hearings, issue subpoenas, administer oaths and take 117 118 testimony thereunder, and decide cases, subject to final decision by the Board, on application of any 119 party aggrieved. The Board may enter into consent agreements and may request and accept from any 120 applicant or, licensee, or permittee a consent agreement in lieu of proceedings on (i) objections to the issuance of a license or permit or (ii) disciplinary action. Any such consent agreement (a) shall include 121

findings of fact and provisions regarding whether the terms of the consent agreement are confidential
and (b) may include an admission or a finding of a violation. A consent agreement shall not be
considered a case decision of the Board and shall not be subject to judicial review under the provisions
of the Administrative Process Act (§ 2.2-4000 et seq.), but may be considered by the Board in future
disciplinary proceedings;

127 26. Make a reasonable charge for preparing and furnishing statistical information and compilations to
128 persons other than (i) officials, including court and police officials, of the Commonwealth and of its
129 subdivisions if the information requested is for official use and (ii) persons who have a personal or legal
130 interest in obtaining the information requested if such information is not to be used for commercial or
131 trade purposes;

132 27. Assess Take appropriate disciplinary action and assess and collect civil penalties and civil
 133 charges for violations of this subtitle and Board regulations;

134 28. Review and approve any proposed legislative or regulatory changes suggested by the Chief
 135 Executive Officer as the Board deems appropriate;

136 29. Report quarterly to the Secretary of Public Safety and Homeland Security on the law-enforcement137 activities undertaken to enforce the provisions of this subtitle;

138 30. Establish and collect fees for all permits set forth in this subtitle, including fees associated with139 applications for such permits;

140 31. Develop and make available on its website guidance documents regarding compliance and safe
 141 practices for persons who cultivate marijuana at home for personal use, which shall include information
 142 regarding cultivation practices that promote personal and public safety, including child protection, and
 143 discourage practices that create a nuisance;

32. Develop and make available on its website a resource that provides information regarding (i)
responsible marijuana consumption; (ii) health risks and other dangers associated with marijuana
consumption, including inability to operate a motor vehicle and other types of transportation and
equipment; and (iii) ancillary effects of marijuana consumption, including ineligibility for certain
employment opportunities. The Board shall require that the web address for such resource be included
on the label of all retail marijuana and retail marijuana product as provided in § 4.1-1402; and

33. Do all acts necessary or advisable to carry out the purposes of this subtitle.

§ 4.1-605. Additional powers; mediation; alternative dispute resolution; confidentiality.

A. As used in this section:

"Appropriate case" means any alleged license *or permit* violation or objection to the application for a
license *or permit* in which it is apparent that there are significant issues of disagreement among
interested persons and for which the Board finds that the use of a mediation or dispute resolution
proceeding is in the public interest.

157 "Dispute resolution proceeding" means the same as that term is defined in § 8.01-576.4.

158 "Mediation" means the same as that term is defined in § 8.01-576.4.

159 "Neutral" means the same as that term is defined in § 8.01-576.4.

B. The Board may use mediation or a dispute resolution proceeding in appropriate cases to resolve underlying issues or reach a consensus or compromise on contested issues. Mediation and other dispute resolution proceedings as authorized by this section shall be voluntary procedures that supplement, rather than limit, other dispute resolution techniques available to the Board. Mediation or a dispute resolution proceeding may be used for an objection to the issuance of a license *or permit* only with the consent of, and participation by, the applicant for licensure *a license or permit* and shall be terminated at the request of such applicant.

167 C. Any resolution of a contested issue accepted by the Board under this section shall be considered a
168 consent agreement as provided in § 4.1-604. The decision to use mediation or a dispute resolution
169 proceeding is in the Board's sole discretion and shall not be subject to judicial review.

D. The Board may adopt rules and regulations, in accordance with the Administrative Process Act (§ 2.2-4000 et seq.), for the implementation of this section. Such rules and regulations may include (i) standards and procedures for the conduct of mediation and dispute resolution proceedings, including an opportunity for interested persons identified by the Board to participate in the proceeding; (ii) the appointment and function of a neutral to encourage and assist parties to voluntarily compromise or settle contested issues; and (iii) procedures to protect the confidentiality of papers, work products, or other materials.

E. The provisions of § 8.01-576.10 concerning the confidentiality of a mediation or dispute resolution
proceeding shall govern all such proceedings held pursuant to this section except where the Board uses
or relies on information obtained in the course of such proceeding in granting a license, suspending, *restricting*, or revoking a license *or permit*, or *in* accepting payment of a civil penalty or investigative
costs. However, a consent agreement Consent agreements shall be signed by the all parties and shall not
be include provisions regarding whether the terms of the consent agreement are confidential.

183 § 4.1-627. Hearings; representation by counsel.

184 Any licensee, permittee, or applicant for any a license granted by the Board or permit authorized by 185 this subtitle shall have the right to be represented by counsel at any Board hearing for which he has 186 received notice. The licensee, *permittee*, or applicant shall not be required to be represented by counsel 187 during such hearing. Any officer or director of a corporation may examine, cross-examine, and question 188 witnesses, present evidence on behalf of the corporation, and draw conclusions and make arguments 189 before the Board or hearing officers without being in violation of the provisions of § 54.1-3904.

CHAPTER 16. MEDICAL CANNABIS PROGRAM.

§ 4.1-1600. Definitions. 192

193 As used in this chapter, unless the context requires a different meaning:

"Botanical cannabis" means cannabis that is composed wholly of usable cannabis from the same 194 195 parts of the same chemovar of cannabis plant.

"Cannabis dispensing facility" means a facility that (i) has obtained a permit from the Board 196 197 pursuant to § 4.1-1602; (ii) is owned, at least in part, by a pharmaceutical processor; and (iii) 198 dispenses cannabis products produced by a pharmaceutical processor to a patient, his registered agent, 199 or, if such patient is a minor or a vulnerable adult as defined in § 18.2-369, such patient's parent or 200 legal guardian.

201 "Cannabis oil" means any formulation of processed Cannabis plant extract, which may include 202 industrial hemp extracts, including isolates and distillates, acquired by a pharmaceutical processor pursuant to § 4.1-1602, or a dilution of the resin of the Cannabis plant that contains no more than 10 203 milligrams of delta-9-tetrahydrocannabinol per dose. "Cannabis oil" does not include industrial hemp, 204 as defined in § 3.2-4112, that is grown, dealt, or processed in compliance with state or federal law, 205 unless it has been grown and processed in the Commonwealth by a registered industrial hemp processor 206 207 and acquired and formulated by a pharmaceutical processor.

"Cannabis product" means a product that is (i) produced by a pharmaceutical processor, registered 208 209 with the Board, and compliant with testing requirements and (ii) composed of cannabis oil or botanical 210 cannabis.

211 "Designated caregiver facility" means any hospice or hospice facility licensed pursuant to 212 § 32.1-162.3, or home care organization as defined in § 32.1-162.7 that provides pharmaceutical 213 services or home health services, private provider licensed by the Department of Behavioral Health and 214 Developmental Services pursuant to Article 2 (§ 37.2-403 et seq.) of Chapter 4 of Title 37.2, assisted living facility licensed pursuant to § 63.2-1701, or adult day care center licensed pursuant to 215 § 63.2-1701. 216 217

"Dispense" means the same as that term is defined in § 54.1-3300.

218 "Pharmaceutical processor" means a facility that (i) has obtained a permit from the Board pursuant 219 to § 4.1-1602 and (ii) cultivates Cannabis plants intended only for the production of cannabis oil, 220 botanical cannabis, and usable cannabis, produces cannabis products, and dispenses cannabis products to a patient pursuant to a written certification, his registered agent, or, if such patient is a minor or a 221 222 vulnerable adult as defined in § 18.2-369, such patient's parent or legal guardian.

223 "Pharmacist" means the same as that term is defined in § 54.1-3300.

224 "Pharmacy intern" means the same as that term is defined in § 54.1-3300.

225 "Pharmacy technician" means the same as that term is defined in § 54.1-3300.

226 "Pharmacy technician trainee" means the same as that term is defined in § 54.1-3300.

227 "Practitioner" means a practitioner of medicine or osteopathy licensed by the Board of Medicine, a 228 physician assistant licensed by the Board of Medicine, or a nurse practitioner jointly licensed by the 229 Boards of Nursing and Medicine.

230 "Registered agent" means an individual designated by a patient who has been issued a written 231 certification, or, if such patient is a minor or a vulnerable adult as defined in § 18.2-369, designated by 232 such patient's parent or legal guardian, and registered with the Board pursuant to subsection F of 233 § 4.1-1601.

234 "Usable cannabis" means any cannabis plant material, including seeds, but not (i) resin that has 235 been extracted from any part of the cannabis plant, its seeds, or its resin; (ii) the mature stalks, fiber 236 produced from the stalks, or any other compound, manufacture, salt, derivative, mixture, or preparation 237 of the mature stalks; or (iii) oil or cake made from the seeds of the plant. 238

§ 4.1-1601. Certification for use of cannabis for treatment.

A. A practitioner in the course of his professional practice may issue a written certification for the 239 240 use of cannabis products for treatment or to alleviate the symptoms of any diagnosed condition or disease determined by the practitioner to benefit from such use. The practitioner shall use his professional judgment to determine the manner and frequency of patient care and evaluation and may 241 242 243 employ the use of telemedicine, provided that the use of telemedicine includes the delivery of patient care through real-time interactive audiovisual technology. If a practitioner determines it is consistent 244

245 with the standard of care to dispense botanical cannabis to a minor, the written certification shall 246 specifically authorize such dispensing. If not specifically included on the initial written certification, 247 authorization for botanical cannabis may be communicated verbally or in writing to the pharmacist at 248 the time of dispensing.

249 B. The written certification shall be on a form provided by the Authority. Such written certification 250 shall contain the name, address, and telephone number of the practitioner, the name and address of the 251 patient issued the written certification, the date on which the written certification was made, and the 252 signature or authentic electronic signature of the practitioner. Such written certification issued pursuant 253 to subsection A shall expire no later than one year after its issuance unless the practitioner provides in 254 such written certification an earlier expiration. A written certification shall not be issued to a patient by 255 more than one practitioner during any given time period.

C. No practitioner shall be prosecuted under § 18.2-248 or 18.2-248.1 for the issuance of a 256 257 certification for the use of cannabis products for the treatment or to alleviate the symptoms of a 258 patient's diagnosed condition or disease pursuant to a written certification issued pursuant to subsection 259 A. Nothing in this section shall preclude the Board of Medicine from sanctioning a practitioner for 260 failing to properly evaluate or treat a patient's medical condition or otherwise violating the applicable 261 standard of care for evaluating or treating medical conditions.

262 D. A practitioner who issues a written certification to a patient pursuant to this section shall register 263 with the Board and shall hold sufficient education and training to exercise appropriate professional 264 judgment in the certification of patients. The Board shall not limit the number of patients to whom a 265 practitioner may issue a written certification. The Board may report information to the applicable 266 licensing board on unusual patterns of certifications issued by a practitioner.

267 E. No patient shall be required to physically present the written certification after the initial 268 dispensing by any pharmaceutical processor or cannabis dispensing facility under each written certification, provided that the pharmaceutical processor or cannabis dispensing facility maintains an 269 270 electronic copy of the written certification. Pharmaceutical processors and cannabis dispensing facilities 271 shall electronically transmit on a monthly basis all new written certifications received by the 272 pharmaceutical processor or cannabis dispensing facility to the Authority.

273 F. A patient, or, if such patient is a minor or a vulnerable adult as defined in § 18.2-369, such 274 patient's parent or legal guardian, may designate an individual to act as his registered agent for the 275 purposes of receiving cannabis products pursuant to a valid written certification. Such designated 276 individual shall register with the Board. The Board may set a limit on the number of patients for whom 277 any individual is authorized to act as a registered agent.

278 G. Upon delivery of a cannabis product by a pharmaceutical processor or cannabis dispensing 279 facility to a designated caregiver facility, any employee or contractor of a designated caregiver facility who is licensed or registered by a health regulatory board and who is authorized to possess, distribute, 280 281 or administer medications may accept delivery of the cannabis product on behalf of a patient or resident 282 for subsequent delivery to the patient or resident and may assist in the administration of the cannabis 283 product to the patient or resident as necessary.

H. Information obtained under the registration process shall be confidential and shall not be subject 284 285 to the disclosure provisions of the Virginia Freedom of Information Act (§ 2.2-3700 et seq.). However, 286 reasonable access to registry information shall be provided to (i) the Chairmen of the House Committee 287 for Courts of Justice and the Senate Committee on the Judiciary, (ii) state and federal agencies or local 288 law enforcement for the purpose of investigating or prosecuting a specific individual for a specific 289 violation of law, (iii) licensed practitioners or pharmacists, or their agents, for the purpose of providing 290 patient care and drug therapy management and monitoring of drugs obtained by a patient, (iv) a 291 pharmaceutical processor or cannabis dispensing facility involved in the treatment of a patient, or (v) a 292 patient's registered agent, but only with respect to information related to such patient. 293

§ 4.1-1602. Permit to operate pharmaceutical processor or cannabis dispensing facility.

294 A. No person shall operate a pharmaceutical processor or a cannabis dispensing facility without first 295 obtaining a permit from the Board. The application for such permit shall be made on a form provided 296 by the Authority and signed by a pharmacist who will be in full and actual charge of the 297 pharmaceutical processor's dispensing area or cannabis dispensing facility. The Board shall establish an 298 application fee and other general requirements for such application.

299 B. Each permit shall expire annually on a date determined by the Board in regulation. The number 300 of permits that the Board may issue or renew in any year is limited to one pharmaceutical processor 301 and up to five cannabis dispensing facilities for each health service area established by the Board of 302 Health. Permits shall be displayed in a conspicuous place on the premises of the pharmaceutical 303 processor and cannabis dispensing facility.

304 C. The Board shall adopt regulations establishing health, safety, and security requirements for 305 pharmaceutical processors and cannabis dispensing facilities. Such regulations shall include

306 requirements for (i) physical standards; (ii) location restrictions; (iii) security systems and controls; (iv) 307 minimum equipment and resources; (v) recordkeeping; (vi) labeling, including the potency of each 308 botanical cannabis product and the amounts recommended by the practitioner or dispensing pharmacist, 309 and packaging; (vii) routine inspections no more frequently than once annually; (viii) processes for 310 safely and securely dispensing and delivering in person cannabis products to a patient, his registered 311 agent, or, if such patient is a minor or a vulnerable adult as defined in § 18.2-369, such patient's parent 312 or legal guardian; (ix) dosage limitations for cannabis oil that provide that each dispensed dose of cannabis oil not exceed 10 milligrams of delta-9-tetrahydrocannabinol; (x) a process for the wholesale 313 314 distribution of and the transfer of usable cannabis, botanical cannabis, cannabis oil, and cannabis products between pharmaceutical processors, between a pharmaceutical processor and a cannabis 315 316 dispensing facility, and between cannabis dispensing facilities; (xi) an allowance for the sale of devices for administration of dispensed cannabis products and hemp-based CBD products that meet the 317 318 applicable standards set forth in state and federal law, including the laboratory testing standards set 319 forth in subsection N; (xii) an allowance for the use and distribution of inert product samples containing 320 no cannabinoids for patient demonstration exclusively at the pharmaceutical processor or cannabis 321 dispensing facility, and not for further distribution or sale, without the need for a written certification; 322 (xiii) a process for acquiring industrial hemp extracts and formulating such extracts into cannabis 323 products; and (xiv) an allowance for the advertising and promotion of the pharmaceutical processor's 324 products and operations, which shall not limit the pharmaceutical processor from the provision of 325 educational material to practitioners who issue written certifications and patients. The Board shall also 326 adopt regulations for pharmaceutical processors that include requirements for (a) processes for safely 327 and securely cultivating cannabis plants intended for producing cannabis products, (b) the secure disposal of agricultural waste, and (c) a process for registering cannabis products. 328

329 D. The Board shall require pharmaceutical processors, after processing and before dispensing any 330 cannabis products, to make a sample available from each batch of cannabis product for testing by an 331 independent laboratory that is located in Commonwealth and meets Board requirements. A valid sample 332 size for testing shall be determined by each laboratory and may vary due to sample matrix, analytical 333 method, and laboratory-specific procedures. A minimum sample size of 0.5 percent of individual units 334 for dispensing or distribution from each homogenized batch of cannabis oil is required to achieve a 335 representative cannabis oil sample for analysis. A minimum sample size, to be determined by the 336 certified testing laboratory, from each batch of botanical cannabis is required to achieve a 337 representative botanical cannabis sample for analysis. Botanical cannabis products shall only be tested 338 for the following: total cannabidiol (CBD), total tetrahydrocannabinol (THC), terpenes, pesticide 339 chemical residue, heavy metals, mycotoxins, moisture, and microbiological contaminants. Testing 340 thresholds shall be consistent with generally accepted cannabis industry thresholds. The pharmaceutical processor may remediate botanical cannabis or cannabis oil that fails any quality testing standard 341 342 except pesticides. Following remediation, all remediated botanical cannabis or cannabis oil shall be 343 subject to laboratory testing and approved upon satisfaction of applicable testing standards, which shall 344 not be more stringent than initial testing prior to remediation. If a batch of botanical cannabis fails 345 retesting after remediation, it shall be considered usable cannabis and may be processed into cannabis 346 oil. Stability testing shall not be required for any cannabis product with an expiration date assigned by 347 the pharmaceutical processor of six months or less from the date of the cannabis product registration 348 approval. Stability testing required for assignment of an expiration date longer than six months shall be 349 limited to microbial testing, on a pass/fail basis, and potency testing, on a 10 percent deviation basis, of 350 active ingredients.

E. A laboratory testing samples for a pharmaceutical processor shall obtain a controlled substances
 registration certificate pursuant to § 54.1-3423 and shall comply with quality standards established by
 the Board of Pharmacy in regulation.

F. Every pharmaceutical processor's dispensing area or cannabis dispensing facility shall be under
the personal supervision of a licensed pharmacist on the premises of the pharmaceutical processor or
cannabis dispensing facility. The pharmaceutical processor shall ensure that security measures are
adequate to protect the cannabis from diversion at all times, and the pharmacist-in-charge shall have
concurrent responsibility for preventing diversion from the dispensing area.

Every pharmaceutical processor shall designate a person who shall have oversight of the cultivation
and production areas of the pharmaceutical processor and shall provide such information to the Board.
The Board shall direct all communications related to enforcement of requirements related to cultivation
and production of cannabis oil products by the pharmaceutical processor to such designated person.

363 G. The Board shall require the material owners of an applicant for a pharmaceutical processor or
 364 cannabis dispensing facility permit to submit to fingerprinting and provide personal descriptive
 365 information to be forwarded along with his fingerprints through the Central Criminal Records Exchange
 366 to the Federal Bureau of Investigation for the purpose of obtaining criminal history record information
 367 regarding the applicant's material owners. The cost of fingerprinting and the criminal history record

search shall be paid by the applicant. The Central Criminal Records Exchange shall forward the results
of the criminal history background check to the Board or its designee, which shall be a governmental
entity.

H. A pharmaceutical processor shall maintain evidence of criminal background checks for all employees and delivery agents of the pharmaceutical processor. Criminal background checks of employees and delivery agents may be conducted by any service sufficient to disclose any federal and state criminal convictions.

375 I. In addition to other employees authorized by the Board, a pharmaceutical processor may employ 376 individuals who may have less than two years of experience (i) to perform cultivation-related duties 377 under the supervision of an individual who has received a degree in a field related to the cultivation of 378 plants or a certification recognized by the Board or who has at least two years of experience cultivating 379 plants, (ii) to perform extraction-related duties under the supervision of an individual who has a degree 380 in chemistry or pharmacology or at least two years of experience extracting chemicals from plants, and 381 (iii) to perform duties at the pharmaceutical processor and cannabis dispensing facility upon 382 certification as a pharmacy technician.

J. A pharmaceutical processor to whom a permit has been issued by the Board may establish up to
five cannabis dispensing facilities for the dispensing of cannabis products that have been cultivated and
produced on the premises of a pharmaceutical processor permitted by the Board. Each cannabis
dispensing facility shall be located within the same health service area as the pharmaceutical processor.
K. No person who has been convicted of a felony under the laws of the Commonwealth or another
jurisdiction within the last five years shall be employed by or act as an agent of a pharmaceutical
processor or cannabis dispensing facility.

390 L. Every pharmaceutical processor or cannabis dispensing facility shall adopt policies for 391 pre-employment drug screening and regular, ongoing, random drug screening of employees.

M. A pharmacist at the pharmaceutical processor's dispensing area and the cannabis dispensing
facility shall determine the number of pharmacy interns, pharmacy technicians, and pharmacy technician
trainees who can be safely and competently supervised at one time; however, no pharmacist shall
supervise more than six persons performing the duties of a pharmacy technician at one time in the
pharmaceutical processor's dispensing area or cannabis dispensing facility.

397 N. A pharmaceutical processor may acquire industrial hemp extracts grown and processed in 398 Virginia, and in compliance with state or federal law, from a registered industrial hemp dealer or 399 processor. A pharmaceutical processor may process and formulate such extracts into an allowable 400 dosage of cannabis product. Industrial hemp extracts acquired and formulated by a pharmaceutical 401 processor are subject to the same third-party testing requirements that may apply to cannabis plant 402 extract. Testing shall be performed by a laboratory located in Virginia and in compliance with state law 403 governing the testing of cannabis products. The industrial hemp dealer or processor shall provide such **404** third-party testing results to the pharmaceutical processor before industrial hemp extracts may be 405 acquired.

406 O. With the exception of § 2.2-4031, neither the provisions of the Administrative Process Act 407 (§ 2.2-4000 et seq.) nor public participation guidelines adopted pursuant thereto shall apply to the 408 adoption of any regulation pursuant to this section. Prior to adopting any regulation pursuant to this 409 section, the Board shall publish a notice of opportunity to comment in the Virginia Register of 410 Regulations and post the action on the Virginia Regulatory Town Hall. Such notice of opportunity to 411 comment shall contain (i) a summary of the proposed regulation; (ii) the text of the proposed 412 regulation; and (iii) the name, address, and telephone number of the agency contact person responsible 413 for receiving public comments. Such notice shall be made at least 60 days in advance of the last date 414 prescribed in such notice for submittals of public comment. The legislative review provisions of 415 subsections A and B of § 2.2-4014 shall apply to the promulgation or final adoption process for 416 regulations pursuant to this section. The Board shall consider and keep on file all public comments 417 received for any regulation adopted pursuant to this section.

418 *P.* The Board shall register all cannabis products that meet testing, labeling, and packaging **419** standards.

420 § 4.1-1603. Dispensing cannabis products; report.

421 A. A pharmaceutical processor or cannabis dispensing facility shall dispense or deliver cannabis 422 products only in person to (i) a patient who is a Virginia resident or temporarily resides in Virginia and 423 has been issued a valid written certification; (ii) such patient's registered agent; or (iii) if such patient 424 is a minor or a vulnerable adult as defined in § 18.2-369, such patient's parent or legal guardian who is a Virginia resident or temporarily resides in Virginia. A companion may accompany a patient into a 425 426 pharmaceutical processor's dispensing area or cannabis dispensing facility. Prior to the initial 427 dispensing of cannabis products pursuant to each written certification, a pharmacist or pharmacy 428 technician employed by the pharmaceutical processor or cannabis dispensing facility shall make and

485

429 maintain, on site or remotely by electronic means, for two years a paper or electronic copy of the 430 written certification that provides an exact image of the document that is clearly legible; shall view, in 431 person or by audiovisual means, a current photo identification of the patient, registered agent, parent, 432 or legal guardian; and shall verify current board registration of the practitioner and the corresponding 433 registered agent if applicable. Thereafter, an initial dispensing may be delivered to the patient, 434 registered agent, parent, legal guardian, or designated caregiver facility. Prior to any subsequent 435 dispensing of cannabis products pursuant to each written certification, an employee or delivery agent shall view a current photo identification of the patient, registered agent, parent, or legal guardian and 436 437 the current board registration issued to the registered agent if applicable. No pharmaceutical processor 438 or cannabis dispensing facility shall dispense more than a 90-day supply, as determined by the dispensing pharmacist or certifying practitioner, for any patient during any 90-day period. A pharmaceutical processor or cannabis dispensing facility may dispense less than a 90-day supply of a 439 440 441 cannabis product for any patient during any 90-day period; however, a pharmaceutical processor or cannabis dispensing facility may dispense more than one cannabis product to a patient at one time. No 442 443 more than four ounces of botanical cannabis shall be dispensed for each 30-day period for which 444 botanical cannabis is dispensed. The Board shall establish in regulation an amount of cannabis oil that constitutes a 90-day supply to treat or alleviate the symptoms of a patient's diagnosed condition or 445 disease. In determining the appropriate amount of a cannabis product to be dispensed to a patient, a 446 447 pharmaceutical processor or cannabis dispensing facility shall consider all cannabis products dispensed 448 to the patient and adjust the amount dispensed accordingly.

449 B. A pharmaceutical processor or cannabis dispensing facility shall dispense only cannabis products 450 produced on the premises of a pharmaceutical processor permitted by the Board or cannabis products that have been formulated with extracts from industrial hemp acquired by a pharmaceutical processor 451 452 from a registered industrial hemp dealer or processor pursuant to § 4.1-1602. A pharmaceutical 453 processor may begin cultivation upon being issued a permit by the Board.

454 C. The Board shall report annually by December 1 to the Chairmen of the House Committee on 455 General Laws and the Senate Committee on Rehabilitation and Social Services on the operation of 456 pharmaceutical processors and cannabis dispensing facilities issued a permit by the Board.

457 D. The concentration of delta-9-tetrahydrocannabinol in any cannabis product on site may be up to 458 10 percent greater than or less than the level of delta-9-tetrahydrocannabinol measured for labeling. A 459 pharmaceutical processor and cannabis dispensing facility shall ensure that such concentration in any 460 cannabis product on site is within such range. A pharmaceutical processor producing cannabis products 461 shall establish a stability testing schedule of cannabis products. 462

§ 4.1-1604. Criminal liability; exceptions.

463 No agent or employee of a pharmaceutical processor or cannabis dispensing facility shall be prosecuted under Chapter 11 (§ 4.1-1100 et seq.) or § 18.2-248, 18.2-248.1, or 18.2-250 for possession 464 465 or manufacture of marijuana or for possession, manufacture, or distribution of cannabis products, subject to any civil penalty, denied any right or privilege, or subject to any disciplinary action by a 466 professional licensing board if such agent or employee (i) possessed or manufactured such marijuana 467 468 for the purposes of producing cannabis products in accordance with the provisions of this chapter and 469 Board regulations or (ii) possessed, manufactured, or distributed such cannabis products that are 470 consistent with generally accepted cannabis industry standards in accordance with the provisions of this 471 chapter and Board regulations. 472

§ 4.1-1605. Summary suspensions and restrictions.

473 A. The Board may summarily suspend or restrict a permit issued pursuant to § 4.1-1602 without a 474 hearing if the Board finds that such suspension or restriction is necessary to prevent substantial danger 475 to public health or safety. The Board shall make decisions to summarily suspend or restrict a permit 476 only during an in-person meeting in which a quorum is present; however, if, after a good faith effort, 477 the Board is unable to assemble a quorum and a majority of the Board members determine that 478 continued operation by the permittee constitutes a substantial danger to public health or safety, the 479 Board may summarily suspend the permit during a telephone, video, or other electronic conference. 480 Institution of proceedings for a hearing shall be provided simultaneously with a summary suspension. 481 The Board may summarily restrict a permit without proceeding simultaneously with notification of an informal conference pursuant to § 2.2-4019 or Board regulations. Such hearing or conference shall be 482 483 held within a reasonable amount of time after the summary suspension or restriction is issued. 484

B. Allegations of violations of this subtitle shall be submitted to the Board in writing.

§ 18.2-251.1:1. Possession or distribution of cannabis oil; public schools.

486 No school nurse employed by a local school board, person employed by a local health department **487** who is assigned to the public school pursuant to an agreement between the local health department and the school board, or other person employed by or contracted with a local school board to deliver health-related services shall be prosecuted under Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or 488 489 490 § 18.2-248, 18.2-248.1, 18.2-250, or 18.2-255 for the possession or distribution of cannabis oil for

491 storing, dispensing, or administering cannabis oil, in accordance with a policy adopted by the local 492 school board, to a student who has been issued a valid written certification for the use of cannabis oil in 493 accordance with subsection B of § 54.1-3408.3 4.1-1601.

494 § 18.2-251.1:2. Possession or distribution of cannabis oil; nursing homes and certified nursing 495 facilities; hospice and hospice facilities; assisted living facilities.

496 No person employed by a nursing home, hospice, hospice facility, or assisted living facility and 497 authorized to possess, distribute, or administer medications to patients or residents shall be prosecuted under Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or § 18.2-248, 18.2-248.1, or 18.2-250 for the 498 499 possession or distribution of cannabis oil for the purposes of storing, dispensing, or administering 500 cannabis oil to a patient or resident who has been issued a valid written certification for the use of cannabis oil in accordance with subsection B of § 54.1-3408.3 and has registered with the Board of 501 502 Pharmacy § 4.1-1601.

§ 22.1-277. Suspensions and expulsions of students generally.

504 A. Students may be suspended or expelled from attendance at school for sufficient cause; however, 505 in no cases may sufficient cause for suspensions include only instances of truancy.

506 B. Except as provided in subsection C or § 22.1-277.07 or 22.1-277.08, no student in preschool 507 through grade three shall be suspended for more than three school days or expelled from attendance at 508 school, unless (i) the offense involves physical harm or credible threat of physical harm to others or (ii) 509 the local school board or the division superintendent or his designee finds that aggravating circumstances 510 exist, as defined by the Department.

511 C. Any student for whom the division superintendent of the school division in which such student is 512 enrolled has received a report pursuant to § 16.1-305.1 of an adjudication of delinquency or a conviction 513 for an offense listed in subsection G of § 16.1-260 may be suspended or expelled from school 514 attendance pursuant to this article.

515 D. The authority provided in § 22.1-276.2 for teachers to remove students from their classes in 516 certain instances of disruptive behavior shall not be interpreted to affect the operation of § 22.1-277.04, 517 22.1-277.05, or 22.1-277.06.

518 E. Notwithstanding the provisions of § 22.1-277.08, no school board shall be required to suspend or 519 expel any student who holds a valid written certification for the use of cannabis oil issued by a 520 practitioner in accordance with subsection B of § 54.1-3408.3 4.1-1601 for the possession or use of such 521 oil in accordance with the student's individualized health plan and in compliance with a policy adopted 522 by the school board. 523

§ 32.1-127. Regulations.

503

524 A. The regulations promulgated by the Board to carry out the provisions of this article shall be in 525 substantial conformity to the standards of health, hygiene, sanitation, construction and safety as 526 established and recognized by medical and health care professionals and by specialists in matters of 527 public health and safety, including health and safety standards established under provisions of Title 528 XVIII and Title XIX of the Social Security Act, and to the provisions of Article 2 (§ 32.1-138 et seq.). 529 B. Such regulations:

530 1. Shall include minimum standards for (i) the construction and maintenance of hospitals, nursing 531 homes and certified nursing facilities to ensure the environmental protection and the life safety of its 532 patients, employees, and the public; (ii) the operation, staffing and equipping of hospitals, nursing homes 533 and certified nursing facilities; (iii) qualifications and training of staff of hospitals, nursing homes and 534 certified nursing facilities, except those professionals licensed or certified by the Department of Health 535 Professions; (iv) conditions under which a hospital or nursing home may provide medical and nursing 536 services to patients in their places of residence; and (v) policies related to infection prevention, disaster 537 preparedness, and facility security of hospitals, nursing homes, and certified nursing facilities;

538 2. Shall provide that at least one physician who is licensed to practice medicine in this 539 Commonwealth shall be on call at all times, though not necessarily physically present on the premises, 540 at each hospital which operates or holds itself out as operating an emergency service;

541 3. May classify hospitals and nursing homes by type of specialty or service and may provide for 542 licensing hospitals and nursing homes by bed capacity and by type of specialty or service;

543 4. Shall also require that each hospital establish a protocol for organ donation, in compliance with 544 federal law and the regulations of the Centers for Medicare and Medicaid Services (CMS), particularly 545 42 C.F.R. § 482.45. Each hospital shall have an agreement with an organ procurement organization 546 designated in CMS regulations for routine contact, whereby the provider's designated organ procurement 547 organization certified by CMS (i) is notified in a timely manner of all deaths or imminent deaths of 548 patients in the hospital and (ii) is authorized to determine the suitability of the decedent or patient for 549 organ donation and, in the absence of a similar arrangement with any eye bank or tissue bank in 550 Virginia certified by the Eye Bank Association of America or the American Association of Tissue Banks, the suitability for tissue and eye donation. The hospital shall also have an agreement with at least 551

one tissue bank and at least one eye bank to cooperate in the retrieval, processing, preservation, storage, 552 553 and distribution of tissues and eyes to ensure that all usable tissues and eyes are obtained from potential donors and to avoid interference with organ procurement. The protocol shall ensure that the hospital 554 555 collaborates with the designated organ procurement organization to inform the family of each potential 556 donor of the option to donate organs, tissues, or eves or to decline to donate. The individual making 557 contact with the family shall have completed a course in the methodology for approaching potential 558 donor families and requesting organ or tissue donation that (a) is offered or approved by the organ 559 procurement organization and designed in conjunction with the tissue and eye bank community and (b) 560 encourages discretion and sensitivity according to the specific circumstances, views, and beliefs of the 561 relevant family. In addition, the hospital shall work cooperatively with the designated organ procurement organization in educating the staff responsible for contacting the organ procurement organization's 562 personnel on donation issues, the proper review of death records to improve identification of potential 563 564 donors, and the proper procedures for maintaining potential donors while necessary testing and placement of potential donated organs, tissues, and eyes takes place. This process shall be followed, 565 without exception, unless the family of the relevant decedent or patient has expressed opposition to 566 567 organ donation, the chief administrative officer of the hospital or his designee knows of such opposition, 568 and no donor card or other relevant document, such as an advance directive, can be found;

569 5. Shall require that each hospital that provides obstetrical services establish a protocol for admission570 or transfer of any pregnant woman who presents herself while in labor;

571 6. Shall also require that each licensed hospital develop and implement a protocol requiring written 572 discharge plans for identified, substance-abusing, postpartum women and their infants. The protocol shall 573 require that the discharge plan be discussed with the patient and that appropriate referrals for the mother 574 and the infant be made and documented. Appropriate referrals may include, but need not be limited to, treatment services, comprehensive early intervention services for infants and toddlers with disabilities 575 576 and their families pursuant to Part H of the Individuals with Disabilities Education Act, 20 U.S.C. 577 § 1471 et seq., and family-oriented prevention services. The discharge planning process shall involve, to 578 the extent possible, the other parent of the infant and any members of the patient's extended family who 579 may participate in the follow-up care for the mother and the infant. Immediately upon identification, 580 pursuant to § 54.1-2403.1, of any substance-abusing, postpartum woman, the hospital shall notify, 581 subject to federal law restrictions, the community services board of the jurisdiction in which the woman 582 resides to appoint a discharge plan manager. The community services board shall implement and manage 583 the discharge plan;

584 7. Shall require that each nursing home and certified nursing facility fully disclose to the applicant585 for admission the home's or facility's admissions policies, including any preferences given;

8. Shall require that each licensed hospital establish a protocol relating to the rights and responsibilities of patients which shall include a process reasonably designed to inform patients of such rights and responsibilities. Such rights and responsibilities of patients, a copy of which shall be given to patients on admission, shall be consistent with applicable federal law and regulations of the Centers for Medicare and Medicaid Services;

591 9. Shall establish standards and maintain a process for designation of levels or categories of care in neonatal services according to an applicable national or state-developed evaluation system. Such standards may be differentiated for various levels or categories of care and may include, but need not be limited to, requirements for staffing credentials, staff/patient ratios, equipment, and medical protocols;

595 10. Shall require that each nursing home and certified nursing facility train all employees who are
596 mandated to report adult abuse, neglect, or exploitation pursuant to § 63.2-1606 on such reporting
597 procedures and the consequences for failing to make a required report;

598 11. Shall permit hospital personnel, as designated in medical staff bylaws, rules and regulations, or 599 hospital policies and procedures, to accept emergency telephone and other verbal orders for medication 600 or treatment for hospital patients from physicians, and other persons lawfully authorized by state statute 601 to give patient orders, subject to a requirement that such verbal order be signed, within a reasonable 602 period of time not to exceed 72 hours as specified in the hospital's medical staff bylaws, rules and 603 regulations or hospital policies and procedures, by the person giving the order, or, when such person is 604 not available within the period of time specified, co-signed by another physician or other person 605 authorized to give the order;

606 12. Shall require, unless the vaccination is medically contraindicated or the resident declines the offer
607 of the vaccination, that each certified nursing facility and nursing home provide or arrange for the
administration to its residents of (i) an annual vaccination against influenza and (ii) a pneumococcal
609 vaccination, in accordance with the most recent recommendations of the Advisory Committee on
610 Immunization Practices of the Centers for Disease Control and Prevention;

611 13. Shall require that each nursing home and certified nursing facility register with the Department of
612 State Police to receive notice of the registration, reregistration, or verification of registration information
613 of any person required to register with the Sex Offender and Crimes Against Minors Registry pursuant

to Chapter 9 (§ 9.1-900 et seq.) of Title 9.1 within the same or a contiguous zip code area in which the
home or facility is located, pursuant to § 9.1-914;

616 14. Shall require that each nursing home and certified nursing facility ascertain, prior to admission,
617 whether a potential patient is required to register with the Sex Offender and Crimes Against Minors
618 Registry pursuant to Chapter 9 (§ 9.1-900 et seq.) of Title 9.1, if the home or facility anticipates the
619 potential patient will have a length of stay greater than three days or in fact stays longer than three
620 days;

621 15. Shall require that each licensed hospital include in its visitation policy a provision allowing each
622 adult patient to receive visits from any individual from whom the patient desires to receive visits,
623 subject to other restrictions contained in the visitation policy including, but not limited to, those related
624 to the patient's medical condition and the number of visitors permitted in the patient's room
625 simultaneously;

626 16. Shall require that each nursing home and certified nursing facility shall, upon the request of the 627 facility's family council, send notices and information about the family council mutually developed by 628 the family council and the administration of the nursing home or certified nursing facility, and provided 629 to the facility for such purpose, to the listed responsible party or a contact person of the resident's 630 choice up to six times per year. Such notices may be included together with a monthly billing statement 631 or other regular communication. Notices and information shall also be posted in a designated location 632 within the nursing home or certified nursing facility. No family member of a resident or other resident 633 representative shall be restricted from participating in meetings in the facility with the families or 634 resident representatives of other residents in the facility;

635 17. Shall require that each nursing home and certified nursing facility maintain liability insurance
636 coverage in a minimum amount of \$1 million, and professional liability coverage in an amount at least
637 equal to the recovery limit set forth in § 8.01-581.15, to compensate patients or individuals for injuries
638 and losses resulting from the negligent or criminal acts of the facility. Failure to maintain such
639 minimum insurance shall result in revocation of the facility's license;

640 18. Shall require each hospital that provides obstetrical services to establish policies to follow when a
641 stillbirth, as defined in § 32.1-69.1, occurs that meet the guidelines pertaining to counseling patients and
642 their families and other aspects of managing stillbirths as may be specified by the Board in its
643 regulations;

644 19. Shall require each nursing home to provide a full refund of any unexpended patient funds on
645 deposit with the facility following the discharge or death of a patient, other than entrance-related fees
646 paid to a continuing care provider as defined in § 38.2-4900, within 30 days of a written request for
647 such funds by the discharged patient or, in the case of the death of a patient, the person administering
648 the person's estate in accordance with the Virginia Small Estates Act (§ 64.2-600 et seq.);

649 20. Shall require that each hospital that provides inpatient psychiatric services establish a protocol 650 that requires, for any refusal to admit (i) a medically stable patient referred to its psychiatric unit, direct 651 verbal communication between the on-call physician in the psychiatric unit and the referring physician, 652 if requested by such referring physician, and prohibits on-call physicians or other hospital staff from 653 refusing a request for such direct verbal communication by a referring physician and (ii) a patient for 654 whom there is a question regarding the medical stability or medical appropriateness of admission for 655 inpatient psychiatric services due to a situation involving results of a toxicology screening, the on-call 656 physician in the psychiatric unit to which the patient is sought to be transferred to participate in direct verbal communication, either in person or via telephone, with a clinical toxicologist or other person who 657 658 is a Certified Specialist in Poison Information employed by a poison control center that is accredited by 659 the American Association of Poison Control Centers to review the results of the toxicology screen and 660 determine whether a medical reason for refusing admission to the psychiatric unit related to the results of the toxicology screen exists, if requested by the referring physician; 661

21. Shall require that each hospital that is equipped to provide life-sustaining treatment shall develop 662 **663** a policy governing determination of the medical and ethical appropriateness of proposed medical care, 664 which shall include (i) a process for obtaining a second opinion regarding the medical and ethical 665 appropriateness of proposed medical care in cases in which a physician has determined proposed care to 666 be medically or ethically inappropriate; (ii) provisions for review of the determination that proposed 667 medical care is medically or ethically inappropriate by an interdisciplinary medical review committee 668 and a determination by the interdisciplinary medical review committee regarding the medical and ethical 669 appropriateness of the proposed health care; and (iii) requirements for a written explanation of the 670 decision reached by the interdisciplinary medical review committee, which shall be included in the 671 patient's medical record. Such policy shall ensure that the patient, his agent, or the person authorized to 672 make medical decisions pursuant to § 54.1-2986 (a) are informed of the patient's right to obtain his 673 medical record and to obtain an independent medical opinion and (b) afforded reasonable opportunity to participate in the medical review committee meeting. Nothing in such policy shall prevent the patient, 674

675 his agent, or the person authorized to make medical decisions pursuant to § 54.1-2986 from obtaining 676 legal counsel to represent the patient or from seeking other remedies available at law, including seeking 677 court review, provided that the patient, his agent, or the person authorized to make medical decisions 678 pursuant to § 54.1-2986, or legal counsel provides written notice to the chief executive officer of the 679 hospital within 14 days of the date on which the physician's determination that proposed medical 680 treatment is medically or ethically inappropriate is documented in the patient's medical record;

22. Shall require every hospital with an emergency department to establish protocols to ensure that
security personnel of the emergency department, if any, receive training appropriate to the populations
served by the emergency department, which may include training based on a trauma-informed approach
in identifying and safely addressing situations involving patients or other persons who pose a risk of
harm to themselves or others due to mental illness or substance abuse or who are experiencing a mental
health crisis;

687 23. Shall require that each hospital establish a protocol requiring that, before a health care provider 688 arranges for air medical transportation services for a patient who does not have an emergency medical 689 condition as defined in 42 U.S.C. § 1395dd(e)(1), the hospital shall provide the patient or his authorized 690 representative with written or electronic notice that the patient (i) may have a choice of transportation by 691 an air medical transportation provider or medically appropriate ground transportation by an emergency medical services provider and (ii) will be responsible for charges incurred for such transportation in the **692** 693 event that the provider is not a contracted network provider of the patient's health insurance carrier or 694 such charges are not otherwise covered in full or in part by the patient's health insurance plan;

695 24. Shall establish an exemption from the requirement to obtain a license to add temporary beds in 696 an existing hospital or nursing home, including beds located in a temporary structure or satellite location operated by the hospital or nursing home, provided that the ability remains to safely staff services across 697 the existing hospital or nursing home, (i) for a period of no more than the duration of the **698** 699 Commissioner's determination plus 30 days when the Commissioner has determined that a natural or man-made disaster has caused the evacuation of a hospital or nursing home and that a public health 700 701 emergency exists due to a shortage of hospital or nursing home beds or (ii) for a period of no more than the duration of the emergency order entered pursuant to § 32.1-13 or 32.1-20 plus 30 days when the 702 703 Board, pursuant to § 32.1-13, or the Commissioner, pursuant to § 32.1-20, has entered an emergency 704 order for the purpose of suppressing a nuisance dangerous to public health or a communicable, 705 contagious, or infectious disease or other danger to the public life and health;

25. Shall establish protocols to ensure that any patient scheduled to receive an elective surgical
procedure for which the patient can reasonably be expected to require outpatient physical therapy as a
follow-up treatment after discharge is informed that he (i) is expected to require outpatient physical
therapy as a follow-up treatment and (ii) will be required to select a physical therapy provider prior to
being discharged from the hospital;

26. Shall permit nursing home staff members who are authorized to possess, distribute, or administer
medications to residents to store, dispense, or administer cannabis oil to a resident who has been issued
a valid written certification for the use of cannabis oil in accordance with subsection B of § 54.1-3408.3
and has registered with the Board of Pharmacy § 4.1-1601;

27. Shall require each hospital with an emergency department to establish a protocol for the 715 treatment and discharge of individuals experiencing a substance use-related emergency, which shall 716 717 include provisions for (i) appropriate screening and assessment of individuals experiencing substance 718 use-related emergencies to identify medical interventions necessary for the treatment of the individual in 719 the emergency department and (ii) recommendations for follow-up care following discharge for any 720 patient identified as having a substance use disorder, depression, or mental health disorder, as 721 appropriate, which may include, for patients who have been treated for substance use-related 722 emergencies, including opioid overdose, or other high-risk patients, (a) the dispensing of naloxone or 723 other opioid antagonist used for overdose reversal pursuant to subsection X of § 54.1-3408 at discharge 724 or (b) issuance of a prescription for and information about accessing naloxone or other opioid antagonist 725 used for overdose reversal, including information about accessing naloxone or other opioid antagonist 726 used for overdose reversal at a community pharmacy, including any outpatient pharmacy operated by the 727 hospital, or through a community organization or pharmacy that may dispense naloxone or other opioid 728 antagonist used for overdose reversal without a prescription pursuant to a statewide standing order. Such 729 protocols may also provide for referrals of individuals experiencing a substance use-related emergency to 730 peer recovery specialists and community-based providers of behavioral health services, or to providers of 731 pharmacotherapy for the treatment of drug or alcohol dependence or mental health diagnoses;

28. During a public health emergency related to COVID-19, shall require each nursing home and
certified nursing facility to establish a protocol to allow each patient to receive visits, consistent with
guidance from the Centers for Disease Control and Prevention and as directed by the Centers for
Medicare and Medicaid Services and the Board. Such protocol shall include provisions describing (i) the
conditions, including conditions related to the presence of COVID-19 in the nursing home, certified

737 nursing facility, and community, under which in-person visits will be allowed and under which in-person 738 visits will not be allowed and visits will be required to be virtual; (ii) the requirements with which 739 in-person visitors will be required to comply to protect the health and safety of the patients and staff of 740 the nursing home or certified nursing facility; (iii) the types of technology, including interactive audio or 741 video technology, and the staff support necessary to ensure visits are provided as required by this 742 subdivision; and (iv) the steps the nursing home or certified nursing facility will take in the event of a 743 technology failure, service interruption, or documented emergency that prevents visits from occurring as 744 required by this subdivision. Such protocol shall also include (a) a statement of the frequency with 745 which visits, including virtual and in-person, where appropriate, will be allowed, which shall be at least 746 once every 10 calendar days for each patient; (b) a provision authorizing a patient or the patient's 747 personal representative to waive or limit visitation, provided that such waiver or limitation is included in 748 the patient's health record; and (c) a requirement that each nursing home and certified nursing facility 749 publish on its website or communicate to each patient or the patient's authorized representative, in 750 writing or via electronic means, the nursing home's or certified nursing facility's plan for providing visits 751 to patients as required by this subdivision;

752 29. Shall require each hospital, nursing home, and certified nursing facility to establish and 753 implement policies to ensure the permissible access to and use of an intelligent personal assistant 754 provided by a patient, in accordance with such regulations, while receiving inpatient services. Such 755 policies shall ensure protection of health information in accordance with the requirements of the federal Health Insurance Portability and Accountability Act of 1996, 42 U.S.C. § 1320d et seq., as amended. 756 For the purposes of this subdivision, "intelligent personal assistant" means a combination of an 757 758 electronic device and a specialized software application designed to assist users with basic tasks using a 759 combination of natural language processing and artificial intelligence, including such combinations 760 known as "digital assistants" or "virtual assistants";

30. During a declared public health emergency related to a communicable disease of public health 761 762 threat, shall require each hospital, nursing home, and certified nursing facility to establish a protocol to 763 allow patients to receive visits from a rabbi, priest, minister, or clergy of any religious denomination or 764 sect consistent with guidance from the Centers for Disease Control and Prevention and the Centers for 765 Medicare and Medicaid Services and subject to compliance with any executive order, order of public 766 health, Department guidance, or any other applicable federal or state guidance having the effect of limiting visitation. Such protocol may restrict the frequency and duration of visits and may require visits 767 768 to be conducted virtually using interactive audio or video technology. Any such protocol may require the 769 person visiting a patient pursuant to this subdivision to comply with all reasonable requirements of the 770 hospital, nursing home, or certified nursing facility adopted to protect the health and safety of the 771 person, patients, and staff of the hospital, nursing home, or certified nursing facility; and

772 31. Shall require that every hospital that makes health records, as defined in § 32.1-127.1:03, of 773 patients who are minors available to such patients through a secure website shall make such health 774 records available to such patient's parent or guardian through such secure website, unless the hospital cannot make such health record available in a manner that prevents disclosure of information, the 775 776 disclosure of which has been denied pursuant to subsection F of § 32.1-127.1:03 or for which consent 777 required in accordance with subsection E of § 54.1-2969 has not been provided.

778 C. Upon obtaining the appropriate license, if applicable, licensed hospitals, nursing homes, and 779 certified nursing facilities may operate adult day care centers.

780 D. All facilities licensed by the Board pursuant to this article which provide treatment or care for 781 hemophiliacs and, in the course of such treatment, stock clotting factors, shall maintain records of all lot numbers or other unique identifiers for such clotting factors in order that, in the event the lot is found to 782 783 be contaminated with an infectious agent, those hemophiliacs who have received units of this 784 contaminated clotting factor may be apprised of this contamination. Facilities which have identified a lot 785 that is known to be contaminated shall notify the recipient's attending physician and request that he 786 notify the recipient of the contamination. If the physician is unavailable, the facility shall notify by mail, 787 return receipt requested, each recipient who received treatment from a known contaminated lot at the 788 individual's last known address.

789 E. Hospitals in the Commonwealth may enter into agreements with the Department of Health for the 790 provision to uninsured patients of naloxone or other opioid antagonists used for overdose reversal. 791

§ 32.1-162.6:1. Possession or administration of cannabis oil.

792 Hospice and hospice facility employees who are authorized to possess, distribute, or administer 793 medications to patients shall be permitted to store, dispense, or administer cannabis oil to a patient who 794 has been issued a valid written certification for the use of cannabis oil in accordance with subsection B 795 of § 54.1-3408.3 and has registered with the Board of Pharmacy § 4.1-1601.

796 § 40.1-27.4. Discipline for employee's medicinal use of cannabis oil prohibited.

797 A. As used in this section, "cannabis oil" means the same as that term is defined in $\frac{54.1-3408.3}{54.1-3408.3}$ 798 4.1-1600.

811

799 B. No employer shall discharge, discipline, or discriminate against an employee for such employee's 800 lawful use of cannabis oil pursuant to a valid written certification issued by a practitioner for the 801 treatment or to eliminate the symptoms of the employee's diagnosed condition or disease pursuant to § 802 54.1-3408.3 4.1-1601.

803 C. Notwithstanding the provisions of subsection B, nothing in this section shall (i) restrict an 804 employer's ability to take any adverse employment action for any work impairment caused by the use of 805 cannabis oil or to prohibit possession during work hours, (ii) require an employer to commit any act that 806 would cause the employer to be in violation of federal law or that would result in the loss of a federal contract or federal funding, or (iii) require any defense industrial base sector employer or prospective 807 employer, as defined by the U.S. Cybersecurity and Infrastructure Security Agency, to hire or retain any 808 applicant or employee who tests positive for tetrahydrocannabinol (THC) in excess of 50 ng/ml for a 809 810 urine test or 10 pg/mg for a hair test.

§ 46.2-341.20.7. Possession of marijuana in commercial motor vehicle unlawful; civil penalty.

812 A. It is unlawful for any person to knowingly or intentionally possess marijuana in a commercial motor vehicle as defined in § 46.2-341.4. The attorney for the Commonwealth or the county, city, or 813 814 town attorney may prosecute such a case.

Upon the prosecution of a person for a violation of this section, ownership or occupancy of the 815 816 vehicle in which marijuana was found shall not create a presumption that such person either knowingly 817 or intentionally possessed such marijuana.

818 Any person who violates this section is subject to a civil penalty of no more than \$25. A violation of 819 this section is a civil offence. Any civil penalties collected pursuant to this section shall be deposited into the Drug Offender Assessment and Treatment Fund established pursuant to § 18.2-251.02. 820 Violations of this section by an adult shall be prepayable according to the procedures in § 16.1-69.40:2. 821

822 B. Any violation of this section shall be charged by summons. A summons for a violation of this section may be executed by a law-enforcement officer when such violation is observed by such officer. 823 824 The summons used by a law-enforcement officer pursuant to this section shall be in form the same as 825 the uniform summons for motor vehicle law violations as prescribed pursuant to § 46.2-388. No court 826 costs shall be assessed for violations of this section. A person's criminal history record information as defined in § 9.1-101 shall not include records of any charges or judgments for a violation of this section, 827 828 and records of such charges or judgments shall not be reported to the Central Criminal Records 829 Exchange; however, such violation shall be reported to the Department of Motor Vehicles and shall be 830 included on such individual's driving record.

831 C. The procedure for appeal and trial of any violation of this section shall be the same as provided by law for misdemeanors; if requested by either party on appeal to the circuit court, trial by jury shall 832 833 be as provided in Article 4 (§ 19.2-260 et seq.) of Chapter 15 of Title 19.2, and the Commonwealth 834 shall be required to prove its case beyond a reasonable doubt.

835 D. The provisions of this section shall not apply to members of state, federal, county, city, or town 836 law-enforcement agencies, jail officers, or correctional officers, as defined in § 53.1-1, certified as 837 handlers of dogs trained in the detection of controlled substances when possession of marijuana is 838 necessary for the performance of their duties.

839 E. The provisions of this section involving marijuana in the form of cannabis products as that term is 840 defined in § 54.1-3408.3 4.1-1600 shall not apply to any person who possesses such cannabis product pursuant to a valid written certification issued by a practitioner in the course of his professional practice 841 842 pursuant to § 54.1-3408.3 4.1-1601 for treatment or to alleviate the symptoms of (i) the person's 843 diagnosed condition or disease, (ii) if such person is the parent or guardian of a minor or of a vulnerable adult as defined in § 18.2-369, such minor's or vulnerable adult's diagnosed condition or 844 disease, or (iii) if such person has been designated as a registered agent pursuant to § 54.1-3408.3 845 846 4.1-1601, the diagnosed condition or disease of his principal or, if the principal is the parent or legal 847 guardian of a minor or of a vulnerable adult as defined in § 18.2-369, such minor's or vulnerable adult's 848 diagnosed condition or disease. 849

§ 54.1-2522.1. (Effective until July 1, 2027) Requirements of practitioners.

850 A. Any prescriber who is licensed in the Commonwealth to treat human patients and is authorized 851 pursuant to §§ 54.1-3303 and 54.1-3408 to issue a prescription for a covered substance shall be 852 registered with the Prescription Monitoring Program by the Department of Health Professions.

853 B. A prescriber registered with the Prescription Monitoring Program or a person to whom he has 854 delegated authority to access information in the possession of the Prescription Monitoring Program pursuant to § 54.1-2523.2 shall, at the time of initiating a new course of treatment to a human patient 855 that includes the prescribing of opioids anticipated at the onset of treatment to last more than seven 856 consecutive days, request information from the Director for the purpose of determining what, if any, 857 858 other covered substances are currently prescribed to the patient. In addition, any prescriber who holds a special identification number from the Drug Enforcement Administration authorizing the prescribing of 859

860 controlled substances approved for use in opioid addiction therapy shall, prior to or as a part of
861 execution of a treatment agreement with the patient, request information from the Director for the
862 purpose of determining what, if any, other covered substances the patient is currently being prescribed.

864 information from the Director as may be required by routine prescribing practices.

865 C. A prescriber shall not be required to meet the provisions of subsection B if:

866 1. The opioid is prescribed to a patient currently receiving hospice or palliative care;

867 2. The opioid is prescribed to a patient during an inpatient hospital admission or at discharge;

3. The opioid is prescribed to a patient in a nursing home or a patient in an assisted living facilitythat uses a sole source pharmacy;

870 4. The Prescription Monitoring Program is not operational or available due to temporary871 technological or electrical failure or natural disaster; or

5. The prescriber is unable to access the Prescription Monitoring Program due to emergency ordisaster and documents such circumstances in the patient's medical record.

874 D. Prior to issuing a written certification for the use of cannabis oil in accordance with §
 875 54.1-3408.3 4.1-1601, a practitioner shall request information from the Director for the purpose of
 876 determining what, if any, other covered substances have been dispensed to the patient.

877 § 54.1-2522.1. (Effective July 1, 2027) Requirements of practitioners.

878 A. Any prescriber who is licensed in the Commonwealth to treat human patients and is authorized
879 pursuant to §§ 54.1-3303 and 54.1-3408 to issue a prescription for a covered substance shall be
880 registered with the Prescription Monitoring Program by the Department of Health Professions.

881 B. Prescribers registered with the Prescription Monitoring Program shall, at the time of initiating a 882 new course of treatment to a human patient that includes the prescribing of benzodiazepine or an opiate 883 anticipated at the onset of treatment to last more than 90 consecutive days, request information from the 884 Director for the purpose of determining what, if any, other covered substances are currently prescribed 885 to the patient. In addition, any prescriber who holds a special identification number from the Drug 886 Enforcement Administration authorizing the prescribing of controlled substances approved for use in 887 opioid addiction therapy shall, prior to or as a part of execution of a treatment agreement with the 888 patient, request information from the Director for the purpose of determining what, if any, other covered 889 substances the patient is currently being prescribed. Nothing in this section shall prohibit prescribers 890 from making additional periodic requests for information from the Director as may be required by 891 routine prescribing practices.

C. The Secretary of Health and Human Resources may identify and publish a list of benzodiazepines
or opiates that have a low potential for abuse by human patients. Prescribers who prescribe such
identified benzodiazepines or opiates shall not be required to meet the provisions of subsection B. In
addition, a prescriber shall not be required to meet the provisions of subsection B if the course of
treatment arises from pain management relating to dialysis or cancer treatments.

897 D. Prior to issuing a written certification for the use of cannabis oil in accordance with §
898 54.1-3408.3 4.1-1601, a practitioner shall request information from the Director for the purpose of
899 determining what, if any, other covered substances have been dispensed to the patient.

900 § 54.1-2903. What constitutes practice; advertising in connection with medical practice.

A. Any person shall be regarded as practicing the healing arts who actually engages in such practice as defined in this chapter, or who opens an office for such purpose, or who advertises or announces to the public in any manner a readiness to practice or who uses in connection with his name the words or letters "Doctor," "Dr.," "M.D.," "D.O.," "D.P.M.," "D.C.," "Healer," "N.P.," or any other title, word, letter or designation intending to designate or imply that he is a practitioner of the healing arts or that he is able to heal, cure or relieve those suffering from any injury, deformity or disease.

907 Signing a birth or death certificate, or signing any statement certifying that the person so signing has 908 rendered professional service to the sick or injured, or signing or issuing a prescription for drugs or 909 other remedial agents, shall be prima facie evidence that the person signing or issuing such writing is 910 practicing the healing arts within the meaning of this chapter except where persons other than physicians 911 are required to sign birth certificates.

912 B. No person regulated under this chapter shall use the title "Doctor" or the abbreviation "Dr." in 913 writing or in advertising in connection with his practice unless he simultaneously uses words, initials, an 914 abbreviation or designation, or other language that identifies the type of practice for which he is 915 licensed. No person regulated under this chapter shall include in any advertisement a reference to 916 marijuana, as defined in § 18.2-247, unless such advertisement is for the treatment of addiction or 917 substance abuse. However, nothing in this subsection shall prevent a person from including in any 918 advertisement that such person is registered with the Board of Pharmacy Directors of the Virginia 919 *Cannabis Control Authority* to issue written certifications for the use of cannabis products, as defined in 920 § 54.1-3408.3 4.1-1600.

921 § 54.1-3408.3. Certification for use of cannabis for treatment.

922 A. As used in this section: "Botanical, "botanical cannabis," means cannabis that is composed wholly
923 of usable cannabis from the same parts of the same chemovar of cannabis plant "cannabis oil,"
924 "cannabis product," and "practitioner" mean the same as those terms are defined in § 4.1-1600.

925 "Cannabis oil" means any formulation of processed Cannabis plant extract, which may include 926 industrial hemp extracts, including isolates and distillates, acquired by a pharmaceutical processor 927 pursuant to § 54.1-3442.6, or a dilution of the resin of the Cannabis plant that contains no more than 10 928 milligrams of delta-9-tetrahydrocannabinol per dose. "Cannabis oil" does not include industrial hemp, as 929 defined in § -3.2-4112, that is grown, dealt, or processed in compliance with state or federal law, unless 930 it has been grown and processed in the Commonwealth by a registered industrial hemp processor and 931 acquired and formulated by a pharmaceutical processor.

932 "Cannabis product" means a product that is (i) produced by a pharmaceutical processor, registered
933 with the Board, and compliant with testing requirements and (ii) composed of cannabis oil or botanical
934 cannabis.

"Designated caregiver facility" means any hospice or hospice facility licensed pursuant to
§ 32.1-162.3, or home care organization as defined in § 32.1-162.7 that provides pharmaceutical services
or home health services, private provider licensed by the Department of Behavioral Health and
Developmental Services pursuant to Article 2 (§ 37.2-403 et seq.) of Chapter 4 of Title 37.2, assisted
living facility licensed pursuant to § 63.2-1701, or adult day care center licensed pursuant to

941 "Practitioner" means a practitioner of medicine or osteopathy licensed by the Board of Medicine, a
942 physician assistant licensed by the Board of Medicine, or a nurse practitioner jointly licensed by the
943 Board of Medicine and the Board of Nursing.

944 "Registered agent" means an individual designated by a patient who has been issued a written
945 certification, or, if such patient is a minor or a vulnerable adult as defined in § 18.2-369, designated by
946 such patient's parent or legal guardian, and registered with the Board pursuant to subsection G.

947 "Úsable cannabis" means any cannabis plant material, including seeds, but not (i) resin that has been

A practitioner in the course of his professional practice may issue a written certification for the 952 use of cannabis products for treatment or to alleviate the symptoms of any diagnosed condition or 953 disease determined by the practitioner to benefit from such use in accordance with the provisions of 954 § 4.1-1601. The practitioner shall use his professional judgment to determine the manner and frequency 955 of patient care and evaluation and may employ the use of telemedicine, provided that the use of telemedicine includes the delivery of patient care through real-time interactive audio-visual technology. 956 957 If a practitioner determines it is consistent with the standard of care to dispense botanical cannabis to a 958 minor, the written certification shall specifically authorize such dispensing. If not specifically included 959 on the initial written certification, authorization for botanical cannabis may be communicated verbally or 960 in writing to the pharmacist at the time of dispensing.

961 C. The written certification shall be on a form provided by the Board of Pharmacy. Such written
962 certification shall contain the name, address, and telephone number of the practitioner; the name and
963 address of the patient issued the written certification; the date on which the written certification was
964 made; and the signature or authentic electronic signature of the practitioner. Such written certification
965 issued pursuant to subsection B shall expire no later than one year after its issuance unless the
966 practitioner provides in such written certification an earlier expiration. A written certification shall not be
967 issued to a patient by more than one practitioner during any given time period.
968 D. No practitioner shall be prosecuted under § 18.2-248 or 18.2-248.1 for the issuance of a

D. No practitioner shall be prosecuted under § 18.2-248 or 18.2-248.1 for the issuance of a certification for the use of cannabis products for the treatment or to alleviate the symptoms of a patient's diagnosed condition or disease pursuant to a written certification issued pursuant to subsection B.
Nothing in this section shall preclude the Board of Medicine from sanctioning a practitioner for failing to properly evaluate or treat a patient's medical condition or otherwise violating the applicable standard of care for evaluating or treating medical conditions.

974 E. A practitioner who issues a written certification to a patient pursuant to this section shall register
975 with the Board and shall hold sufficient education and training to exercise appropriate professional
976 judgment in the certification of patients. The Board shall not limit the number of patients to whom a
977 practitioner may issue a written certification. The Board may report information to the applicable
978 licensing board on unusual patterns of certifications issued by a practitioner.

979 F. No patient shall be required to physically present the written certification after the initial
 980 dispensing by any pharmaceutical processor or cannabis dispensing facility under each written
 981 electronic copy of the written certification. Pharmaceutical processors and cannabis dispensing facilities

983 shall electronically transmit, on a monthly basis, all new written certifications received by the 984 pharmaceutical processor or cannabis dispensing facility to the Board.

985 G. A patient, or, if such patient is a minor or a vulnerable adult as defined in § 18.2-369, such 986 patient's parent or legal guardian, may designate an individual to act as his registered agent for the 987 purposes of receiving cannabis products pursuant to a valid written certification. Such designated 988 individual shall register with the Board. The Board may set a limit on the number of patients for whom 989 any individual is authorized to act as a registered agent.

990 H. Upon delivery of a cannabis product by a pharmaceutical processor or cannabis dispensing facility 991 to a designated caregiver facility, any employee or contractor of a designated caregiver facility, who is 992 licensed or registered by a health regulatory board and who is authorized to possess, distribute, or 993 administer medications, may accept delivery of the cannabis product on behalf of a patient or resident 994 for subsequent delivery to the patient or resident and may assist in the administration of the cannabis 995 product to the patient or resident as necessary.

996 I. Information obtained under the registration process shall be confidential and shall not be subject to 997 the disclosure provisions of the Virginia Freedom of Information Act (§ 2.2-3700 et seq.). However, **998** reasonable access to registry information shall be provided to (i) the Chairmen of the House Committee 999 for Courts of Justice and the Senate Committee on the Judiciary, (ii) state and federal agencies or local 1000 law enforcement for the purpose of investigating or prosecuting a specific individual for a specific 1001 violation of law, (iii) licensed practitioners or pharmacists, or their agents, for the purpose of providing 1002 patient care and drug therapy management and monitoring of drugs obtained by a patient, (iv) a 1003 pharmaceutical processor or cannabis dispensing facility involved in the treatment of a patient, or (v) a 1004 registered agent, but only with respect to information related to such patient. 1005

1006 A. The following fraudulent acts or practices committed by a supplier in connection with a consumer 1007 transaction are hereby declared unlawful: 1008

1021 8. Advertising goods or services with intent not to sell them as advertised, or with intent not to sell 1022 at the price or upon the terms advertised.
