10	Be it enacted by the General Assembly of Virginia:
11	1. That §§ 46.2-800 and 46.2-833 of the Code of Virginia are amended and reenacted as follows:
12	§ 46.2-800. Riding bicycles, electric personal assistive mobility devices, electric power-assisted
13	bicycles, mopeds, or motorized skateboards or scooters; riding or driving animals.
14 15	A. Every person riding a bicycle, electric personal assistive mobility device, electric power-assisted bicycle, moped, motorized skateboard or scooter, or animal or driving an animal on a highway shall be
16	subject to the provisions of this chapter and shall have all of the rights and duties applicable to the
17	driver of a vehicle, unless the context of the provision clearly indicates otherwise.
18	B. Notwithstanding the provisions of this section, § 46.2-830, and subsection B of § 46.2-833, a
19	person riding a bicycle, electric personal assistive mobility device, electric power-assisted bicycle,
20	moped, or motorized skateboard or scooter may, while remaining in the travel lane, follow the
21	pedestrian control signal to his right indicating "Walk" across the intersection in the direction that
22 23	corresponds to the person's direction of travel, provided that such person shall only proceed straight or turn right, and shall yield to pedestrians in the crosswalk controlled by the same signal. At an
23 24	intersection with an exclusive pedestrian phase, such person shall yield to all pedestrians and to any
25	person riding a bicycle, electric personal assistive mobility device, electric power-assisted bicycle,
26	moped, or motorized skateboard or scooter in a crosswalk.
27	C. The provisions of subsections A and C of § 46.2-920 applicable to operation of emergency
28	vehicles under emergency conditions shall also apply, mutatis mutandis, to bicycles, electric personal
29	assistive mobility devices, electric power-assisted bicycles, mopeds, and motorized skateboards or
30 31	scooters operated under similar emergency conditions by law-enforcement officers. <b>§ 46.2-833. Traffic lights; penalty.</b>
32	A. Signals by traffic lights shall be as follows:
33	Steady red indicates that moving traffic shall stop and remain stopped as long as the red signal is
34	shown, except in the direction indicated by a steady green arrow.
35	Green indicates the traffic shall move in the direction of the signal and remain in motion as long as
36	the green signal is given, except that such traffic shall yield to other vehicles and pedestrians lawfully
37 38	within the intersection. Steady amber indicates that a change is about to be made in the direction of the moving of traffic.
30 39	When the amber signal is shown, traffic which has not already entered the intersection, including the
40	crosswalks, shall stop if it is not reasonably safe to continue, but traffic which has already entered the
41	intersection shall continue to move until the intersection has been cleared.
42	Flashing circular red indicates that traffic shall stop before entering an intersection. Such traffic shall
43	yield the right-of-way to pedestrian and vehicular traffic lawfully within the intersection.
44 45	Flashing red arrow indicates that traffic shall stop before entering an intersection. After stopping,
45 46	traffic may cautiously enter the intersection to turn in the direction of the signal. Such traffic shall yield the right-of-way to pedestrian and vehicular traffic lawfully within the intersection.
47	Flashing circular amber indicates that traffic may proceed through the intersection or past such signal
<b>48</b>	with reasonable care under the circumstances. Such traffic shall yield the right-of-way to pedestrian and
49	vehicular traffic lawfully within the intersection.
50	Flashing amber arrow indicates that traffic may turn in the direction of such signal with reasonable
51	care under the circumstances. Such traffic shall yield the right-of-way to pedestrian and vehicular traffic
52 53	lawfully within the intersection. <b>B</b> Notwithstanding any other provision of law if a driver of a metersystel or monod or a bisystel
53 54	B. Notwithstanding any other provision of law, if a driver of a motorcycle or moped or a bicycle rider approaches an intersection that is controlled by a traffic light, the driver or rider may proceed
5 <b>4</b>	through the intersection on a steady red light only (a) if the driver or rider (i) comes to a full and
56	complete stop at the intersection for two complete cycles of the traffic light or for two minutes,
57	whichever is shorter, (ii) exercises due care as provided by law, (iii) otherwise treats the traffic control
58	device as a stop sign, (iv) determines that it is safe to proceed, and (v) yields the right of way to the

59 driver of any vehicle approaching on such other highway from either direction or (b) when permitted 60 pursuant to subsection B of § 46.2-800.

61 C. If the traffic lights controlling an intersection are out of service because of a power failure or 62 other event that prevents the giving of signals by the traffic lights, the drivers of vehicles approaching 63 such an intersection shall proceed as though such intersection were controlled by a stop sign on all 64 approaches. The provisions of this subsection shall not apply to: intersections controlled by portable stop 65 signs, intersections with law-enforcement officers or other authorized persons directing traffic, or 66 intersections controlled by traffic lights displaying flashing red or flashing amber lights as provided in 67 subsection A.

D. The driver of any motor vehicle may be detained or arrested for a violation of this section if the detaining law-enforcement officer is in uniform, displays his badge of authority, and (i) has observed the violation or (ii) has received a message by radio or other wireless telecommunication device from another law-enforcement officer who observed the violation. In the case of a person being detained or arrested based on a radio message, the message shall be sent immediately after the violation is observed, and the observing officer shall furnish the license number or other positive identification of the vehicle

75 Violation of any provision of this section shall constitute a traffic infraction punishable by a fine of

**76** no more than \$350.
