184 federal Rehabilitation Act. Membership and duties shall be constructed according to federal provisions.

§ 51.5-25.1. Statewide Independent Living Council created. 185

The Statewide Independent Living Council is hereby created to jointly plan with the Department of 186 Rehabilitative Services activities carried out under Title VII of the federal Rehabilitation Act and to 187 188 provide advice to the Department regarding such activities. Membership and duties shall be constructed 189 according to federal provisions. The Department of Rehabilitative Services shall provide staff support

190 for the Council.

§ 63.1-84. Statewide Rehabilitation Advisory Council for the Blind created. The Statewide Rehabilitation Advisory Council for the Blind is hereby created to provide advice to 192

193 the Department for the Visually Handicapped regarding vocational services provided pursuant to Title I

194 and Title VI of the federal Rehabilitation Act. Membership and duties shall be constructed according to 195 federal provisions.
